## OVERVIEW

With the Blueprint for a Responsible Budget as the guide, the Assembly Budget Subcommittees have completed their work in crafting a State Budget.

The Assembly Budget exceeds the Blueprint's goals of continuing fiscal responsibility, strengthening the middle class, and delivering effective and efficient services:

- The Assembly Budget is balanced, with reserves and set-asides totaling around \$2.5 billion, and is balanced in each year of the forecast, with fund balances ranging from over \$1.5 billion to over \$4 billion;
- The Assembly Budget strengthens the middle class with new investments in education, the Middle Class Scholarship, and safety net programs that get people back to work and enable low income students to succeed in school; and,
- The Assembly Budget delivers effective, efficient services with improvements to business filings, exporting licenses, and local coastal plans; as well as improved services for veterans and increased funding for the courts.

Preliminary scoring of the Assembly action, along with a summary of all actions are contained in this document. This will frame the Assembly version of the budget, which will move forward into a budget conference committee.

Summary of Key Components of Subcommittee Actions:

- ***Continuing Fiscal Responsibility:***
  - Reserves/Set-Asides totaling \$2.5 billion.
    - Increases regular General Fund Reserve to \$1.3 billion, an increase of \$200 million.
    - Establishes Prop 98 Set-Asides of \$1.2 billion to allow Prop 98 spending to decrease to the extent LAO revenues do not materialize.
    - Therefore, provides a total of \$2.5 billion in reserves/set-asides to protect against revenues not meeting the forecast.
  - Balanced Budget Each and Every Year.
    - Results in out-year fund balances ranging from over \$1.5 billion to over \$4 billion.

- Pays Down Debt.
  - Provides a total of \$4.7 billion in debt payments toward the “Wall of Debt”
  - Reduces the Cap and Trade Loan by \$100 million, and begins repayment in 2014-15 (May Revision provides no repayment schedule).
- Constitutional Amendment for a New Rainy Day Fund.
  - Begins the discussions for crafting a workable Rainy Day Fund that captures spiking capital gains revenues to be preserved for times of economic downturns.
- ***Strengthening the Middle Class.***
  - Improves Educational Outlook for Low Income and English Learners.
    - Provides over \$1.7 billion over the May Revision in programmatic spending targeted toward low income and English Learners.
    - Provides \$250 million for child care programs serving working parents.
    - Provides \$200 million for a Child Poverty Adjustment for families receiving CalWORKs assistance to reduce the impacts of poverty on their children’s ability to learn.
  - Increases Access to Higher Ed:
    - Establishes the Middle Class Scholarship to reduce student fees at the UC and CSU by 40 percent. The Middle Class Scholarship will begin the Spring Semester of the 2013-14 school year.
  - Helps Small Businesses and Job Programs.
    - Provides \$2 million for the administration of small business loan programs to expedite to allocation of federal loan funds to small businesses.
    - Expands key welfare-to-work programs to get recipients into the right programs and to provide subsidized employment opportunities to people unable to land employment.

- **Providing Effective, Efficient Services.**

- Approves improvements to business filings at the Secretary of State, export licensing at the Department of Public Health, and Local Coastal Plans.
- Provides funding to improve veterans services, including assisting the federal government process disability claims backlogs.
- Increase Court funding by \$100 million, growing to \$200 million in 2014-15 to avoid court closures and program reductions.

## HEALTH

### Medi-Cal

- **Federal Health Care Reform Implementation.** Approved of \$1.5 billion in federal funds to implement the optional Medi-Cal expansion; approves of \$104 million General Fund to implement Medi-Cal program simplifications required by the Affordable Care Act; rejects the Administration's human services realignment proposal, and instead approves of a fiscal mechanism for the state to capture county savings that result from the Medi-Cal expansion; approves of trailer bill language to create a mechanism for calculating county savings that requires that the savings be shared between the state and counties; approves of up to \$120 million in increased funds for counties for Medi-Cal eligibility administration; extends Medi-Cal coverage to former foster youth up to age 26; requires DHCS to seek federal matching funds for application assistors; and modifies statute to allow sufficient time for federal approval of Low Income Health Program capitated rates to prevent the loss of significant federal funding.
- **Medi-Cal Restorations.** Restored the enteral nutrition optional benefit that was eliminated from the Medi-Cal program in 2011; repeals the statute instituting a 7-physician-visit cap; and reforms the reimbursement policy for hearing aids to create transparency and maintain access.
- **Major Revenue Solutions.** Reinstated the Managed Care Organization Tax to support the Healthy Families Program in 2012-13 and Medi-Cal in 2013-14 through June 30, 2016; and approved of assumed savings of \$310 million in 2013-14 from extending the Hospital Quality Assurance Fee.

### Managed Health Care

- **Expansion of the Role and Responsibilities of the Department of Managed Health Care.** Approved of resources for: Medi-Cal dental managed care oversight; premium rate review; Medi-Cal managed care rural expansion oversight; Coordinated Care Initiative oversight; and Affordable Care Act implementation.

### Public Health

- **Core Public Health Resources.** Approved of resources for: the Export Document Program; implementation of the STAKE Act; emergency preparedness; healthcare associated infections reporting; and drinking Water programs.

- **Safe Cosmetics Act Implementation.** Approved of trailer bill to more clearly define the purpose and structure of the consumer website required in the Safe Cosmetics Act, and requires that the website be launched by December 31, 2013.

**Managed Risk Medical Insurance Board (MRMIB)**

- **MRMIB Elimination.** Denies the proposed elimination of MRMIB.
- **AIM-Linked Infants Transition.** Approved of the proposed transition of AIM-Linked infants (0-2 year olds, between 250 and 300 percent of federal poverty) from Healthy Families to Medi-Cal, beginning October 1, 2013. Requires that this transition be subject to all of the same consumer protections, accountability factors, transparency, and stakeholder involvement as the transition of all children from Healthy Families to Medi-Cal.

**State Hospitals**

- **Stockton Facility.** Approved of \$67.5 million General Fund to complete the activation of the new California Health Care Facility in Stockton, that will begin serving patients on July 1, 2013. Approves of reductions in staff and resources at the Vacaville and Salinas Psychiatric Facilities to reflect the transition of patients from these facilities to Stockton.
- **State Hospitals Safety.** Approved of resources for the full implementation of Personal Duress Alarms at all five state hospitals; and approves of improvements to fire alarms and security fencing and structures.



## HUMAN SERVICES

### CalWORKs

- **Child Poverty Adjustment.** Approved the phase-in of a CalWORKs Child Poverty Adjustment, so that after a five-year period CalWORKs provides support for families to live at 50 percent of the Federal Poverty Level (FPL). This will begin with a 12 percent increase in the CalWORKs MAP starting January 1, 2014, with 4.5 percent increases each year thereafter for four years. The grants will be adjusted annually thereafter to maintain the tie to 50 percent of FPL. For 2013-14, this change requires approximately \$217.8 million and the adoption of placeholder trailer bill language to effectuate this change both in budget and out-years.
- **Early Engagement Fulfillment.** Approved the May Revision's Early Engagement proposal, with additional changes to adopt placeholder trailer bill language to (a) construct a statutory framework to ensure an appropriate and systemwide tool for Robust Appraisal, (b) provide specified services under Family Stabilization, prior to time limits beginning for families receiving these services, to more effectively remove barriers to employment, and (c) authorize an expanded Subsidized Employment program, leading to a universal offer of subsidized employment after four years. This includes an increase of \$10 million for Family Stabilization enhanced services in 2013-14. As part of this trailer bill, includes provisions to make related changes to existing law regarding the flow of welfare-to-work services and to require data collection and client experience monitoring.
- **Anti-Poverty Strategies.** Approved corresponding anti-poverty changes for CalWORKs families, including (a) limiting the Maximum Family Grant (MFG) Rule to a two-year period, (b) eliminating the Vehicle Asset Limit, allowing families to retain a functional vehicle to support their employment and self-sufficiency goals, and (c) lifting the "once-in-a-lifetime" Homeless Assistance provision. This includes an increase of \$15 million in 2013-14 for ramp-up for these policies to be implemented toward the last quarter of the budget year, with the implementation date occurring for these policies no later than July 1, 2014.
- **Single Allocation.** Approved the baseline adjustment in the CalWORKs Single Allocation as proposed in the January Budget.
- **TANF Transfer.** Reduced the TANF transfer to CSAC to eliminate any amount of the transfer that is tied to the creation of excess Maintenance of Effort (MOE) funding. The overall budget impact of the change is neutral to the General Fund.
- **Non-MOE Cases.** Adopted the May Revision proposal related to changes in cases funded under the non-MOE portion of the program, however stated continuing legislative interest in continued careful oversight over funding decisions and implications for all CalWORKs cases.

**Supplemental Security Income/State Supplementary Payment**

- **Cost of Living Adjustment.** Reinstated the annual state Cost of Living Adjustment (COLA) for SSI/SSP starting July 1, 2014.

**In-Home Supportive Services**

- **Coordinated Care Initiative (CCI).** Approved seven limited-term positions to support the work for the In-Home Supportive Services (IHSS) Program within the Coordinated Care Initiative (CCI). As part of this, requested that DSS provide an update to the legislative staff by January 1, 2014 on the hiring of positions pursuant to the Budget Change Proposal (BCP).
- **Statewide Public Authority.** Approved two permanent and two limited-term positions to support the IHSS CCI-Statewide Public Authority as requested in the May Revision. Adopted associated clean-up trailer bill language to SB 1036, the trailer bill that established the Statewide Public Authority.
- **Community First Choice Option.** Approved the net decrease of \$15.7 million to reflect increased General Fund savings from the Community First Choice Option program, attributable to a revised methodology based on average monthly hours of higher needs recipients.
- **CMIPS II.** Approved the January proposal to extend four existing limited-term positions for two additional years for Case Management, Information, and Payrolling System II (CMIPS II) transition and approved the May Revision proposal for a decrease of \$23.9 million (\$12.1 million General Fund) to reflect a revised project schedule.
- **May Revision Adjustments.** Approved the following IHSS May Revision proposals related to the Health Care Certification Requirement and the Settlement Agreement-Related Changes, both to rescind the prior 20 percent reduction in hours and to account for the 8 percent reduction pursuant to the settlement.
- **Public Authority Rate Methodology.** Approved the effective continuation of work related to the Public Authority Rate Methodology, by removing fixed dates in the uncodified section of statute regarding this ongoing work.

### **Child Welfare Services**

- **Resource Family Approval Project.** Rejected the May Revision request to rescind a January request related to the Resource Family Approval Project and instead approved the necessary funding, anticipated to be approximately \$171,000 GF and \$36,000 Federal Trust Fund, along with two positions, for the project to move forward. Correspondingly, (1) adopted only the technical aspects of the related trailer bill language (e.g. to update outdated references to the project's former status as a pilot) and (2) required the department to update the Subcommittee on its progress in implementing the project during the 2014-15 budget hearings.
- **FSH Fund.** Approved the requested adjustments in the Foster Family Home and Small Family Home Insurance (FSH) Fund Spring Finance Letter, to both lower the annual General Fund contribution into the Fund and to authorize a one-time transfer of excess fund balance to the General Fund.
- **May Revision Adjustments.** Approved the May Revision proposals to extend the moratorium on group homes for an additional year and to adjust the Kin-GAP caseload to reflect fewer cases transferring.
- **Congregate Care Reform.** Approved resources requested in the January budget (making one limited-term position permanent, as well as funding consultant services for two years) for the Congregate Care Reform (also known as Continuum of Care Reform) effort and adopted placeholder TBL to clarify some of the concrete reforms that should take effect in the shorter term, including: a) Limitations on, and/or levels of review needed for, placements in group homes, particularly for children as young as six to twelve years old; b) A requirement for the department to update the Legislature regarding the outcomes of the assessments and planning regarding transitions to family settings for children and youth who have been in group homes for longer than one year; and, c) Encouragement for the department to ensure that educational qualifications and training requirements for direct care staff in group homes are consistent with the intended role of group homes as short-term placements focused on crisis intervention, and behavioral stabilization, with specific treatment goals.

### **Other Department of Social Services**

#### **CalFresh.**

- Adopted the Administration's May Revision proposed trailer bill language for Semi-Annual Reporting, along with the changes recommended by advocates, as placeholder language, subject to refinement in the trailer bill process.
- Approved the January proposal to transfer program management for CalFresh Outreach to the Department of Social Services from the Department of Public Health.

- Extended the CalFresh County Match Waiver for one additional year, with the understanding that the counties and the state will work toward a reinstatement of the match.

#### **State Hearings Division.**

- In response to the Governor's January and May proposals, approved funding and authority for 24 new, permanent administrative law judges, and corresponding funding for 17 administrative support staff. The effect of this action should be determined by the administration, after consultation with Subcommittee staff. Additionally, deferred, to a court-based process related to the underlying litigation that established the penalty structure, the potential for funding, through temporary penalty relief, state hearings resources necessary to get to timely decisions.
- In tandem with the above action, rejected the January State Hearings BCP and trailer bill proposal.

#### **Community Care Licensing.**

- Approved four limited-term positions at a cost of \$470,000 total funds (\$385,000 General Fund) to strengthen resources for client protections by reducing the risk of abuse of children and vulnerable adults in out-of-home care posed by the potential presence of registered sex offenders (RSOs).
- Continued for an additional two years the suspension of existing law that prohibits DSS and the Department of Justice (DOJ) from charging a fee to process a criminal history check of individuals who are licensed to operate child and adult facilities, provide care in a facility, or reside at that facility.
- Approved the May Revision request to authorize a transfer of \$2.1 million from the Child Health and Safety Fund to CCL to backfill a reduction in the Social Services Block Grant (Title XX) related to federal sequestration.

#### **Human Services and ACA Implementation**

- **CalHEERS.** Approved the January and May Revision proposals related to the design, development, implementation, and operation and maintenance for the California Healthcare Eligibility, Enrollment and Retention System (CalHEERS) project.
- **Realignment.** Rejected all programmatic aspects of the Administration's human services realignment proposal and defer to actions on the Health side of the Subcommittee's work for decisions on the broader health care implementation proposal.

- **Office of the Patient Advocate.** Approved the Spring Finance Letter from the Office of the Patient Advocate (OPA) requesting \$184,000 from the OPA Trust Fund and one two-year limited term position to meet new statutory requirements under AB 922 (Monning), Chapter 552, Statutes of 2011 to develop a Complaint Data Reporting Project. Requested that the OPA provide a roadmap of expected activities and milestones to meet the requirements of AB 922 by June 15, 2013.
- **Human Services and the ACA.** Approved the May Revision request from the Department of Social Services for support for three positions related to the intersection between the implementation of the Affordable Care Act with Human Services programs, with a requirement to the Department to be prepared to report to the Subcommittee during the 2014 spring hearing process on a vision and framework for the improvement of human services programs as a result of integration efforts, with clear and concrete goals for what this enhancement will look like for families receiving benefits, workers and training at the county office level, and systems more broadly. This framework should include timelines for achieving goals and metrics to evaluate outcomes. The Subcommittee requested that the approved positions work closely with the County Welfare Directors Association of California and county human services agencies, as well as other stakeholders, in development of this vision and framework.

#### **Department of Developmental Services**

- **Co-Payments and Co-Insurance.** Approved the Governor's proposal related to co-payments and co-insurance tied to accessing services identified as necessary in the consumer's Individual Program Plan (\$9.9 million General Fund in 2013-14) and trailer bill language, with the following changes: 1) clarification that the trailer bill language is intended to cover co-insurance, as well as co-pays; 2) clarification that the use of the word "parent" also includes guardians or caregivers; and, 3) inclusion of placeholder language to require data collection related to coverage by regional centers of co-payments and co-insurance.
- **Annual Family Fee.** Approved the Governor's proposal to make the annual family fee permanent. Additionally, directed the department to continue to work with each regional center to ensure that the fee will be implemented as intended, and to update the Subcommittee on those efforts.
- **Additional trailer Bill Related to DDS Consumers.** Approved placeholder trailer bill language to clarify placements into Institutions for Mental Disease (IMDs), strengthen the required assessment process for consumers, and assure the involvement of client's rights advocates in the appropriate legal proceedings to assist the interests of consumers petitioning to leave a developmental center (DC).

- **Sonoma DC May Revision Requests.** Approved the May Revision requests to backfill \$15.7 million in federal funding and fund the Independent Consultative Review Expert (ICRE) contract for the Sonoma Developmental Center. Rejected the May Revision proposed provisional Budget Bill Language as it related to unanticipated costs associated with activities pursuant to the ICRE's recommendations, scoring \$10 million in General Fund savings associated with this.
- **Master Plan for Developmental Centers.** Adopted placeholder uncodified trailer bill language requiring that the Administration submit a master plan for the future of developmental centers, which it has committed to producing by November 15, 2013, to the appropriate fiscal and policy committees of the Legislature, by that same date. Required the Administration to report, by January 10, 2014, on the resulting plans to address the service needs of all developmental center (DC) residents, including a timeline for future closures, and the statutory and regulatory changes that may be needed to ensure the delivery of cost-effective, integrated, quality services for this population.
- **Early Start Program.** Approved a \$12 million reinvestment in the Early Start program, with placeholder trailer bill language to alter and prioritize changes in eligibility to allow for more children to participate in the program, effective October 1, 2013.
- **Lanterman DC Positions, Resources, and Closure.** Approved the requested resources and authority for 88 positions (18-month, limited-term) for Lanterman DC and adopted uncodified trailer bill language on closure of the facility by fall of 2014, but no later than December 31, 2014. Also directed the Department of Developmental Services to provide quarterly briefings on the meeting of milestones and timelines as previously outlined, to begin July 2013 and which may coincide with the briefings related to Sonoma DC (described below).
- **Sonoma DC Positions, Resources, and Oversight.** Approved the requested resources and authority for 36 positions (two-year, limited-term) for Sonoma DC issues and directed the department to provide quarterly briefings to update leg staff regarding implementation of corrective actions and the Program Improvement Plan for the facility, as well as its staffing (e.g. the use of overtime and the ratio of licensed to unlicensed staff where relevant) and the collaboration between DDS and RCs regarding required assessments of residents' needs, to begin July 2013.

### Department of Aging

- **Federal Grants.** Approved the January BCPs related to the Chronic Disease Self-Management Education Grant Program, the Supplemental Nutrition Assistance Program Nutrition Education Obesity Prevention Program (SNAP-Ed), and the New Freedom Transportation Grant Extension Request.
- **Health Insurance Counseling.** Approved the May Revision requested expenditure authority (\$660,000 in 2013-14) and budget bill language relating to the Health Insurance Counseling Program.

**Department of Child Support Services**

- **Additional Federal Funds.** Approved the May Revision request to authorize receipt of additional federal trust funds (\$276,000) due to improved performance.

**Department of Rehabilitation**

- **Transfer of Client Assistance Program.** Approved the May Revision requested transfer of Client Assistance Program responsibilities from the Department to Disability Rights California, reducing program administrative costs by an estimated \$198,000 annually, allowing additional funding to become available for direct services. The total federal fiscal year 2013 grant is \$1.2 million.

**Department of Alcohol and Drug Programs**

- **Program Transfer.** Approved the BCP requests as budgeted, facilitating the transfer of Alcohol and Drug Program (ADP) responsibilities pursuant to the Transition Plan as developed with stakeholders and presented as part of the Governor's 2013-14 Budget. Additionally, approved placeholder trailer bill language to effectuate the ADP transfer, using the Administration's proposal as a basis, with the following modifications: 1) including a mechanism to require continued legislative oversight as this transition unfolds over the next few years; 2) requiring continued stakeholder involvement and input as the delivery of alcohol and other drug (AOD) and healthcare services in California continues to evolve; and, 3) establishing a baseline for evaluating on an ongoing basis how and why AOD service delivery changed or improved as a result of this administrative transfer.

# **Subcommittee No. 2**

## **Education Finance**

## K-12 EDUCATION

### Proposition 98 Package

- **Overall Funding Levels.** Provides a Proposition 98 minimum guarantee of approximately \$57.4 billion in the current year and \$57.6 billion for 2013-14. The Assembly package assumes the Legislative Analyst's Office revenue estimates, which provide an additional \$899 million in the current year and \$1.6 billion in 2013-14 for K-14 education as compared to the Governor's May Revision funding levels. The Assembly package also shifts child care back into Proposition 98, which increases the guarantee by an additional \$768 million in 2013-14.
- **Deferrals.** Overall, the Assembly package pays down the same amount of deferrals as the Governor's May Revision but takes a slightly different approach. The Assembly package uses more one-time money in the current year to pay an additional \$400 million more towards deferrals (a total of \$4.4 billion). For the budget year, the Assembly package pays \$400 less towards deferrals than the Governor proposes. The net effect of these current year and budget year payments are the same as the Governors - \$4.9 billion. Up to \$1.2 billion of these payments would not be made however if LAO revenues do not materialize.

### K-12 Major Adjustments

- Provides an additional \$500 million in one-time Proposition 98 funds, for a total of \$1.5 billion, for Common Core State Standards implementation pursuant to legislation.
- Increases funding for the Local Control Funding Formula by \$1.7 billion for a total of \$3.6 billion. Adopts core principles informing the implementation of this formula.
- Provides \$630 million for Adult Education and maintains as a separate program. In 2013-14, all LEAs receiving adult education funding shall continue to receive the same level of funding. Those districts operating adult education programs shall maintain the same 2012-13 spending level for those programs. Beginning in 2014-15 adult education program and funding requirements shall be restored.
- Maintains several programs separate from the Local Control Funding Formula including Foster Youth Services, Adults in Correctional Facilities and Apprenticeship programs.
- Provides \$15 million to restore the Early Mental Health Initiative, which was vetoed by the Governor in 2012-13.

- Backfills the \$1.8 billion General Fund reduction to the State Special Schools with one-time federal IDEA funding.
- Rejects the Governor's proposal to increase mandate block grant funding by \$100 million and rejects inclusion of the Behavioral Intervention Program mandate and the Graduation Requirements mandate. Further, rejects the suspension of five additional mandates.
- Makes a number of changes to special education including AB 602 formula modifications and several program consolidations. Rejects the Governor's proposal to add Program Specialists and Regional Services and Staff Development Grant funds to the AB 602 formula.

## CHILD CARE AND DEVELOPMENT

- **Child Care back in Proposition 98.** Restores Child Development programs back into Proposition 98, with all child care programs that were part of Proposition 98 prior to 2011 back into the calculation. This will cause a rebenching of the Proposition 98 guarantee in 2013-14.
- **Reinvestment in Early Childhood Education.** Appropriates a net \$250 million for child development programs for the following changes:
  - \$100 million for additional Preschool slots.
  - \$100 million for additional Child Development Slots in capped programs—like General Child Care, Alternative Payment
  - \$57 million to fully fund CalWORKs Stage 3 Child Care, offsetting the Sequestration reduction attributed by DOF and also clarifying that caseload supported by one-time funding will continue as part of Stage 3 in the future.
  - \$4 million to preschool to backfill the loss of family fee revenue. The Subcommittee previously took action to eliminate this fee.
  - Reduce CalWORKs Stage 2 funding by \$11 million to reflect lower than expected caseloads, per LAO.
  - Adopt Budget Bill Language to allow for adjustment of caseload budgeted amounts to reflect actual caseload experience.
  - \$1.4 million to backfill the lost sequestration funding for quality child care programs.
- **Family Fees.** Adopts Placeholder Trailer Bill to eliminate family fees for Preschool programs allow for the simplification of the family fee schedule.

- **Preschool Plan.** Adopts \$341,000 General Fund and Budget Bill Language proposed by CDE to implement the California Preschool plan previously approved by the Subcommittee at its March 20<sup>th</sup> hearing.
  - *The Department of Education shall develop a plan to provide a system of voluntary preschool for all children one year before kindergarten. The plan shall include a program that is age and developmentally appropriate, based on the California Preschool Learning Foundations and Frameworks, guidelines and appropriate instructional practices adopted by the Superintendent of Public Instruction, and aligned with statewide academic standards for elementary schools. The plan shall be submitted to the Joint Legislative Budget Committee and the Department of Finance by April 1, 2014.*
- **Repeals freeze on COLA.** Adopts placeholder trailer bill language to eliminate existing statutory provisions that prohibit a COLA adjustments to child development programs. Also rejects a proposal to permanently freeze income eligibility levels in statute.

## HIGHER EDUCATION

### California Community Colleges

- **Enrollment Growth.** Approves enrollment growth to begin reversing a 5-year decline in access to community colleges.
- **Categorical Programs.** Augments categorical programs, increasing many programs that are key to students' success, such as the Disabled Students Programs and Services, Extended Opportunity Programs and Services, and the new Student Success program. Many categorical programs will receive funding above the 2007-08 funding levels. This funding also will allow the Chancellor's Office to develop E-Planning tools for students and create a Common Assessment System.
- **On-Line Courses.** Approves language directing the Chancellor's Office to use \$16.9 million of its state funding to improve students' access to courses through technology.
- **Cost-of-Living Adjustment.** Approves a 1.57 percent cost-of-living adjustment, the first such COLA since 2007-08.
- **Pays Down Deferrals.** Increases the deferral pay-down in the current year to \$220.1 million and provides another deferral pay-down of \$19.8 million in the budget year. Includes budget bill and trailer bill language allowing for \$77 million of the current-year deferral payment to be set aside, with Department of Finance making payments only if the LAO revenue projections materialize.
- **Proposition 39.** Approves \$51 million in Proposition 39 funds for energy efficiency projects at community colleges.
- **Adult Education.** Reduces the Administration's proposal to distribute \$30 million in planning grants for adult education programs to \$7.2 million. The Subcommittee earlier in the year rejected the Administration's first proposal regarding adult education.
- **Matriculation and Apprenticeship "flex."** Repeals the matriculation and apprenticeship categoricals from the flex, thus requiring districts to spend the funding for these programs on these services.

- **Census Change.** Rejects the Administration's proposal to shift apportionment funding from the beginning of the term to the end of the term. The proposal does not address a significant problem and could provide perverse incentives for colleges to offer less-rigorous courses.
- **Unit Caps.** Rejects the Administration's proposal to impose a cap on the number of units a student can take. Students exceeding the cap would be required to pay the full cost of instruction. This is a harsh penalty on students who might have excessive units due to difficulties in enrolling in classes.
- **Board of Governors Fee Waiver Changes.** Rejects the Administration's proposal to require every student who receives the BOG Fee Waiver to fill out a federal financial aid form. The proposal also called for a significant change in how colleges determined if a student was dependent from their parents in determining eligibility for the waiver. This proposal also does not address a significant problem and could lead to more than 100,000 students losing their fee waiver.
- **CalWORKs Enrollment Priority.** Approves trailer bill language that would allow students receiving CalWORKs benefits to sign up for classes earlier than other students. Due to actions taken in the 2012 Budget Act, CalWORKs recipients have much less time on benefits and might run out of benefits as they wait to enroll in classes.

### California State Library

- **High-Speed Internet Access and Adult Literacy.** Approves \$5 million General Fund to allow the State Library to join the Corporation for Education Networks Initiatives in California (CENIC), provide grants to libraries seeking to improve their Internet capabilities, and restores \$750,000 in funding for adult literacy programs.

### University of California

- **State Funding Increase.** Approves a 5-percent state General Fund increase, totaling \$125.1 million, to the University of California.
- **Statewide Priorities.** Adds language directing the university to provide funding to key state programs such as AIDS Research, the Science and Math Teacher Initiative, nursing programs and the UC Riverside Medical Center. Also includes an enrollment target equal to the current enrollment.
- **On-Line Courses.** Approves language directing the university to use \$10 million of its state funding to improve students' access to courses through technology.

- **Performance Measurements.** Defers the Administration's proposal to tie increased funding to specific performance measurements to the policy process, which is better positioned to provide a thorough examination of the state's higher education goals.
- **Capital Outlay.** Rejects the Administration's proposal to move capital outlay costs into the university's main appropriation and allow the university to restructure its lease-revenue debt service. The proposal, which would be a major policy shift, should be considered in a broader discussion of the state's infrastructure needs and the processes to support infrastructure.
- **UC Merced Classroom and Academic Office Building.** Approves the use of lease-revenue bonds to construct a new building at UC Merced, which will allow the campus to increase enrollment as planned.
- **Unit Caps.** Rejects the Administration's proposal to impose a cap on the number of units a student can take. Students exceeding the cap would be required to pay the full cost of instruction. University officials noted the purported problem of students taking too many classes before they graduate was not a significant issue and that the proposed policy could impact students taking double-majors or other high-unit majors.
- **Cost of Education.** Approves placeholder trailer bill language that would require the university to provide biannual reports on the costs of education, on a systemwide and campus-by-campus basis, broken down by undergraduate instruction, graduate instruction, and research activities.

### **Hastings College of Law**

- **State Funding Increase.** Approves a 5-percent state General Fund increase, totaling \$329,000, to Hastings College of Law.

### **California State University**

- **State Funding Increase.** Approves a 5-percent state General Fund increase, totaling \$125.1 million, to California State University.
- **Statewide Priorities.** Adds language directing the university to provide funding to key state programs such as the Science and Math Teacher Initiative and nursing programs. Also includes an enrollment target equal to the current enrollment.
- **On-Line Courses.** Approves language directing the university to use \$10 million of its state funding to improve students' access to courses through technology.

- **Performance Measurements.** Defers the Administration's proposal to tie increased funding to specific performance measurements to the policy process, which is better positioned to provide a thorough examination of the state's higher education goals.
- **Capital Outlay.** Rejects the Administration's proposal to move capital outlay costs into the university's main appropriation and allow the university to restructure its lease-revenue debt service. The proposal, which would be a major policy shift, should be considered in a broader discussion of the state's infrastructure needs and the processes to support infrastructure.
- **CSU Pomona Administration Replacement Facility.** Approves the use of lease-revenue bonds to address seismic and structural issues at the four-building Classrooms, Laboratories and Administration complex on the CSU Pomona campus.
- **Unit Caps.** Rejects the Administration's proposal to impose a cap on the number of units a student can take. Students exceeding the cap would be required to pay the full cost of instruction. This is a harsh penalty on students who might have excessive units due to difficulties in enrolling in classes.
- **Cost of Education.** Approves placeholder trailer bill language that would require the university to provide biannual reports on the costs of education, on a systemwide and campus-by-campus basis, broken down by undergraduate instruction, graduate instruction, and research activities.
- **Employer Pension Contributions.** Rejects the Administration's proposal to freeze the state's contribution to CSU pension costs based on the system's 2012-13 payroll. The action would freeze contributions at an artificially-low point and could discourage the system from increasing courses and enrollment.

### **California Student Aid Commission**

- **Middle Class Scholarship.** Approves the Middle Class Scholarship, which provides grants to families earning less than \$150,000 annually. The program will be funded by non-Proposition 98 funds from Proposition 39 and could allow more than 180,000 UC and CSU student annually to receive as much as 40 percent off of their tuition. The program addresses the major tuition increases during the past decade that have had the most impact on the middle class.
- **Cal Grant Program Reforms.** Makes four changes to the Cal Grant program to improve Cal Grant's value to students:



- Repeals the annual income/asset test, which has stripped Cal Grants from nearly 20,000 needy students due to slight income improvements by their families.
- Repeals the 5-percent veto on the neediest students by restoring the Cal Grant B and C amounts to 2011-12 levels.
- Repeals upcoming 2- and 11-percent cuts to Cal Grant amounts for students attending nonpublic colleges. The cuts would lead to these institutions accepting fewer Cal Grant students.
- Enacts a change allowing nonpublic institutions to remain eligible for Cal Grants if they have a cohort default rate below 20 percent but a 6-year graduation rate above 80 percent.

### Local Control Funding Formula Assembly Package Principles

- **Additional Investment in Low-income Children.** Improvements in other areas of the Budget – including funding for child care and child poverty adjustments in CalWORKs – must be made in order in order for targeted education funds to have their intended benefit for low income and English Learner students.
- **Base Grant.** Provide a base grant target that achieves the goal of providing per pupil spending based on the national average. Adjusts funding using the Governor's grade span differentials.
  - K-3 Supplement: Moves towards a K-3 class sizes target of 20:1 ratio, commensurate with current law funding.
  - CTE Supplement: Funding same as the Governor's Proposal. Require districts participating in an ROC/P operated by a JPA to use this funding adjustment for the purpose of funding the ROC/P.
  - "Fixed-Costs" add-on: Provide an Add-on for "base categorical" programs – Instructional materials, professional development, deferred maintenance, etc.
- **Establish Economic Recovery Target.** All schools get paid back deficit factor (including foregone cost of living adjustment) and 19.8% categorical program reduction.
- **Supplemental Grant.** Provide a supplemental grant for English learner (EL) and low income pupils (LI) and foster children. A weight will be used that reflects the best available research on additional costs of meeting the unique costs associated with helping these students become academically successful.
- **Concentration Grant.** Provide a concentration grant for English learner (EL) and low income pupils (LI) and foster children. A weight will be used that reflects the best available research on additional costs of meeting the unique costs associated with helping these students become academically successful.
- **Uses duplicated counts.** Uses duplicated rather than unduplicated counts of EL, LI and foster youth.
- **Expenditure Accountability.** Require funds to be spent on services for LI, EL and foster children.
- **Excluded Programs.** Excludes the same programs from the formula as the Governor with the addition of Foster Youth Services. Also excludes Adults in Correctional Facilities, Apprenticeship programs and Adult Education but maintains program requirements.
- **Home To School Transportation and Targeted Instructional Improvement Grant (TIIG).** Maintain TIIG as a separate add-on program per the Governor's proposal. Maintain the Home-to-School Transportation program as a separate program with the goal of equalizing funding formulas.
- **Accountability.**
  - Require school districts to adopt a plan consistent with the Single Plan for Student Achievement and other federal planning requirements.
  - Require EL and LI Master Plan within overall accountability plan regarding use of Supplemental Grant Funds.
  - Provide funds to develop a statewide accountability infrastructure that supports school districts and their ability to build local capacity to improve academic achievement for all pupils, including but not limited to providing technical assistance.

## RESOURCES AND ENVIRONMENTAL PROTECTION

### Secretary for Natural Resources

- **Forest Resource Management.** Approved \$217,000 (Timber Regulation and Forest Restoration Fund) and three permanent positions to implement the regulatory requirements of AB 1492 (Committee on Budget), Chapter 289, Statutes of 2012, which established new forest resource management funding through an assessment on lumber. The Governor proposed the positions be three-year limited term.
- **Ocean Programs.** Approved the shift of \$1.9 million (bond funds) and nine positions from the State Coastal conservancy to the Secretary in order to consolidate all ocean programs including the Ocean Protection Council within the Resources Agency.

### California Conservation Corps

- **Fire Prevention Activities.** Approved \$5 million (Proposition 40) annually for the next three years to support fire prevention activities.
- **Career Development.** Approved an augmentation of \$1.5 million (General Fund) for career development and transition assistance for Corpsmembers.

### Department of Conservation

- **Abandoned Mine Remediation.** Rejected \$500,000 (Abandoned Mine Remediation Fund) for increased department activity related to abandoned mines and instead directed the funding to the state's obligation related to Empire Mine remediation overseen by the Department of Parks and Recreation.

### Department of Forestry and Fire Protection

- **Civil Cost Recovery Program.** Approved a shift of \$4.2 million from the State Responsibility Area Fund (SRA Fund) to the General Fund for the Civil Cost Recovery Program. Approved the conversion of ten positions from limited-term to permanent in the program.
- **Forest Resource Management.** Approved \$967,000 and six permanent positions (Timber Regulation and Forest Restoration Fund) and three permanent positions to implement the expansion of Timber Harvest Plan reviews.
- **Fireworks Disposal.** Approved \$500,000 (General Fund) one time for the disposal of seized illegal and dangerous fireworks.

### Department of Fish and Wildlife

- **Salton Sea Restoration.** Approved \$12.1 million (Salton Sea Restoration Fund) for monitoring and pilot studies related to the Salton Sea Habitat restoration. Approved \$28 million (Proposition 84 bond funds) to construct managed ponds to support area wildlife.
- **Forest Resource Management.** Approved \$4.3 million and 35 permanent positions (Timber Regulation and Forest Restoration Fund) and three permanent positions to implement the expansion of Timber Harvest Plan reviews.
- **Agriculture and Grazing Leases.** Approved \$2.5 million (Wildlife Restoration Fund) for management and oversight of state-owned land. Approved trailer bill language to clarify that revenue generated from leases is authorized to be used to improve and maintain the intrinsic and ecological values of wildlife areas, ecological reserves and other DFW managed lands.

### California Coastal Commission

- **Local Coastal Plans.** Approved an augmentation of \$4 million (GF) including \$1 million local assistance and \$3 million state operations to increase the state's funding for local coastal plan updates.

### State Coastal Conservancy

- **Baseline Funding Realignment.** Approved a baseline funding realignment to implement the State Coastal Conservancy 10-year funding plan, submitted in April, in order to manage bond funds over a longer period of time.

### Department of Parks and Recreation

- **Goat Canyon Sediment Basin.** Approved \$1 million (DPR Fund) for three years including budget bill language for Goat Canyon Sediment Basin maintenance. Budget bill language directs the department to seek other funding for this project that is the result of polluted runoff from Mexico.
- **Boating and Waterways Merger.** Approved \$40.9 million and 73.5 positions to complete the merger of the Department of Boating and Waterways into the department as the Division of Boating and Waterways.

- **Off-Highway-Vehicles.** Approved the reappropriation of all Off-Highway-Vehicle (OHV) program requests.

### Department of Water Resources

- **FloodSAFE Program.** Approved \$82.9 million (Proposition 1E bond funds) for continued implementation of the flood management system through the FloodSAFE Program.
- **Lake Perris Dam.** Approved \$37.7 million (Proposition 84 bond funds) over two years for the state's share of the of the restoration of Lake Perris Dam to maximize operational and recreational facilities and remediate seismic and public safety concerns.
- **Fish Screens.** Approved \$10 million (Proposition 40 bond funds) to provide for the state's share of a state, local, and federal project on the Sacramento River. The project will include the installation of a fish screen for Anadromous fish protection and enhancement at the water intake project on the Sacramento River.

### Air Resources Board

- **Cap and Trade Loan.** Approved a \$400 million loan from the Greenhouse Gas (GHG) Reduction Fund to the General Fund, leaving \$100 million unappropriated and subject to legislation. Approved a repayment schedule starting in 2014-15 at \$100 million per year. Adjusted existing Special Fund loan repayment schedules to replace the Governor's solution.
- **Cap and Trade Auction Activities and Budgetary Administration.** Approved \$1.3 million and two positions from the Cost of Implementation Account to enhance oversight of Cap and Trade auction activities and budgetary administration.

### Department of Pesticide Regulation

- **Enforcement of Pesticide Regulations.** Approved five positions to increase enforcement of the state's pesticide regulations and the speed of pesticide product re-referral reviews and approvals.
- **Mitigation of Pesticide Use.** Approved \$788,000 (Department of Pesticide Regulation Fund) and five positions to address the mitigation of pesticide use in the environment. Provided provisional language to require the department to provide five risk assessments by June 30, 2014.



### State Water Resources Control Board

- **Beach Water Quality Monitoring.** Approved an \$800,000 (Waste Discharge Permit Fund) augmentation to the Board for Beach Water Quality Monitoring.
- **Nitrates in Drinking Water.** Adopted place-holder trailer bill language to address the issue associated with nitrate-contaminated groundwater. Approved seven positions to the Water Board to increase the oversight and enforcement of the state's laws and regulations dealing with agricultural wastewater discharges.
- **Small Disadvantaged Community Wastewater Projects.** Approved \$7 million for small disadvantaged community wastewater project grants to be funded by the State Water Pollution Control Revolving Fund, Small Community Grant Fund.
- **Forest Resource Management.** Approved \$620,000 (Timber Regulation and Forest Restoration Fund) and nine positions to implement the regulatory requirements of AB 1492 (Committee on Budget), Chapter 289, Statutes of 2012, which established new forest resource management funding through an assessment on lumber.

### Department of Resources Recycling and Recovery

- **Transfer of Office of Education and the Environment.** Approved \$2.3 million and ten positions to implement the transfer of Office of Education and the Environment from the Secretary to the Department of Resources Recycling and Recovery.
- **Beverage Container Recycling Program Reform.** Approved a proposal to reform the Beverage Container Recycling Program funding structure and collection methods to provide structural stability and increased financial management oversight.

### Office of Environmental Health Hazard Assessment

- **Identification of Disadvantaged Communities.** Approved \$577,000 and three positions from the Cost of Implementation Fee to identify disadvantaged communities in California that will benefit from investments made by the state from Cap and Trade allowance proceeds.

### California Energy Commission

- **Electric Program Investment Charge (EPIC).** Held Open approval of \$160 million and 55 positions from Investor Owned Utility ratepayer funds for the implementation of the Electric Program Investment Charge (EPIC), thus sending this issue to Conference.

- **Public Goods Charge Ramp Down.** Approved a multi-year plan for the reduction of positions and expenditures related to the Public Goods Charge (PGC) for renewable energy programs and the Public Interest Energy Research Program. This plan is necessitated due to the sunset of the PGC on January 1, 2012. The first year reduction includes a reduction of \$980,000 (PGC) and nine positions.
- **Proposition 39 Proposal.** Approved place-holder trailer bill language that: counts all associated Prop. 39 revenues toward the Prop. 98 minimum guarantee for schools and community colleges; distributes revenue based regional ADA calculation rather than on a per-student allocation to districts; awards 75 percent of revenues as Prop. 39 School Grants; awards 25 percent of revenues as Prop. 39 Loans and Loan Guarantees; provides Prop. 39 Workforce Development through Workforce Investment Board; and, provides standardized accountability measurements.
- **Prop 39 Positions.** Denied without prejudice \$4 million (Energy Resources Program Account) and eight positions for the California Energy Commission, to provide technical assistance to small local educational agencies. This funding was intended to help identify cost-effective energy savings opportunities for K-12 school facilities, and to provide guidance on establishing baselines and tracking performance.

### California Public Utilities Commission

- **Zero Based Budget.** Approved requiring the CPUC to submit, as part of the 2014-15 Governor's Budget, a zero-based budget.
- **JLBC Request.** Requested the Joint Legislative Audit Committee direct the Bureau of State Audits to conduct an audit of CPUC's processes for auditing the accounts of those entities it regulates for regulatory and tax purposes.
- **Fiscal Audit.** Requested the Department of Finance's Office of State Audits and Evaluations conduct a fiscal audit of the CPUC, paid for by the CPUC.
- **Expenditure of Settlement Monies.** Approved that the distribution or expending of proceeds of any settlements of claims by the CPUC be subject to the Joint Legislative Budget Committee process.
- **FPPC Review.** Approved a request to the Fair Political Practices Commission to review the CPUC practice of directing, adjudicating and approving the establishment of nonprofits for possible conflict of interest or behest violations.
- **Unauthorized Project Halt.** Approved trailer bill language halting the establishment of the California Energy Systems for the 21<sup>st</sup> Century Project that was not legislatively authorized and ordered a refund of all ratepayer funds that have been directed to this project.

- **Creation of Non-State Entities.** Approved trailer bill language that prohibits the CPUC from creating non-state entities through decisions, settlements, rules, orders, or mergers without a legislative approval process.
- **Conflict of Interest.** Approved trailer bill language that prohibits the CPUC from awarding contracts to nonprofits in which a sitting commissioner serves as an employee, officer or director. Approved trailer bill language that prohibits CPUC commissioners and executive staff from serving on commission-established non-state entities.
- **EPIC Position.** Denied \$88,000 (Electricity Program Investment Charge [EPIC]) and one position for oversight of the EPIC program proposed to be administered by the Energy Resources Development Commission. Required the CPUC to account for all positions and expenditures used to develop and adjudicate this program with a report back to the Legislature on January 10, 2014.
- **Demand-Side Program Facilitation Position.** Denied \$88,000 (PUC Utilities Reimbursement Account [PURA]) and one position for expanded policy programs at the CPUC including demand-side program facilitation and expansion.
- **Administrative Law Judge Positions.** Denied \$231,000 and two administrative law judge positions to implement the requirements of recently passed legislation.
- **High-Speed Rail.** Denied \$330,000 (Public Transportation Account, State Transportation Fund) to oversee the design and construction of California's High-Speed Rail system.
- **Division of Ratepayer Advocates.** Approved five positions and \$391,000 for the Division of Ratepayer Advocates (DRA) for energy financial examiners, water auditors and natural gas safety workload. Approval was granted provisionally such that DRA funds be used solely for the support of the DRA activities. Approved trailer bill language to provide DRA independence from CPUC.
- **Energy Efficiency Data Transparency.** Approved trailer bill language to require the CPUC to increase access to non-confidential utility data related to their energy efficiency and clean energy program results.

**Department of Food and Agriculture**

- **Nitrates in Drinking Water.** Approved seven positions to increase the management, research, oversight, regulation and enforcement of the state's laws and regulations related to fertilizer.
- **Specialized License Plates.** Approved \$577,000 (Specialized License Plate Fund) to award grants to agricultural education organizations with funds received from the sales and renewals of the specialized agriculture license plate.
- **Asian Citrus Psyllid.** Approved \$2.5 million (Department of Food and Agriculture Fund) for two years to provide resources to enhance the Asian Citrus Psyllid and Huanglongbing Mitigation Project. The Asian Citrus Psyllid are the carriers for Huanglongbing disease which is fatal to citrus trees.

## TRANSPORTATION

### CalTrans

- **Active Transportation Proposal.** Denied without prejudice, the Active Transportation Proposal, but adopted placeholder trailer bill language to require the Secretary of Transportation convene a stakeholder group over the summer with the intent of adopting a compromise on this issue after the budget is adopted.
- **Continue use of Special Funds for Transportation-Related Debt Service.** Approved the continued transfer \$67.0 million in special fund revenue to offset transportation debt service costs on a permanent basis.
- **Proposition 1B.** Appropriated \$258.2 million in Proposition 1B Bond Funding, reflecting the total amount anticipated for expenditure as of the May Revision.
- **Zero Base Budget-Local Assistance Program.** Approved a portion of Governor's January Budget reduction associated with the implementation of various efficiency measures, including the establishment of staffing levels that are consistent across 12 district offices. However, the Subcommittee restored positions that were proposed to be eliminated as part of the Active Transportation Program proposal.
- **Zero Base Budget-Planning Program.** Adopts a Governor's January Budget proposal to increase by \$8.4 million and 10 positions to address additional workload and implement various efficiency measures, including streamlining and standardizing Caltrans' planning documents and reducing administrative costs for existing grant programs.
- **Capital Outlay Support.** Approved a May Revision reduction of \$36.3 million and 256 FTEs (184 state staff, 64 consultants, and 8 from overtime) resulting from an analysis of the needed workload for the program.
- **Inter-City Rail.** Approved a May Revision increase of \$18.6 million special fund appropriations for the Pacific Surfliner AMTRAK line to reflect that due to a change in federal law, the State is now required to cover the federal share of cost for this service.
- **Zero-Based Budgeting for Equipment Program.** Approved a \$2.2 million reduction to the equipment program as a result of a zero-based budgeting analysis of the program that was reflected in the May Revision.
- **Zero-Based Budgeting for Stormwater Program.** Approved a May Revision proposal to redirect 50 positions for Capital Outlay Support and Administration to the Stormwater program to address workload associated with the National Pollution Discharge Eliminate System Stormwater Permit.

### Department of Motor Vehicles

- **Grass Valley Field Office.** Approved \$6.5 million to begin construction of a 7,583 square foot field office building in Grass Valley. This facility would replace the current 1,998 square foot facility that was formerly a California Highway Patrol building. The Assembly has previously approved funding for planning documents for this project in the 2012-13 budget.
- **Implementation of SB 1298 (Padilla).** Approved \$980,000 and two limited-term positions for the implementation of SB 1298 (Padilla), Chapter 570 Statutes of 2012, which allows for the testing of autonomous vehicles. The bill requires DMV to adopt regulations to specify insurance requirements, testing, equipment, and performance standards for the safe operation of autonomous vehicles.

### High Speed Rail

- **Administrative Staff.** Approved \$4.8 million and 44 positions for administrative support work associated with the ramp-up of the authority as project construction begins and \$265,000 and 41 positions to bring project management and oversight activities in-house. This request also includes provisional language to allow optional reimbursement to the authority and Caltrans to allow the Authority to use State staff for planning.
- **Authorizes Public Transportation Account Loan.** Approves provisional language to allow for a one-time loan of \$26.2 million to the High Speed Rail Bond fund from the Public Transportation Account for the Authority's operating costs. The loan provides an alternative funding source for the Authority's support costs as the Authority seeks a validation action to affirm that the overall project is consistent with the funding requirements of the Proposition 1A bond act.
- **Trailer bill language on Utility Relocation.** Adopts statutory language to establish a process and rules for the relocations of utilities outside the right-of-way for the High Speed Rail project. The language is modeled after procedures already in place for Caltrans projects.
- **Budget Consolidation Language.** Adopts budget bill language to allow unspent planning and acquisition funding to be reappropriated without reference to segment.

## **State Administration**

## STATE ADMINISTRATION

### Employment Development Department

- **Unemployment Insurance Federal Interest Loan Payment.** Approves the use of \$261.5 million from the General Fund to make interest payments on a federal loan.
- **Unemployment Insurance Program Administration Funding.** Approves the one-time use of \$29.7 million from the Contingent Fund to support 297 positions in the Unemployment Insurance Administration Unit that would otherwise be lost due to the federal sequester.

### Agricultural Labor Relations Board

- **Administrative Funding.** Approves \$189,000 in 2012-13, and \$502,000 in 2013-14 to support four new administrative support positions to allow the Board to operate its Oxnard office and improve timely responses to enforcing the Agricultural Labor Relations Act.

### Department of Industrial Relations

- **Continuation of the Occupational Safety and Health Fund and the Labor Enforcement and Compliance Fund.** Eliminates the sunset dates and increases the annual revenue caps of the Occupational Safety and Health Fund and the Labor Enforcement and Compliance Fund.
- **Stabilization of the Compliance Monitoring Unit.** Shifts internal funds and provides a one-time loan from the Targeted Inspection and Consultation Fund to stabilize the operations of the Compliance Monitoring Unit.
- **Elimination of the High Hazard Assessment.** Eliminates the High Hazard Assessment and shifts the assessment into the Occupational Safety and Health Fund, streamlining assessment collection for both businesses and the department. Shifts remaining funds and positions related to this assessment to the Process Safety Management Unit.
- **Implementation of Workers Compensation Reforms.** Approves \$152.9 million in 2013-14 and \$146.5 million in 2014-15 and 82 positions from the Workers Compensation Administration Revolving Fund to implement reforms required by SB 863 (De León), Chapter 363, Statutes of 2012. .
- **Augmentation of the Process Safety Management Unit.** Directs the department to use its statutory authority to approve a few to support an increase in funding and positions for the Process Safety Unit, which inspects oil refineries and chemical plants.

**Department of Veterans Affairs**

- **Improving Veterans Access to Federal Claims.** Authorizes \$6 million to develop state strike force teams that will work with the U.S. Department of Veterans Affairs to address the backlog in processing veterans claims. Also approves \$3 million in additional funding for County Veterans Service Offices.
- **Final Implementation of the Enterprise Wide Veterans Homes Information System.** Approves one-time funding of \$1.8 million General Fund to implement a new electronic medical records system at the Yountville Veterans Home.
- **Rector Reservoir.** Authorizes \$50,000 General Fund to allow the department to hire a technical water expert to develop plans for Rector Reservoir, and also creates trailer bill language that would allow the department to develop a water sales program if possible.
- **Activation of the Redding and Fresno Veterans Homes.** Approves \$24.5 million General Fund to continue the staffing ramp up at the Redding and Fresno veterans homes. Both homes are expected to admit their first residents in Fall 2013.
- **Conversion of Units at the West Los Angeles Veterans Home.** Approves the reduction of \$3.2 million General Fund to reflect the conversion of 82 beds from Skilled Nursing Facility to Domiciliary Units. The change will reduce state costs and allow the facility to better serve the area's homeless veterans population.

**Small Business and Economic Development Tools**

- **Economic Development Tools and Small Business.** Provides \$2 million for the California Small Business Expansion Fund for the administration of small business loans consistent with the Assembly Blueprint and provides for the implementation of local economic development tools.
- **Enterprise Zone Clarification.** Closes a loophole in Enterprise Zone Law to prohibit businesses in Enterprise Zones from obtaining additional credits when they laid off workers and later rehired them for lower wages and benefits.

**State Controller's Office**

- **21<sup>st</sup> Century Project.** Adopts the Governor's May Revise proposal, which supports multiple efforts to assist with the unwinding of the MyCalPays and the 21<sup>st</sup> Century project. Includes additional oversight of the project including priority for an assessment.

### **Retirement Costs**

- **Full Payment of Employee Retirement Costs.** Adopts the Governor's Budget proposal to pay the full costs of employee retirement.

### **Local Government Finance**

- **Amador, Alpine, and San Mateo Counties.** Adopts the Governor's May Revision proposal to provide funding to Amador, Alpine, and San Mateo Counties to make the counties whole for a shortfall associated with the tax swap provided as part of the "Triple Flip" that provided funding for the 2004 Economic Recovery Bonds.

### **Mandates**

- **Mandate Suspension.** Suspends five new mandates in addition to the mandates currently suspended, resulting in a cost savings of about \$519 million.
- **Additional Staff for Timely Mandate Determinations.** Adopts the Governor's proposal to hire additional staff to comply with statutory timeframes and provide timely mandate determinations.

### **Cash Management**

- **Additional Cash Management Provisions.** Adopts additional cash management provisions to improve the State's cash position.

### **Franchise Tax Board**

- **Ongoing Projects.** Provides additional resources for the Enterprise Data to Revenue to update and enhance the Franchise Tax Boards' tax systems and includes resources for improvements to the processing unit capacity to ensure that programs are administered successfully.

### **Board of Equalization**

- **Tax Compliance Measures.** Adopts two of the Governor's proposals to clarify that software delivered on media is tangible physical property subject to sales tax provisions. Adopts Governor's trailer bill language to prepare for the end of the triple flip by outlining a process to provide compensation to cities and counties once the mechanism is no longer need to pay for the Economic Recovery Bonds.

**Department of Housing and Community Development**

- **Proposition 1C.** Adopts Governor's May Revise proposal to provide \$25 million for the Housing Related Parks Program.
- **Proposition 1C Infill and Transit Oriented Development.** Extends the liquidation period for funds previously appropriated from the Regional, Planning, Housing and Infill Incentive Account and the Transit Oriented Implementation Fund. Requires the Department of Housing and Community Development to create criteria and a process for the liquidation, and adds a technical adjustment for disencumbered funds.
- **Emergency Housing Assistance Program.** Coordinates and integrates the Emergency Housing and Assistance Program Operating Facilities Grant (EHAP) and Emergency Housing and Assistance Capital Development (EHAP-CD) funds with the federal Homeless Emergency Assistance and Rapid Transition to Housing Act (HEARTH Act). Provides an additional \$1 million to implement the program.

**Secretary of State**

- **Business Filings Backlog.** Increases funding for additional staff to decrease the Business Filings Backlog, in order to achieve and maintain a 5 business-day processing time. Includes language requiring the Secretary of State's office to report monthly to the Department of Finance and Joint Legislative Budget Committee regarding their progress.
- **California Business Connect.** Continues funding for the information technology project that will create a centralized database for all business records and automate the filing and retrieving of business documents. The project is critical to maintaining a 5 business-day processing time for business filings, and is scheduled to be online in June 2016.

**Department of Insurance**

- **Affordable Care Act Mandates.** Approves funding and additional personnel to establish a California Health Benefit Exchange Program, and implement Health Insurance and Health Care Coverage reforms in compliance with federal Affordable Care Act mandates.

**Department of Consumer Affairs**

- **BreEZe.** Continues funding for the information technology project BreEZe, which will support all of the Department of Consumer Affairs' applicant tracking, licensing, renewal, enforcement, monitoring, cashiering, and data management needs.

**Commission on the Status of Women and Girls.**

**Support the Commission.** Provides a one-time General Fund appropriation to the Commission in order to support newly formed partnerships with the California Department of Veterans Affairs, the California Research Bureau, and the California Department of Education. Establishes a special account to house private funds, and includes language requiring the Commission expend all funds generated through donations prior to using any general fund dollars.

## PUBLIC SAFETY

### California Department of Corrections and Rehabilitation

- **Sex Offender Treatment for Non-High Risk Sex Offenders.** Approved \$5.0 million (increasing to \$12.4 million in 2014-15) to allow the California Department of Corrections and Rehabilitation (CDCR) to contract for sex offender treatment for both high risk and non-high risk sex offender parolees, as required by “Chelsea’s Law.”
- **Rehabilitative Programs.** Approved the reappropriation of \$3.1 million from unused rehabilitative program funding in support of the Prison Industry Authority (PIA). The PIA has proven to be effective in providing rehabilitative programs and reducing inmate recidivism. The PIA is required to provide an annual report to the Legislature and the Department of Finance detailing all of its projected expenditures and revenues.
- **Fire Camp Capacity.** Approved \$15.4 million to keep all 39 of the CDCR's male fire camps activated. The citizens of California receive a very direct and tangible benefit from the continued operation of the conservation camp program. The conservation camp crews currently provide emergency incident response, conservation work, and community service assistance.
- **Local Public Safety Funding for Probation.** Approved \$107 million (\$72 million more than proposed in the Governor's January proposal) in support of local probation department efforts to decrease jail and prison admissions by reducing criminal behavior.

### Judicial Branch

- **Restoration of Branch Funding.** Approved \$100 million directed specifically at reducing the impact of past reductions, improving public access to justice. Access to this funding stream is contingent to courts meeting specified accountability measures.
- **Trial Court Reserves.** Approved an 11 percent increase in the amount of reserves each court is allowed to hold. This increase will address the cash flow concerns identified by many local courts.

### Department of Justice

- **Firearm Background Checks.** Approved \$3.2 million to support background checks associated with new firearm purchases. According to DOJ reports, through this program, the DOJ has prevented over 27,000 firearms from being transferred to violent criminals, domestic batteries, and other dangerous individuals.

- **Controlled Substance Utilization Review & Evaluation System (CURES) 2.0.** Approved \$3 million to support an upgrade of the state's electronic prescription drug monitoring system. The current, problem-plagued, and antiquated system is ineffective due to low utilization rates by doctors and pharmacists. Consequently, diversion prevention and intervention efforts have been less than stellar.

**California Highway Patrol**

- **Air Fleet Replacement.** Approved \$17 million to support the replacement of CHP's four aircraft with the highest number of flight hours. CHP's aircraft play numerous roles California's health and safety system including search and rescue, emergency medical services, traffic enforcement, and assisting other law enforcement agencies.
