**Amendment to and Addition of Various Budget Bill Items and Reimbursements, and  
Statutory Changes, Support and Local Assistance, State Department of Education**

**Federal Funds Adjustment**

**Item 6100-001-0890 and 6100-178-0890, Support and Local Assistance, American Rescue Plan Act (ARPA) Emergency Assistance to Non-Public Schools (EANS II) Program (Issue 138 and 139)**—It is requested that Schedule (1) of Item 6100-001-0890 be increased by \$907,000 one-time federal ARPA carryover funds to support the administration of the Emergency Assistance to Non-Public Schools Program, which aims to provide services or assistance to eligible non-public schools to address the impacts of the COVID-19 pandemic.

It is further requested that provisional language be added as follows to conform to this action.

35. Of the amount appropriated in Schedule (1) \$907,000 is available on a one-time basis for state administrative expenses related to the Emergency Assistance to Non-Public Schools funds as provided under Section 2002(a) of the federal American Rescue Plan Act, 2021 (P.L. 117-2).

It is also requested that Item 6100-178-0890 be added in the amount of \$180,406,000 one-time federal ARPA carryover funds to support eligible non-public schools in addressing the impacts of the COVID-19 pandemic as part of the Emergency Assistance to Non-Public Schools Program.

It is further requested that Item 6100-178-0890 be added as follows to conform to this action.

Provisions:

1. The funds appropriated in this item are available on a one-time basis to support eligible nonpublic schools in accordance with the requirements of the Emergency Assistance to Non-Public Schools funds as provided under Section 2002(a) of the federal American Rescue Plan Act, 2021 (P.L. 117-2).

**Item 6100-001-0890, Support, Coronavirus Response and Relief Supplemental Appropriations (CRRSA) Emergency Assistance to Non-Public Schools (EANS I) Program (Issue 140)**—It is requested that Schedule (1) of Item 6100-001-0890 be increased by \$810,000 one-time federal CRRSA carryover funds to support the administration of the Emergency Assistance to Non-Public Schools Program, which aims to provide services or assistance to eligible non-public schools to address the impacts of the COVID-19 pandemic.

It is further requested that provisional language be added as follows to conform to this action.

36. Of the amount appropriated in Schedule (1), \$810,000 is available on a one-time basis for state administrative expenses related to the Emergency Assistance to Non-Public Schools funds as provided under Section 312(d) of the Coronavirus Response and Relief Supplemental Appropriations Act, 2021, (Division M, P.L. 116-260).

**Items 6100-001-0890 and 6100-104-0890, Support and Local Assistance, Project Advancing Wellness and Resilience in Education (AWARE) Grant (Issues 143 and 144)**—It is requested that Schedule (1) of Item 6100-001-0890 be increased by \$240,000 federal Project AWARE carryover funds for state-level support of the Project Cal-Well program funded by the Project AWARE grant. Project AWARE is a five-year grant program that provides funding for the Department and local educational agencies to increase awareness of mental health issues among school-aged youth, provide Mental Health First Aid training to teachers and other school personnel, and ensure students with signs of mental illness are referred to appropriate services.

It is further requested that provisional language be added to Item 6100-001-0890 as follows to conform to this action.

37. Of the amount appropriated in Schedule (1), \$240,000 in one-time federal carryover is available for state-level support of the Project Cal-Well program.

It is also requested that Item 6100-104-0890 be increased by \$150,000 one-time federal Project AWARE carryover funds for allocation to selected local educational agencies for programs and activities that increase access to mental health services for students and families.

It is further requested that provisional language be added to Item 6100-104-0890 as follows to conform to this action.

1. Of the funds appropriated in Schedule (1), \$150,000 in one-time federal carryover is available to support the existing Project AWARE program.

**Item 6100-001-0890 and 6100-104-0890, Support and Local Assistance, Project Students, Teachers, and Officers Preventing School Violence Grant (Cal-STOP) Program (Issues 145 and 146)**—It is requested that Schedule (1) of Item 6100-001-0890 be increased by \$481,000 federal Cal-STOP funds and 1 position in 2022-23 and 2023-24 for state-level support of the Project Cal-STOP federal grant. Project Cal-STOP is a two-year grant program that provides violence prevention and mental health training for students and staff in schools.

It is further requested that provisional language be added to Item 6100-001-0890 as follows to conform to this action.

38. Of the funds appropriated in Schedule (1), 1.0 position and \$481,000 in 2022-23 and \$481,000 in 2023-24, is available to support state-level activities related to violence prevention and mental health training programs for students and staff through Project Cal-STOP.

It is also requested that Item 6100-104-0890 be increased by \$1,038,000 one-time federal Project Cal-STOP funds for grants to nonprofit organizations to provide school violence prevention trainings and support schools in setting up mental health student organizations.

It is further requested that provisional language be added to Item 6100-104-0890 as follows to conform to this action.

2. Of the funds appropriated in Schedule (1), \$1,038,000 is available on a one-time basis to support the Project Cal-STOP program.

**Item 6100-001-0890, Support, Child Nutrition Technology Innovation Grant (Issue 232)**—It is requested that Schedule (2) of this item be increased by \$575,000 one-time federal Technology Innovation Grant carryover funds to support updates to the Food Distribution Program's warehouse management system.

It is further requested that provisional language be added to Item 6100-001-0890 as follows to conform to this action.

39. Of the funds appropriated in Schedule (2), \$575,000 is available on a one-time basis to support updates to the Food Distribution Program's warehouse management system.

**Items 6100-001-0890 and 6100-125-0890, Support and Local Assistance, Migrant Education Program, Migrant Education Program State-Level Activities, and English Language Acquisition Program (Issues 237, 239, 240, 241, 243)**—It is requested that Schedule (1) of Item 6100-001-0890 be increased by \$332,000 ongoing federal Title III,

Part A funds and 2 positions to support federal program monitoring reviews and technical assistance to local educational agencies for the support of English Learners.

It is further requested that provisional language be added to Item 6100-001-0890 as follows to conform to this action.

40. Of the funds appropriated in Schedule (1), \$332,000 federal Title III, Part A funds and 2.0 positions are provided for the Department to conduct federal program monitoring reviews of local educational agency English Learner programs.

It is also requested that Schedule (1) of Item 6100-125-0890 be increased by \$10,676,000 federal Title I, Part C funds to reflect a \$19,163,000 increase in one-time carryover funds and an ongoing \$8,487,000 decrease to align to the federal grant award. This program provides educational support services to meet the needs of highly mobile children.

It is further requested that provisional language be added to Item 6100-125-0890 as follows to conform to this action.

3. Of the funds appropriated in Schedule (1), \$19,163,000 in federal carryover is provided on a one-time basis to support the existing program.

It is also requested that Schedule (2) of item 6100-125-0890 be increased by \$2,492,000 ongoing federal Title I, Part C State Level Activity funds to align to the federal grant award. The state-administered Migrant Education programs include the Binational Migrant Education Program, Mini-Corps Program, and the Migrant Student Information Network.

It is also requested that Schedule (3) of item 6100-125-0890 be increased by \$4,576,000 ongoing federal Title III, Part A funds to align to the federal grant award. This program provides services to help students attain English proficiency and meet grade level academic standards.

**Item 6100-001-0890, Support, Private School State Operations Spending Authority (Issue 378)**—It is requested that Schedule (1) of this item be increased by \$1 million one-time federal Title II carryover funds for federally-required professional development of private school teachers and administrators.

It is further requested that provisional language be added to Item 6100-001-0890 as follows to conform to this action.

41. Of the funds appropriated in Schedule (1), \$1,000,000 in one-time federal carryover is available for the professional development of private school teachers and administrators as required by Title II of the federal Every Student Succeeds Act (20 U.S.C. Sec 6601 et seq.).

**Item 6100-001-0890 and 6100-117-0890, Support and Local Assistance, Comprehensive Literacy State Development Grant (Issues 464 and 474)**—It is requested that Schedule (1) of Item 6100-001-0890 be increased by \$300,000 one-time federal Comprehensive

Literacy State Development Grant carryover funds to support the administration of the grant. The Comprehensive Literacy State Development Grant advances literacy skills for children from birth through grade twelve, with an emphasis on disadvantaged children, including children living in poverty, English learners, and children with disabilities, through the use of evidence-based practices, activities and interventions, including pre-literacy skills, reading, and writing.

It is further requested that provisional language be added to Item 6100-001-0890 as follows to conform to this action.

42. Of the funds appropriated in Schedule (1), \$300,000 in one-time federal fund carryover is available for the administration of the Comprehensive Literacy State Development Grant.

It is also requested that Item 6100-117-0890 be added in the amount of \$415,000 federal Comprehensive Literacy State Development Grant carryover funds for grants to eligible local educational agencies.

It is further requested that Item 6100-117-0890 be added as follows to conform to this action.

6100-117-0890—For local assistance, State Department of Education, Comprehensive Literacy State Development Grant, payable from the Federal Trust Fund

Provisions:

1. The funds appropriated in this item are one-time federal fund carryover Comprehensive Literacy State Development Grant funds available to be awarded to local educational agencies in line with the grant program.

**Item 6100-001-0890, Support, Office of Administrative Hearings (Issue 544)**—It is requested that Schedule (1) of this item be increased by \$3.5 million one-time federal Individuals with Disabilities Education Act (IDEA) funds to support increased costs associated with special education dispute resolution services. The Department contracts with the Office of Administrative Hearings to provide special education services, which includes hearings, mediations, and related due process activities required by both state and federal law. The number of claims filed and the cost per case have increased over the past few years.

It is further requested that Provision 4 of this item be amended as follows to conform to this action.

“4. Of the funds appropriated in this item, ~~\$13,514,000~~ \$17,014,000, of which \$3,500,000 is available on a one-time basis, is for dispute resolution services, including mediation and fair hearing services, provided through contract for the special education programs. The State Department of Education shall ensure the quarterly reports that the contractor submits on the results of its dispute resolution services reflect year-to-date

data and final yearend data, includes the same information as required by Section 56504.4 of the Education Code, and includes the following information:

- (a) The total number of cases won by each side.
- (b) The number of issues decided in favor of each side in split decisions.
- (c) The number of cases in which schools and parents were represented by attorneys.
- (d) The number of requests for due process initiated by parents that were dismissed for insufficiency.
- (e) The number of pupils of color who accessed the system.
- (f) The number of non-English-speaking people who used the system.
- (g) The length of each hearing.
- (h) The number of hearing requests initiated by parents.
- (i) The number of hearing requests initiated by school districts.
- (j) The school district of each parent-initiated request for due process.
- (k) The issues, within special education, that generated due process hearing requests during the quarter.
- (l) The disabilities that generated due process hearing requests during the quarter.
- (m) The age groups (preschool, primary, junior high, high school) that generated hearing requests.
- (n) The number of requests received during the quarter.
- (o) The number of hearing decisions that were appealed to a court during the quarter.
- (p) The number of cases that were completely resolved in mediation by agreement.
- (q) The number of cases that were completely resolved in a mandatory resolution session."

**Item 6100-001-0890, Support, Special Education (Issues 545, 548, 549)**—It is requested that Schedule (1) of this item be increased by \$800,000 one-time federal Individuals with IDEA funds for the compilation and development of alternative coursework options and performance tasks to meet California's state graduation requirements.

It is further requested that provisional language be amended as follows to conform to this action.

"31. (a) Of the funds appropriated in Schedule (1), ~~\$200,000~~ \$1,000,000 in Individuals with Disabilities Education Act funds shall be available on a one-time basis to identify and develop alternative coursework and performance tasks for educators to use with students with disabilities who are not eligible for the California Alternate Assessments and may benefit from demonstrating completion of the state graduation requirements through alternate means.

(1) On or before October 1, 2022, the Superintendent of Public Instruction shall, in consultation with the executive director of the State Board of Education, contract with the federal comprehensive technical assistance provider for the state educational agency to conduct a national review of available alternative coursework options and performance tasks that are publicly available and can be compiled for use to meet California's state graduation requirements. Following completion of the review, the contractor shall, as needed, develop alternative coursework options and performance tasks that can be used to demonstrate completion of California's state graduation requirements. When performing these activities, the federal comprehensive technical

assistance provider for the state educational agency may enter into appropriate contracts to provide support and services, as necessary.

(b) On or before June 30, 2024, the Superintendent of Public Instruction and contractor shall provide the chairs of the relevant policy committees and budget subcommittees of the Legislature, the executive director of the State Board of Education or their designee, and the Director of Finance with the alternative coursework options and performance tasks available for use in California schools that meet each state graduation requirement."

It is also requested that Schedule (1) of this item be increased by \$238,000 federal IDEA funds and 2 positions to support increased workload associated with allocating special education funds.

It is further requested that provisional language be added as follows to conform to this action.

43. Of the funds appropriated in Schedule (1), \$238,000 federal Individuals with Disabilities Education Act funds and 2.0 positions shall be available to address workload associated with allocating special education funds.

It is also requested that Schedule (1) of this item be increased by \$215,000 federal IDEA funds to reflect one-time carryover for special education monitoring activities.

It is further requested that provisional language of this item be amended as follows to conform to this action.

"25. Of the funds appropriated in Schedule (1), ~~\$1,293,000~~ \$1,508,000 of Individuals with Disabilities Education Act (20 U.S.C. Sec. 1400 et seq.) funds, of which \$215,000 is one-time carryover, and 6.0 positions shall be available to address special education complaints and perform court-ordered special education monitoring of local educational agencies."

It is further requested that provisional language be amended as follows to conform to this action.

"32. Of the funds appropriated in Schedule (1), \$200,000 in Individuals with Disabilities Education Act funds shall be available on a one-time basis for the California Collaborative for Educational Excellence to convene a panel, comprised of members selected in consultation with and subject to the approval of the executive director of the State Board of Education, to continue refining the Individualized Education Program template designed by the workgroup authorized in Chapter 6, Statutes of 2020 for usability. On or before June 30, 2024, the California Collaborative for Educational Excellence shall provide the chairs of the relevant policy committees and budget subcommittees of the Legislature, the executive director of the State Board of Education or their designee, and the Director of Finance with an update on the development of a state standardized Individualized Education Program template."

**Item 6100-001-0890, Support, Early Head Start (Language Only)**—It is requested that provisional language be amended as follows to conform to this action.

“13. Of the funds appropriated in this item, \$1,470,000 shall be available to support local Early Head Start services under the Early Head Start-Child Care Partnership Grant, consistent with the plan approved by the Department of Finance. This funding is available on a limited-term basis until June 30, 2024. The funds appropriated in this provision shall not be used for indirect department costs.”

**Item 6100-067-0890, Support, ARPA Funds Administration (Issues 130,131,142, 242, and 631)**—It is requested that Item 6100-067-0890 be added in the amount of \$11,876,000 one-time federal ARPA carryover funds, of which \$10,530,000 and 6.5 positions reflect the availability of one-time federal carryover funds to support the administration and monitoring of federal relief funds provided to local educational agencies, and \$1,346,000 reflects one-time federal ARPA Homeless Children and Youth carryover funds for state-level activities which include implementation of Homeless Education Technical Assistance Centers and administering the Homeless Innovative Programs Grant program.

It is further requested that Item 6100-067-0890 be added as follows to conform to this action.

Provisions:

1. Of the funds appropriated in this item, \$10,530,000 and 6.5 positions are available on a one-time basis, of which 2.0 positions are provided for the Government Affairs Division, 2.5 positions are provided to the Audits and Investigations Division, 1.0 position for the Fiscal Administrative Services Division, and 1.0 position for the School Fiscal Services Division for workload related to COVID-19 relief funds.

2. Of the funds appropriated in this item, \$1,346,000 in federal carryover is provided on a one-time basis for administration of American Rescue Plan McKinney-Vento Homeless Children Education funding.

**Items 6100-113-0890 and 6100-113-0001, Local Assistance, Student Assessment Program (Issues 468 and 469)**—It is requested that Schedule (3) of Item 6100-113-0890 be decreased by \$136,000 ongoing federal Title I, Part B funds to align to the federal grant award.

It is also requested that Schedule (3) of Item 6100-113-0001 be decreased by \$1,477,000 ongoing Proposition 98 General Fund to align with estimated contract costs for the California Assessment for Student Performance and Progress administration in 2022-23.

It is further requested that Schedule (2) of Item 6100-113-0001 be increased by \$2,245,000 ongoing Proposition 98 General Fund to align with estimated contract costs for the English Language Proficiency Assessment for California administration in 2022-23.

It is further requested that Schedule (4) of Item 6100-113-0001 be decreased by \$1,175,000 ongoing Proposition 98 General Fund to align with estimated assessments apportionments for the 2021-22 school year.

**Item 6100-119-0890, Local Assistance, Program for Neglected and Delinquent Children (Issues 626)**—It is requested that Schedule (1) of this item be decreased by \$303,000 federal Title I, Part D funds to align to the federal grant award. This program provides supplemental instruction, including math and literacy activities, to children, youth, and adults in state correctional institutions to ensure that these youth make successful transitions to school or employment.

**Item 6100-134-0890, Local Assistance, Elementary and Secondary Education Act Program, Title I State Grant and School Improvement Program Grant (Issue 470)**—It is requested that Schedule (2) of this item be increased by \$44,522,000 ongoing federal Title I funds to align to the federal grant award. In accordance with California's Every Student Succeeds Act State Plan, Title I funds support eligible local educational agencies and schools that serve high numbers of low-income students.

It is further requested that provisional language be amended as follows to increase the amount of federal Title I funds allocated for school support in proportion to the state's increased Title I Basic Grant award:

"6. Of the funds appropriated in Schedule (2), no less than ~~\$129,432,000~~ \$133,724,000 is available for purposes of providing grants to local educational agencies with schools identified as requiring support, consistent with the California State Plan for the federal Every Student Succeeds Act (P.L. 114-95). The Department shall develop and administer a process for providing grants from these funds on a formula basis to local educational agencies with schools identified as requiring support. Local educational agencies shall use the funds for the development of strategies to improve pupil performance at schools identified as requiring support that are aligned to goals, actions and services identified in the local educational agency's local control accountability plan. Such funds shall not be expended to hire additional permanent staff."

**Item 6100-135-0890, Local Assistance, ARPA Homeless Children and Youth (Issue 244)**—It is requested that Schedule (1) of this item be increased by \$20 million one-time federal ARPA Homeless Children and Youth carryover funds. This program supports local educational agencies' efforts to identify homeless students and ensure equal access to public education.

It is further requested that provisional language be added to Item 6100-135-0890 as follows to conform to this action.

2. Of the funds appropriated in Schedule (1), \$20,000,000 in federal carryover is provided on a one-time basis to support the existing program.

**Item 6100-136-0890, Local Assistance, McKinney-Vento Homeless Children Education (Issue 245)**—It is requested that Schedule (1) of this item be increased by \$343,000

ongoing federal McKinney-Vento funds to align to the federal grant award. This program supports local educational agencies' efforts to identify homeless students and ensure equal access to public education.

**Item 6100-149-0890, Local Assistance, ARPA Carryover for After School Programs (Issues 318, 319, and 320)**—It is requested Item 6100-149-0890 be added in the amount of \$3,324,616,000 one-time federal ARPA carryover funds. Of this amount, \$3,293,906,000 is for transfer to the Department of Social Services, \$27,710,000 is for after and summer school programs, and \$3 million is for Save the Children to operate After School Education and Safety programs in rural school districts.

It is further requested that Item 6100-149-0890 be added as follows to conform to this action.

6100-149-0890—For local assistance, State Department of Education, American Rescue Plan Act for After School and Child Care Programs, payable from the Federal Trust Fund.....3,324,616,000

Provisions:

1. Of the funds appropriated in Schedule (1), \$3,000,000 shall be available for Save the Children to operate After School Education and Safety programs in rural school districts for the purposes of Section 2001(f)(3) of the federal American Rescue Plan Act of 2021 (P.L. 117-2).

2. Of the funds appropriated in Schedule (2), \$3,296,906,000 is provided for transfer to the State Department of Social Services.

**Item 6100-156-0890, Local Assistance, Adult Education Program (Issues 777 and 779)**—It is requested that this item be increased by \$19,858,000 federal Workforce Innovation and Opportunity Act, Title II funds to reflect a \$16 million increase in one-time carryover funds, and a \$3,858,000 ongoing increase to align to the federal grant award. The federal Adult Education Program supports adult basic education, English as a second language, and adult secondary education programs.

It is further requested that provisional language be added as follows to conform to this action.

5. Of the funds appropriated in Schedule (1), \$16,000,000 in one-time federal carryover is available to support the existing program.

**Item 6100-161-0890, Local Assistance, Special Education (Issue 552)**—It is requested that Schedule (1) of this item be decreased by \$14,758,000 ongoing federal IDEA funds to align to the federal grant award to support special education programs for students.

It is also requested that Schedule (3) of this item be decreased by \$611,000 ongoing federal IDEA funds to align to the federal grant award to support special education programs for preschoolers.

It is also requested that Schedule (4) of this item be decreased by \$1,460,000 federal IDEA funds to align to the federal grant award to support state improvement of special education programs.

**Item 6100-166-0890, Local Assistance, Vocational Education Program (Issues 550 and 551)**—It is requested that this item be increased by \$24,256,000 federal Perkins V Act funds to reflect the availability of \$24.5 million one-time carryover funds and a \$244,000 ongoing decrease to align to the federal grant award. The Vocational Education Program develops the academic, vocational, and technical skills of students in high school, community colleges, and regional occupational centers and programs.

It is further requested that provisional language be added as follows to conform to this action.

4. Of the funds appropriated in this item, \$24,500,000 in one-time federal carryover is available to support the existing program.

**Item 6100-195-0890, Local Assistance, Adjustment to Align Title II Federal Grant (Issue 384)**—It is requested that Schedule (1) of this item be decreased by \$3,420,000 ongoing federal Title II, Part A funds to align to the federal grant award.

It is also requested that Schedule (3) of Item 6100-195-0890 be decreased by \$55,000 federal Title II, Part A funds to align to the federal grant award.

It is further requested that provisional language be amended as follows to conform to this action.

"2. Of the funds appropriated in Schedule (3), ~~\$14,139,000~~ \$14,084,000 in ongoing federal funds shall be used to support the 21st Century California School Leadership Academy pursuant to Section 44690 of the Education Code. Specifically, this amount reflects ~~\$8,834,000~~ \$8,779,000 in ongoing federal Title II funds, and \$5,305,000 in ongoing federal Title IV funds, transferred to Title II, consistent with the California State Plan adopted by the State Board of Education pursuant to the Every Student Succeeds Act. This program shall be implemented pursuant to Title II of the federal Every Student Succeeds Act (20 U.S.C. Sec. 6601 et seq.) and consistent with the statewide system of support pursuant to Article 4.5 (commencing with Section 52059.5) of Chapter 6.1 of Part 28 of Division 4 of Title 2 of the Education Code."

**Item 6100-197-0890, Local Assistance, 21st Century Community Learning Grant Federal Adjustment (Issues 321, 322, and 323)**—It is requested that Schedule (1) of this item be increased by \$39,925,000 Federal Trust Fund to reflect a \$4,342,000 increase to align to the federal grant award, \$32,583,000 in one-time carryover from the Federal ARPA Elementary and Secondary School Emergency Relief Grant III funds and \$3 million in one-time carryover funds.

It is further requested that provisional language be added as follows to conform to this action.

1. Of the funds appropriated in this item, \$3,000,000 in one-time federal carryover is available to support the existing program.
2. Of the funds appropriated in this item, \$32,583,000 in one-time federal carryover is available for the same purposes as authorized in Item 6100-197-0890 of the Budget Act of 2021.

**Item 6100-201-0890, Local Assistance, Federal Child Nutrition Program (Issue 246)**—It is requested that this item be decreased by \$1,210,796,000 ongoing Federal Trust Fund to reflect a decrease in anticipated growth in the federal reimbursement rates for child nutrition programs.

### **Trailer Bill Language**

**California State Preschool Program**—It is requested that statutory changes transmitted with the Governor's Budget be amended to:

- Clarify the definitions for early education and the California State Preschool Program and to reflect an adjustment factor for two-year-old children consistent with statute authorizing California State Preschool Program providers to serve eligible two-year old children that was transmitted with the 2022-23 Governor's Budget.
- Clarify the ratios applicable to joint transitional kindergarten and preschool classes.
- Reflect that contractors will not collect family fees for the 2022-23 fiscal year and that contractors must reimburse providers from a family childcare home education network for their full amount of their voucher without deducting family fees.
- Reimburse California State Preschool Contractors based off full enrollment rather than attendance in the 2022-23 fiscal year.
- Increase the audit threshold triggering an annual fiscal audit, rather than biannual audit, from \$25,000 to \$100,000.

**Inclusive Early Education Expansion Program**—It is requested that statutory changes transmitted with the Governor's Budget be amended to remove the requirement for school districts to meet the 33 percent match if they are experiencing financial hardship.

**California Community Schools Partnership Act Program**—It is requested that statutory changes transmitted with the Governor's Budget be amended to: (1) appropriate \$1.5 billion one-time non-Proposition 98 General Fund for the existing program; (2) clarify the role of community school networks, community-based organizations, reporting and accountability requirements, and permitted uses and restrictions of grant funds; and (3) specify that funds shall not be used for punitive disciplinary practices.

**Transitional Kindergarten**—It is requested that statutory changes transmitted with the Governor's Budget be amended to: (1) define a unit for purposes of a specified degree program at institutions of higher education; (2) clarify fiscal penalties for infractions related to class size ratios and teacher education requirements in transitional kindergarten classrooms; (3) until June 30, 2026, authorize individuals meeting specified criteria to teach on a local assignment option in a transitional kindergarten classroom for at least one school year; (4) clarify that funding proposed in the 2022-23 Governor's Budget to add one additional certificated or classified staff person to every transitional kindergarten class be allocated based upon second principal apportionment average daily attendance; and (5) clarify the ratios applicable to joint transitional kindergarten and preschool classes.

It is also requested that statutory changes be added to: (1) clarify that a child identified as a English learner would be qualified as a dual language learner, (2) to extend the deadline to establish procedures to implement the bill to August 15, 2022, and (3) to only require a family interview for children who are identified as dual language learners.

It is also requested that statutory changes be added to require the California Longitudinal Pupil Achievement Data System to collect data on pupils in transitional kindergarten separate from pupils in kindergarten.

**Declining Enrollment**—It is requested that statutory changes transmitted with the Governor's Budget be amended to: (1) revise the computation of the proposed three-year declining enrollment protection for school districts by modifying the computation of 2021-22 average daily attendance for the purposes of the three year-average; (2) provide a declining enrollment protection for classroom-based charter schools for the 2021-22 fiscal year only; and (3) make technical revisions to further refine the proposed declining enrollment protections.

**Independent Study Requirements**—It is requested that statutory changes transmitted with the Governor's Budget be amended to clarify: (1) tiered reengagement requirements for pupils in traditional independent study; (2) written agreement requirements; (3) exemptions from extended independent study requirements; (4) requirements for calculating synchronous instructional time in the calculation of daily and total instructional time for average daily attendance collection purposes in a traditional independent study program; and (5) that if a parent of a student with disabilities requests independent study, the student's Individualized Education Plan team shall make an individualized determination whether the student can receive a free appropriate public education in an independent study placement.

**Local Control and Accountability Plan Special Education Addendum**—It is requested that statutory changes transmitted with the Governor's Budget be amended to extend the development and implementation of the Special Education Addendum and modify the entities required to complete the addendum.

**Golden State Pathways Program**—It is requested that statutory changes transmitted with the Governor's Budget be amended to: (1) extend the timeline for which funding is available from 5 years to 7 years, (2) specify that a community college may apply in partnership with a local educational agency to receive funding under the program, and (3) encourage applicants to describe ways in which they will leverage other state programs to support college and career pathways developed or offered under the program.

**Special Olympics**—It is requested that statutory changes transmitted with the Governor's Budget be amended to clarify that funds may also be used to cover general operating expenses.

**Kitchen Infrastructure and Training Funding**—It is requested that statutory changes transmitted with the Governor's Budget be amended to: (1) provide authority to use funding reallocated from Item 6100-203-0001 for the same allowable uses as specified

for the Kitchen Infrastructure and Training grants; (2) make all participating local educational agencies eligible for additional infrastructure funding beyond the base grant; (3) update the allocation formula for infrastructure funding to be proportionate based on meals served; and (4) require local educational agencies, to the extent practicable, to acquire energy-saving electric and induction equipment when purchasing new equipment.

**Multilingual School and Classroom Library Program**—It is requested that statutory changes transmitted with the Governor's Budget be amended to: (1) extend the encumbrance and expenditure date from June 30, 2023 to June 30, 2024; (2) update the allocation formula for grants to schools; (3) update eligibility requirements for schools to receive funding; (4) require the Department of Education to provide technical assistance to schools receiving funding; (5) update planning and reporting requirements for local educational agencies receiving funding; and (6) adds and amends various definitions.

**Literacy Coaches and Reading Specialists Grant Program**—It is requested that statutory changes transmitted with the Governor's Budget be amended to ensure that local educational agencies receive a minimum of \$450,000 over the three year grant period for each eligible school-site, and to remove a matching fund requirement from the grant program.

**Expanded Learning Opportunities Program**—It is requested that statutory changes transmitted with the Governor's Budget be amended to further clarify the Expanded Learning Opportunities Program's definitions and to make other technical amendments.

**School Transportation Grant Program**—It is requested that statutory changes transmitted with the Governor's Budget be amended to support school transportation programs, with a focus on greening school bus fleets, to enable the program's proposed grants to be allocated over a five-year period and to modify the reporting requirements for grant recipients.

**Department of Education-Retained Fiscal Experts and Advisors**—It is requested that statutory changes be added to align the funding mechanism for reimbursing the Department of Education for its fiscal oversight of county offices of education with that of the reimbursement process for county offices of education performing the same function for local educational agencies.

**County Office of Education LCFF Base Increase**—It is requested that statutory changes be added to provide a base increase to the Local Control Funding Formula apportionments for county offices of education.

**Single District County Offices of Education Technical Assistance Funding**—It is requested that statutory changes be added to provide a base level of funding for county offices of education where the county board of education serves as the governing board of any school district under its jurisdiction, for purposes of supporting school districts identified for differentiated assistance pursuant to subdivision (c) of Section 52071.

**County Office of Education Adjustment for Charter Schools Identified for Differentiated Assistance**—It is requested that statutory changes be added to provide funding for county offices of education to provide technical assistance to charter schools identified for differentiated assistance pursuant to subdivision (a) of Section 47607.3, commencing with the 2022-23 fiscal year.

**Observation Protocol for Teachers of English Learners Deadline Extension**—It is requested that statutory changes be added to extend the deadline for the development of a standardized English language teacher observation protocol tool from December 31, 2022 to December 31, 2023 due to contract delays for conducting the field study.

**Basic Aid Court Ordered Voluntary Pupil Transfer Adjustment**—It is requested that statutory changes be added to clarify that basic aid school districts serving basic aid court ordered voluntary pupil transfers will continue to receive apportionment funding to serve those students.

**AB 1055 Foster Youth Definition Cleanup**—It is requested that statutory changes be added to amend the definition of foster youth in various Education Code sections to include youth subject to a Welfare and Institutions Code 602 petition which was unintentionally removed in AB 1055.

**Necessary Small School Funding Bands**—It is requested that statutory changes be added to adjust the funding bands used to compute necessary small schools entitlements to provide qualifying necessary small schools with the greater of either their computed local control funding formula entitlement or their computed necessary small schools entitlement.

**National Board Certification Incentive Grant**—It is requested that statutory changes be added to allow the Department to award the full grant award to a candidate in a single payment rather than 50 percent upon application and 50 percent upon completion of a certification, in alignment with recent changes to the National Board for Professional Teaching Standards payment policies.

**Wildfire Necessary Small Schools Funding Protection for Pioneer Union Elementary**—It is requested that statutory changes be added to provide emergency funding protections to school districts that have had a necessary small school site become temporarily inoperative due to an emergency.

**Technical Amendment for Statewide Benefit Charters: Sunset Date Extension**—It is requested that statutory changes be added to reflect a technical amendment extending the sunset date for statewide benefit charter schools transitioning to local authorization.

**SB 14 Clean Up**—It is requested that statutory changes be added to remove the requirement for the State Board of Education to update its illness verification regulations

since it creates additional workload and is not necessary for implementing provisions of the bill.

**California College Guidance Initiative**—It is requested that statutory changes be added to: (1) strike references to the California College Guidance Initiative (CCGI) providing services to elementary school pupils as part of its role within the Cradle-to-Career Data System; and (2) move CCGI's annual budget reporting deadline from April 1<sup>st</sup> to September 1<sup>st</sup> of each year.

**Community Engagement Initiative Expansion Funding**—It is requested that statutory changes be added that appropriate \$100 million Proposition 98 General Fund to strengthen and expand the Community Engagement Initiative (CEI). This second round of funding for the CEI is intended to provide increased and enhanced emphasis on engagement of students in all aspects of the CEI, expand the use of the CEI's identified metrics to create a common definition and clear standards for meaningful engagement at the local and state level, develop in-depth trainings and increase capacity to scale up the CEI, and support additional community engagement professional learning networks.

**2021 Kitchen Infrastructure and Training Funding Flexibility**—It is requested that statutory changes be added to provide local educational agencies flexibilities to use remaining training funds from the 2021 Kitchen Infrastructure and Training program for eligible infrastructure improvements.

**Math and Science Professional Development Funding**— It is requested that statutory changes be added that appropriate \$385 million Proposition 98 General Fund for professional development and family engagement to support educators in implementing California's science and mathematics standards and frameworks for pupils in preschool and transitional kindergarten through grade 12.

**Statewide Assessment Independent Evaluation Extension**—It is requested that statutory changes be added to: (1) extend the deadline for the Department of Education to submit the independent evaluation of the statewide assessment system to October 31, 2023, and (2) allow the Department, in consultation with the executive director of the State Board of Education, to extend the contract for the independent evaluation by a period of up to two years, if additional time is needed to complete the evaluation.

**Discretionary Block Grant and Mandates Debt Payments**—It is requested that statutory changes be added that appropriate \$8 billion one-time Proposition 98 General Fund to K-12 LEAs for discretionary use that would also reduce outstanding mandate cost balances for schools. Funds could be used for a variety of one-time costs, including, but not limited to, one-time expenditures to protect staffing levels, addressing student learning challenges, implementing new state initiatives as well as recently updated standards, frameworks, and curriculum, and operational costs and supporting the mental health and wellness needs of students and staff.

**Deferred Maintenance**—It is requested that statutory changes be added to appropriate \$1,705,985,000 one-time Proposition 98 General Fund to address deferred maintenance projects for school districts.

**Various Technical Amendments**—It is requested that statutory changes be amended to make various technical amendments as follows:

- Make a technical amendment to the special education base funding calculation to clarify how to utilize charter school Average Daily Attendance.
- Make a technical amendment to the State System of Support Medi-Cal Billing Guidance Lead to clarify the ongoing appropriation.
- Amend Provision 25 of Item 6100-001-0890 of the Budget Act of 2021 to extend the report deadline to October 1, 2024, and extend the encumbrance period for the funds through fiscal year 2024-25.
- Amend provisional language reflected in Item 6100-001-0001 of the 2021 Budget Act to clarify the period of availability for funds allocation to support the development of direct deposits to State Preschool contractors and relating to updates to the California Preschool Learning Foundations to address a previous chaptering issue.
- Align provisional language in Item 6100-197-0001 of the 2021 Budget Act to clarify that the applicable rate increases are for the 21<sup>st</sup> Century Community Learning Centers Program.

**Amendment to 6100-194-0001 of the 2021 Budget Act**—It is requested that statutory changes be added to reflect the increase of \$1.1 million ongoing General Fund to support waiver of family fees in fiscal year 2021-22 consistent with the Budget Act of 2021. This adjustment should provide the funding necessary to support the family fee waiver until the end of fiscal year 2021-22.

**LGBTQ+ Cultural Competency Training Lead Partner and Advisory Committee Funding Encumbrance Extension**—It is requested that statutory changes be added to extend the encumbrance period for funding appropriated through the Budget Act of 2021 for the Department to contract with a LGBTQ+ organization to act as a lead partner in the creation of LGBTQ+ cultural competency training, and to convene an advisory committee to work with the lead partner and various entities in creating the trainings. This extension will align the encumbrance period for this work to that of related work mandated through trailer bill (AB 130, Section 148).

**Educator Effectiveness Block Grant (AB 130, Sec. 22)**—It is requested that statutory changes be added to extend the deadline for local educational agencies to develop and adopt an expenditure plan for purposes of the program to March 31, 2023.

**2022 Dashboard Technical Cleanup (AB 130, Sec. 123)**—It is requested that statutory changes be added to ensure the Department of Education can use English learner performance data from English Language Proficiency Assessments for California summative assessments taken in the 2020-21 school year to determine a local educational agency's English Learner Progress Indicator status for purposes of the 2022 Dashboard.

**Educator Workforce Investment Grant**—It is requested that statutory changes be added to appropriate \$15 million Proposition 98 General Fund to further support the Educator Workforce Investment Grant Program established pursuant to Section 84 of Chapter 51, Statutes of 2019, to coordinate and support professional learning opportunities for educators across the state.

**Routine Restricted Maintenance Account**—It is requested that statutory changes be added to clarify that school districts and county offices of education should be excluding routine restricted maintenance account deposits from their GANN limit submissions to the Department of Education starting with the 2021-22 fiscal year.

**Amendment to Budget Bill Item 6100-301-0001 and Addition of Items 6100-492 and 6100-498, Capital Outlay, California Department of Education**

**California School for the Deaf – Riverside: Athletic Complex Replacement and Expansion – Study and Preliminary Plans**—It is requested that Item 6100-301-0001 (Attachment 1) be increased by \$2,471,000 one-time to provide \$280,000 for the study phase and \$2,191,000 for the preliminary plans phase of an overall \$43.1 million project to replace all outdoor sports fields (Football, Track, Softball, and Baseball) and add a stand-alone practice soccer field at the California School for the Deaf - Riverside. Existing fields date to the opening of the school in the 1950s and are no longer able to support the athletic needs of the school.

**California School for the Deaf – Riverside: Remove Modular Buildings – Reappropriate Working Drawings, Revert Existing Construction Appropriation and Provide New Construction Authority**—It is requested that Item 6100-492 (Attachment 2) be added to reappropriate the working drawings phase of the California School for the Deaf – Riverside: Remove Modular Buildings project. Provisional language in Item 6100-301-0001 of the 2021 Budget Act authorized additional time to encumber working drawings, but inadvertently excluded this project.

It is further requested that Item 6100-301-0001 (Attachment 1) be increased by \$1,744,000 one-time for the construction phase of this project and Item 6100-498 (Attachment 3) be added to revert \$1,478,000 of existing authority for the construction phase, resulting in a net increase of \$266,000. The national construction market has experienced significant inflation since 2021. The California Construction Cost index, which is the metric the state uses to track overall construction prices, has increased by approximately 10 percent since the Governor's Budget and 25 percent for capital projects that were proposed in the 2021-22 budget. This request will address the cost increases resulting from these inflationary pressures to ensure projects can proceed to

the construction phase with adequate funding. Providing new construction funds and reverting prior funds for these projects allows for easier project tracking.

It is further requested that provisional language be added to Item 6120-011-0001 as follows to conform to this action:

3. Of the funds appropriated in Schedule (1), \$570,000 shall be available on an ongoing basis to support the modernization of library services and online database subscriptions and e-books to support the research needs of California policymakers and state agencies.

**Amendment to Budget Bill Item 6360-001-0001 and Statutory Changes, Support,  
Commission on Teacher Credentialing**

**Early Childhood Education Preparation and Licensure Support, (Issue 40)**—It is requested that Schedule (1) of this item be increased by \$946,000 ongoing General Fund and 7 positions to support early childhood education preparation and licensure activities.

It is also requested that Schedule (2) of this item be added in the amount of \$597,000 General Fund and 4 positions through the 2024-25 fiscal year, and \$309,000 General Fund and 2 positions thereafter, to support early childhood education preparation and licensure activities.

It is further requested that provisional language be amended and added as follows to conform to these actions:

"3. Of the funds appropriated in ~~this item~~ Schedule (1), \$161,000 and 1.0 position is provided to provide technical assistance to the California Department of Education and the Personnel Management Assistance Teams as defined pursuant to Chapter 3.8 (commencing with Section 44740) of Part 25 of Division 3 of the Education Code.

4. Of the funds appropriated in ~~this item~~ Schedule (1), \$161,000 and 1.0 position is provided to support administration and fiscal coordination of credential and examination fee waivers."

5. Of the funds appropriated in ~~this item~~ Schedule (1), \$763,000 and 5.0 positions are available to support outreach, contracting, technical assistance, and administration of multiple grant programs including, but not limited to, Teacher Residencies, Classified School Employee Credentialing Grants, Integrated Teacher Preparation Program Grants, and Computer Science Supplementary Authorization Grants.

6. Of the funds appropriated in ~~this item~~ Schedule (1), \$1,400,000 and 9.0 positions are available to support the Roadmap to Educational Careers initiative. Of the 9.0 positions, 8.0 positions shall serve as career guidance counselors, credential experts, subject matter experts, and resource specialists for individuals seeking to make the transition into a PK–12 educational career. Of the 9.0 positions, 1.0 position shall be available to assist with development and maintenance of a multifaceted web portal on the Commission's website and social media connection and presence.

8. Of the funds appropriated in ~~this item~~ Schedule (1), \$900,000 and 1.0 position is for public outreach to support educational careers in California PK–12 classrooms. The Commission shall collaborate with the executive director of the State Board of Education to develop a competitive process to contract with an outreach partner on or before December 15, 2022, to support this public outreach. The outreach provided by the contractor shall be informed by the Personnel Management Assistance Teams and their recruitment efforts, and shall highlight, at minimum, all of the following:

(a) The value and benefits of educational careers in California's PK–12 schools.

(b) The state investments and numerous resources available to teacher candidates.

(c) Pathways of connection for interested individuals with the Commission's career guidance counselors. The Commission shall report on outreach efforts to the Department of Finance effective April 30, 2024, and bi-annually thereafter, on all of the following:

(a) Objectives completed and their associated costs.

(b) A general description of each strategy or method used for outreach.

(c) Geographic areas and special populations targeted, if any, and why the special targeting was needed.

(d) A comparison to the previous years' outreach efforts, if applicable.

In implementing this, the Commission may amend any existing or future outreach contracts that it has entered into pursuant to this provision. Notwithstanding any other provision of law, any such contract entered into, or amended, as required to implement this provision, shall be exempt from the approval of the Director of General Services and from the provisions of the Public Contract Code.

9. Of the funds appropriated in Schedule (1), \$946,000 and 7.0 positions are available to support early childhood education preparation and licensure activities.

10. Of the funds appropriated in Schedule (2), \$597,000 and 4.0 positions are available through the 2024-25 fiscal year, and \$309,000 and 2.0 positions are available thereafter, to support early childhood education preparation and licensure activities."

**Credential and Exam Fee Waivers (Language Only)**—It is requested that provisional language be added to include the preliminary designated subjects adult education teaching credential as one of the credential types eligible for fee waiver pursuant to Provision (1) of this item.

It is also requested that provisional language be added to include the California Teacher of English Learners Examination and the California Preliminary Administrative Credential Examination as exams that are eligible for fee waiver pursuant to Provision (2) of this item.

It is further requested that provisional language be amended as follows to conform to these actions:

"1. Of the funds appropriated in ~~this item~~ Schedule (1), \$12,000,000 shall be available on a one-time basis for the Commission on Teacher Credentialing to waive the fee for first-time credential applicants in 2022–23. The fee shall be waived only for a candidate's initial application for the following credentials: preliminary multiple subject, single subject, or education specialist teaching credential, preliminary career technical education credential, intern credential, preliminary administrative services credential, preliminary designated subjects adult education teaching credential, preliminary speech-language pathologist services credential, pupil personnel services credential, preliminary school nurse services credential, preliminary teacher librarian services credential, clinical rehabilitative services credential, certificates of clearance document, child development permit, substitute permit, and teaching permit for statutory leave. No fee waiver may be granted for renewal costs associated with currently licensed individuals. On or before October 1, 2023, the Commission on Teacher Credentialing shall report the number of fee waivers provided to applicants by type to the Department of Finance, and the appropriate fiscal and policy committees of the Legislature. Reports shall be made in conformance with Section 9795 of the Government Code.

2. Of the funds appropriated in ~~this item~~ Schedule (1), \$24,000,000 is available for the Commission to waive the examination fee for the California Basic Educational Skills Test, Reading Instruction Competence Assessment, any California Subject Examinations for Teachers, the California Teacher of English Learners Examination, the California Preliminary Administrative Credential Examination, and teacher and administrator performance assessments, regardless of passing score. Any waived examination fee shall directly eliminate the fee or fees paid directly by an individual examinee and shall not be provided to offset any fee or fees paid by an agency or institution on behalf of an examinee. On or before October 1, 2023, the Commission on Teacher Credentialing shall report the number of examination fee waivers by type to the Department of Finance, and the appropriate fiscal and policy committees of the Legislature. Reports shall be made in conformance with Section 9795 of the Government Code. Any funds not used for this purpose shall be used to support integrated teacher preparation programs, pursuant to Section 44259.1 of the Education Code."

**Data Gathering and Support Positions (Language Only)**—It is requested that provisional language be amended to add specificity around the data gathering and report efforts to be supported by resources provided in Provision (7).

It is further requested that provisional language be amended as follows to conform to this action:

7. Of the funds appropriated in ~~this item~~ Schedule (1), \$453,000 and 4.0 positions are available to support data gathering around California's PK–12 educational workforce, reporting and analysis for Cradle-to-Career data reporting, teacher grant program reporting, and research, and analysis of, but not limited to, CalSAAS, including how CalSAAS relates to the State Department of Education's PK-12 educational workforce data reporting for the federal Every Student Succeeds Act (P.L. 114-95), the School Accountability Report Card, and data reporting for the Local Control Funding Formula and the Local Control and Accountability Plan–Cradle to Career, California's PK–12 educational workforce, and teacher grant programs.

**Teacher Residency Technical Assistance Centers**—The Administration proposes statutory changes to appropriate \$20 million one-time Proposition 98 General Fund to support a statewide technical assistance center to support teacher residency programs.

**Teacher Residency Grant Program**—The Administration proposes statutory changes to appropriate \$500 million one-time Proposition 98 General Fund to augment the Teacher Residency Grant Program to support teacher and school counselor residency programs that recruit and support the preparation of teachers and school counselors.

**Amendment to and Addition of Various Budget Bill Items, Support, and Statutory Changes, University of California**

**Institute for Immunology and Immunotherapy at University of California (UC) Los Angeles**—It is requested that Item 6440-001-0001 be increased by \$300 million one-time General Fund for the construction of the Institute for Immunology and Immunotherapy at UCLA. An additional \$200 million one-time General Fund in 2023-24 will further support the construction of the Institute for Immunology and Immunotherapy at UCLA.

It is further requested that Provision 24 of Item 6440-001-0001 be added as follows to conform to this action:

24. Of the funds appropriated in this time, \$300,000,000 shall be available for the construction of an Institute for Immunology and Immunotherapy at UCLA. One-time funding appropriated pursuant to this provision is not subject to Section 89773 of the Education Code.

**Support for Labor Centers**—It is requested Item 6440-001-0001 be increased by \$13 million ongoing General Fund to support UC labor centers.

It is further requested that Provision 27 of Item 6440-001-0001 be added as follows to conform to this action:

27. Of the fund appropriated in this item, \$13,000,000 shall be available on an ongoing basis to support the activities of UC labor centers.

**Support for UC Berkeley Center for Responsible, Decentralized Intelligence**—It is requested Item 6440-001-0001 be increased by \$5 million one-time General Fund to

support research, education, and entrepreneurship at the UC Berkeley Center for Responsible, Decentralized Intelligence.

It is further requested that Provision 28 of Item 6440-001-0001 be added as follows to conform to this action:

28. Of the funds appropriated in this item, \$5,000,000 shall be available on a one-time basis to support the Center for Responsible, Decentralized Intelligence at UC Berkeley.

**Support for Ralph J. Bunche Center**—It is requested that Item 6440-001-0001 be increased by \$5 million one-time General Fund to support research and educational opportunities at the Ralph J. Bunche Center for African-American Studies at UCLA.

It is further requested that Provision 29 of Item 6440-001-0001 be added as follows to conform to this action:

29. Of the funds appropriated in this item, \$5,000,000 shall be available on a one-time basis to support the support of the University of California, Los Angeles Ralph J. Bunche Center for African American Studies.

**Support for ASSIST Platform Integration**—It is requested that Item 6440-001-0001 be increased by \$1.5 million on a one-time basis and \$650,000 on an ongoing basis starting in fiscal year 2023-24 to support the integration of private non-profit universities within the ASSIST platform. The ASSIST platform helps community college students understand how their college credits may or may not transfer to prospective colleges and universities.

It is further requested that Provision 25 of Item 6440-001-0001 be added as follows to conform to this action:

25. \$1,500,000 shall be available to support the integration of Association of Independent California Colleges and Universities members onto the ASSIST platform.

**Proposition 56 Backfill for Graduate Medical Education**—It is requested that Item 6440-001-0001 be increased by \$2,135,000 for the Graduate Medical Education grant program to maintain a total of \$40 million for the program based on the most recent Proposition 56 revenue estimates.

It is further requested that provisional language for Item 6440-001-0001 be amended as follows to conform to this action:

“10. Of the funds appropriated in this item, ~~\$3,774,000~~ \$5,909,000 shall be allocated for a statewide grant program expanding the number of primary care and emergency medicine residency slots.”

**Coordination of Climate Research Efforts**—It is requested that subdivision (a) of Provision 21 of Item 6440-001-0001 be amended as follows to provide additional guidance to UC regarding identification of areas of research supported by climate action research seed and matching grants:

“(a) \$100,000,000 shall support climate action research seed and matching grants. These grants shall be made on a competitive basis, support applied research, be made available to individuals and teams without regard for their affiliation or non-affiliation with the University of California, and be awarded as matching grants to leverage additional funding sources. It is the intent of the Legislature that the University of California coordinate with state agencies and departments in the identification of areas of research to be supported by these grants to promote alignment with the state’s climate research needs.”

**Clarification of UC’s Role in Climate Resiliency Efforts**—It is requested that subdivision (d) be added to Provision 21 of Item 6440-001-0001 to clarify the nature of UC’s involvement in these programs is not in conflict with its nonprofit status.

It is further requested that Provision 21 of Item 6440-001-0001 be amended to conform to this action:

“21. Of the funds appropriated in this item, \$185,000,000 shall be available on a one-time basis to support University of California climate initiatives intended to further progress towards the State of California’s climate goals, allocated as follows:”

It is further requested that subdivision (d) be added to Provision 21 of Item 6440-001-0001 to conform to this action:

(d) It is the intent of the Legislature that with the appropriation in this provision, the University of California further ongoing efforts to address climate change in California through climate initiatives, including climate action research seed and matching grants, support of climate innovation and entrepreneurship, and the development of a climate-focused workforce. It is the intent of the Legislature in providing these funds to the University of California that the University of California act on its behalf to lessen the burdens of government to further the state’s climate goals.

It is further requested that paragraphs (3) and (4) of subdivision (a) of Provision 6 of this item be amended as follows to conform to this action:

“(3) (A) \$5,300,000 shall be allocated to a community college district to conduct a statewide outreach, marketing, and paid media campaign to promote the following messages: (i) ~~the California Community Colleges are affordable,~~ many types of financial aid is are available year-round to cover fees and help with college costs, such as books, housing, and other educational costs, and (ii) ~~an interested~~ (ii) students can should contact the student's their local community college financial aid office to get one-on-one assistance with completing and submitting financial aid applications and forms, and (iii) a community college education can improve the life of students' and their families by providing financial aid, as well as career training and guaranteed transfer opportunities to get into a rewarding, good-paying career. (B) Of the amount identified in subparagraph (A), \$2,500,000 shall be allocated to ~~expand~~: (i) expand outreach for students from non-English speaking households and bilingual households, (ii) tie financial aid messaging to enrollment messaging where applicable to encourage current and potential students to enroll or continue their education at a California community college and apply for financial aid, ~~(iii) marketing and outreach aimed at baccalaureate degree pilot programs~~, and (iii) marketing and outreach aimed at increasing current and potential future student awareness of the California College Promise Grant and other types of financial aid available for California community college students. Bilingual efforts shall target areas of the state that meet at least one of the following conditions: (i) have concentrations of non-English speaking and bilingual households, or (ii) have underserved populations, a history of declining community college attendance, or both."

**Item 6870-101-0001, Disabled Student Programs and Services Program COLA**

**(Issue 117)**—It is requested that Schedule (6) of Item 6870-101-0001 be increased by \$1,555,000 Proposition 98 General Fund to reflect a 6.56-percent COLA for the Disabled Student Programs and Services Program.

**Item 6870-101-0001, Student Services for CalWORKs Recipients Program COLA**

**(Issue 109)**—It is requested that Schedule (7) of Item 6870-101-0001 be increased by \$588,000 Proposition 98 General Fund to reflect a 6.56-percent COLA for the Student Services for CalWORKs Recipients Program.

It is further requested that paragraphs (1) and (2) of subdivision (b) of Provision 8 of this item be amended as follows to conform to this action:

"(1) ~~\$10,163,000~~ \$10,282,000 shall be for childcare, except that a community college district may request that the chancellor approve the use of funds for other purposes.

(2) No less than ~~\$5,420,000~~ \$5,483,000 shall be used to provide direct workstudy wage reimbursement for students served under this program, and ~~\$679,000~~ \$687,000 is available for campus job development and placement services."

**Item 6870-101-0001, Foster Care Education Program Funding (Issue 78)**—It is requested that Schedule (8) of Item 6870-101-0001 be increased by \$500,000 Proposition 98 General Fund to sustain program funding for foster and relative or kinship care education at current funding levels, due to a projected decrease in federal matching funds.

**Item 6870-101-0001, Extended Opportunity Programs and Services Program COLA**

**(Issue 98)**—It is requested that Schedule (18) of Item 6870-101-0001 be increased by \$1,906,000 Proposition 98 General Fund to reflect a 6.56-percent COLA for the Extended Opportunity Programs and Services Program.

It is further requested that paragraphs (1) and (2) of subdivision (a) of Provision 18 of this item be amended as follows to conform to this action:

"(1) ~~\$142,513,000~~ \$144,177,000 shall be used pursuant to Article 8 (commencing with Section 69640) of Chapter 2 of Part 42 of Division 5 of Title 3 of the Education Code. Funds provided in this item for Extended Opportunity Programs and Services shall be available to students on all campuses within the California Community Colleges system.

(2) ~~\$20,693,000~~ \$20,935,000 shall be used for funding, at all colleges, the Cooperative Agencies Resources for Education program in accordance with Article 4 (commencing with Section 79150) of Chapter 9 of Part 48 of Division 7 of Title 3 of the Education Code. The chancellor shall allocate these funds to local programs on the basis of need for student services."

**Item 6870-101-0001, NextUp Program Expansion (Issue 111)**—It is requested that Schedule (19) of Item 6870-101-0001 be increased by \$10 million Proposition 98 General Fund to expand the NextUp program at community colleges. It is also requested that provisional language be amended to remove the cap on the number of districts that may receive an allocation and to allow funds be allocated to colleges instead of districts.

It is further requested that subdivision (e) of Provision 19 of this item be amended as follows to conform to these actions:

"(e) Consistent with the intent of Article 7 (commencing with Section 79220) of Chapter 9 of Part 48 of Division 7 of Title 3 of the Education Code, the chancellor shall enter into agreements with ~~30~~ community college districts to provide additional services in support of postsecondary education for foster youth. Up to ~~\$30,000,000~~ \$40,000,000 of the funds appropriated in this item shall be prioritized for services pursuant to Article 7 (commencing with Section 79220) of Chapter 9 of Part 48 of Division 7 of Title 3 of the Education Code. Further, the chancellor shall ensure that the list of eligible expenditures developed pursuant to subdivision (d) of Section 78221 of the Education Code includes expenditures that are consistent with the intent of Article 7 (commencing with Section 79220) of Chapter 9 of Part 48 of Division 7 of Title 3 of the Education Code."

**Item 6870-101-0001, Campus Childcare Tax Bailout Program COLA (Issue 96)**—It is requested that Schedule (20) of Item 6870-101-0001 be increased by \$45,000 Proposition 98 General Fund to reflect a 6.56-percent COLA for the Campus Childcare Tax Bailout Program.

**Item 6870-101-0001, CCC Systemwide Technology and Data Security Reporting**—It is requested that Item 6870-101-0001 be amended to include reporting requirements for community college districts as a condition of accepting funding for CCC systemwide technology and data security improvements.

It is further requested that subdivision (f) of Provision 23 of this item be amended as follows to conform to this action:

"(f) (1) \$25,000,000 shall be provided for community college districts to implement local and systemwide technology and data security measures that support improved

oversight of fraud mitigation, online learning quality, and cybersecurity efforts. Funds shall be used by community college districts to hire local cybersecurity staff, and funds shall also be used for systemwide measures, including, but not limited to, security upgrades for CCCApply and education technology platforms and the establishment of systemwide cybersecurity teams.

(2) As a condition of receiving funds pursuant to this subdivision, a community college district shall do all of the following:

(A) Complete an annual cybersecurity self-assessment of their information technology infrastructure to determine their National Institute of Standards and Technology (NIST) Computer Systems Laboratory (CSL) score and report their current phase in Cal-Secure standards.

(B) Participate in regularly scheduled cybersecurity reporting, including, but not limited to:

(i) Submit remediation updates twice per year, for the fall and spring semester terms, on vulnerability and other issues identified in the previous self-assessment or triennial assessment.

(ii) Submit detailed after-action reports of all cybersecurity incidents that either lead to a breach of personally identifiable information or lead to the disruption of services, including, but not limited to, a breach of student identification numbers, distributed denial-of-service attacks, and ransomware.

(iii) The total number of admission applications received from CCCApply that are determined to be fraudulent, including applications marked as "likely fraud" within CCCApply.

(iv) Information requested on suspected fraudulent enrollments, and fraudulent receipt of financial aid."

**Item 6870-101-0001, Classified Employee Summer Assistance Program (Issue 114)**—It is requested that Schedule (24) of Item 6870-101-0001 be added in the amount of \$10 million Proposition 98 General Fund to establish the Classified Employee Summer Assistance Program for community college classified employees.

It is further requested that Provision 24 be added to this item as follows to conform to this action:

24. The funds appropriated in Schedule (24) shall be allocated to support the Classified Employee Summer Assistance Program as specified in Section 88280 of the Education Code.

**Item 6870-108-0001, Student Success Completion Grant Adjustment (Issue 95)**—It is requested that Item 6870-108-0001 be decreased by \$50 million Proposition 98 General Fund to reflect a revised estimate of eligible Cal Grant B and Cal Grant C students for 2022-23, including a revised estimate of newly eligible students receiving a Cal Grant B or C award as a result of CCC Cal Grant entitlement expansion in Budget Act of 2021.

**Item 6870-201-0001, Adult Education Program COLA (Issue 91)**—It is requested that this item be increased by \$6,893,000 Proposition 98 General Fund to reflect a 6.56-percent COLA for the Adult Education Program.

It is further requested that Provision 2 of this item be amended as follows to conform to this action:

"2. Of the funds appropriated in this item, ~~\$29,868,000~~ \$36,761,000 is provided as a cost-of-living adjustment."

**Item 6870-121-0001, Retention and Enrollment Strategies Technical Correction**—It is requested that Item 6870-121-0001 be amended to provide a corrected fiscal year for a transfer to the State School Fund by the Controller.

It is further requested that Provision 1 of this item be amended as follows to conform to this action:

"1. The funds appropriated in this item are for transfer by the Controller during the ~~2021–22~~ 2023–23 fiscal year to Section B of the State School Fund."

**Item 6870-295-0001, Mandate Reimbursement**—It is requested that Item 6870-295-0001 be amended to provide technical changes to clarify Schedule (1) provisional language.

It is further requested that this item be amended as follows to conform to this action:

"6870-295-0001—For local assistance, Board of Governors of the California Community Colleges (Proposition 98), for reimbursement, in accordance with provisions of Section 6 of Article XIII B of the California Constitution or Section 17561 of the Government Code, of the costs of any new program or increased level of service of an existing program mandated by statute or executive order, for annual mandate claims collected as prescribed by Sections 17560 and 17568 of the Government Code for disbursement by the Controller, ~~for claims for costs incurred during the prior fiscal years~~ ..... 13,000

Schedule:

(1) 5685010-Mandates: For payment of the following annual mandate claims collected as prescribed by sections 17560 and 17568 of the Government Code for disbursement by the Controller ~~for costs incurred during the prior fiscal years~~ ..... 13,000"

**Item 6870-296-0001, Mandate Block Grant Adjustment and COLA (Issues 93 and 106)**—It is requested that Item 6870-296-0001 be increased by a total of \$312,000 Proposition 98 General Fund to reflect a decrease of \$105,000 to align block grant funding with the revised estimate of applicable full-time equivalent students and an increase of \$417,000 for a 6.56-percent COLA for the Mandate Block Grant program.

It is further requested that Provision 1 of this item be amended as follows to conform to this action:

"1. The funds appropriated in this item are for transfer by the Controller to Section B of the State School Fund. Pursuant to Section 17581.7 of the Government Code, the funds appropriated in this item shall be distributed to community college districts that elect to participate in the block grant on the basis of funded full-time equivalent students (FTES)

calculated as of the second principal apportionment for the 2021–22 fiscal year multiplied by ~~\$32.31~~ \$32.68 per FTES."

**Item 6870-403, Mandates Suspensions Technical Correction**—It is requested that Item 6870-403 be amended to provide a corrected fiscal year for mandates that are specifically identified by the Legislature for suspension (see Attachment 3).

**Item 6870-488, Local Assistance, Reappropriation (Issue 118)**—It is requested that Item 6870-488 be added (see Attachment 1) to provide \$23,287,000 one-time Proposition 98 General Fund to backfill a revenue shortfall for apportionments in fiscal year 2019-20.

### Current and Prior Year

**Item 6870-101-0001, 2021-22 Apportionment Adjustments to Reflect Revised Local Revenue Estimate**—It is requested that statutory changes transmitted with the Governor's Budget be amended to increase Schedule (1) of Item 6870-101-0001, Budget Act of 2021, by \$81,039,000 Proposition 98 General Fund to reflect an associated decrease in revised offsetting local revenue estimates. It is also requested that corresponding adjustments be made to a related informational non-Budget Act item.

**Item 6870-101-0001, 2021-22 Apportionment Adjustments to Reflect Revised Estimate of Offsetting Student Fees**—It is requested that statutory changes transmitted with the Governor's Budget be amended to increase Schedule (1) of Item 6870-101-0001, Budget Act of 2021 by \$41,016,000 Proposition 98 General Fund to reflect revised estimates of offsetting student fees. It is also requested that corresponding adjustments be made to a related informational non-Budget Act item.

**Item 6870-101-0001, 2021-22 Net Offsetting EPA Revenue**—It is requested that statutory changes transmitted with the Governor's Budget be amended to decrease Schedule (1) of Item 6870-101-0001, Budget Act of 2021 by \$403,775,000 Proposition 98 General Fund to reflect an associated increase in net offsetting EPA revenue. It is also requested that corresponding adjustments be made to related non-Budget Act items.

**Deferred Maintenance**—It is requested that statutory changes transmitted with the Governor's Budget be amended to increase a 2022–23 appropriation by \$754,256,000 one-time Proposition 98 General Fund, increase a 2021–22 appropriation by \$381,445,000 one-time Proposition 98 General Fund, and decrease a 2020–21 appropriation one-time Proposition 98 General Fund by \$313,000. These appropriations are intended to address deferred maintenance needs at the community colleges.

**Discretionary Institutional Block Grants**—It is requested that statutory changes be adopted that appropriates \$750 million one-time Proposition 98 General Fund, attributable to the 2021–22 fiscal year, to community college districts for discretionary use that would reduce outstanding mandate cost balances for community college districts. Funds may be used for a variety of one-time costs, including, but not limited to the following: expenditures to support and retain faculty, administrators, and classified employees; paying down pension obligations; accommodating student learning

modality demand; and supporting the mental health and wellness needs of students and staff.

### **Statutory Changes**

**Expansion of the NextUp Program**—It is requested that statutory changes transmitted with the Governor's Budget be amended to reflect various modifications to the NextUp Program, including eliminating of the statutory cap and indicating that funds be provided to specified colleges within a community college district.

**Extend Sunset Date for the CollegeBuys Program**—It is requested that statutory changes be adopted to remove the sunset date for the CollegeBuys Program, allowing the continued procurement of goods and services in bulk for the community college system, which is expected to create cost savings for districts.

**Technical Correction**—It is requested that statutory changes be adopted to address a drafting error reflected in Item 6870-101-0001 Budget Act of 2020, as that Item was amended pursuant to Section 77 of Chapter 77 of the Statutes of 2021 (AB 132). The language inadvertently reflected a total appropriation of \$2,230,465,000 when it should have reflected a total appropriation of \$2,320,465,000 (see Attachment 2).

### **Informational**

Pursuant to Education Code section 84758, the Department of Finance is required to notify the Legislature and the Chancellor's Office of the amount of revenue estimated to be available to community college districts during the next fiscal year from local taxes, exclusive of bond interest and redemption, and timber taxes received.

Finance estimates that property taxes totaling \$3,652,733,000 net of excess taxes will be available to offset district apportionments in 2022-23. This estimate excludes \$562,000 in estimated timber tax revenues.

Education Code section 84758 also requires Finance to notify the Legislature of the difference between the Chancellor's Office 2021-22 local property tax estimate, excluding timber taxes, and Finance's 2021-22 property tax estimates as of May 2021, excluding timber taxes.

As of the second principal apportionment payment, the Chancellor's Office reported 2021-22 local property taxes of \$3,448,149,000, net of excess taxes and excluding timber taxes, which was \$598,000. As of May 2021, Finance's 2021-22 property tax estimate was \$3,534,675,000 net of excess taxes and excluding timber taxes, which was \$690,000. Therefore, the Chancellor's Office's current property tax estimate, based on second principal apportionment payments, for 2021-22 is \$86,526,000 above Finance's May 2021 estimate.

This reimbursement only applies to students who completely withdraw from college before the census date pursuant to Section 58508 of Title 5 of the California Code of Regulations.
  - (d) Of the funds appropriated in Schedule (1), \$81,372,000 shall be allocated to support the California College Promise pursuant to Article 3 (commencing with Section 76396) of Chapter 2 of Part 47 of Division 2 of Title 3 of the Education Code.
  - (e) Of the funds appropriated in Schedule (1), \$50,000,000 shall be used to hire new full-time faculty for community college districts to increase their percentage of full-time faculty, toward meeting the 75 percent full-time faculty target. The Chancellor's Office of the California Community Colleges shall consult with representatives from the Department of Finance, the Legislature, and the Legislative Analyst's Office before distributing these funds to community college districts.
3. (a) The funds appropriated in Schedule (2) shall be available pursuant to Article 3 (commencing with Section 79140) of Chapter 9 of Part 48 of Division 7 of Title 3 of the Education Code.
- (b) Pursuant to Section 79149.3 of the Education Code, the reimbursement rate shall be \$6.44 per hour.
  - (c) Of the funds appropriated in Schedule (2), \$15,000,000 shall be used for the California

Apprenticeship Initiative pursuant to Section 79148.1 of the Education Code. Funds appropriated pursuant to this subdivision shall be available for encumbrance or expenditure until June 30, 2026.

4. (a) The funds appropriated in Schedule (3) shall be available pursuant to Article 8 (commencing with Section 8150) of Chapter 1 of Part 6 of Division 1 of Title 1 of the Education Code.
- (b) Pursuant to Section 8152 of the Education Code, the reimbursement rate shall be \$6.44 per hour.
5. The funds appropriated in Schedule (4) shall be apportioned to community college districts pursuant to Section 78222 of the Education Code.
6. (a) Of the funds appropriated in Schedule (5):
  - (1) Not less than \$14,977,000 is available to provide \$0.91 per unit reimbursement to community college districts for the provision of California College Promise Grants pursuant to paragraph (2) of subdivision (m) of Section 76300 of the Education Code.
  - (2) Not less than \$15,141,000 is available for the Board Financial Assistance Program to provide reimbursement of 2 percent of total waiver value to community college districts for the provision of California College Promise Grants pursuant to paragraph (2) of subdivision (m) of Section 76300 of the Education Code.
  - (3) Not more than \$35,200,000 shall be for direct contact with potential and current financial aid applicants. Each California Community College campus shall receive a minimum allocation of \$50,000. The remainder of the funding shall be allocated to campuses based upon a formula reflecting FTES weighted by a measure of low-income populations demonstrated by the California

College Promise Grant program participation within a district.

- (4) Funds allocated to a community college district pursuant to paragraphs (1) and (2) shall supplement, not supplant, the level of funds allocated for the administration of student financial aid programs during the 2001–02 or 2006–07 fiscal year, whichever is greater.
- (5) Funding allocated to a community college district pursuant to paragraphs (1) and (2) shall directly offset any costs claimed by that district for any of the following mandates: Enrollment Fee Collection (99-TC-13), Enrollment Fee Waivers (00-TC-15), Cal Grants (02-TC-28), and Tuition Fee Waivers (02-TC-21).
- (6) Notwithstanding subdivision (m) of Section 76300 of the Education Code or any other provision of law, the amount of funds appropriated for the purpose of administering fee waivers for the 2020–21 fiscal year shall be determined in this act.
- (7) Not more than \$5,000,000 shall be for ongoing maintenance, subscription, and training costs for financial aid technology advancements and innovations that streamline the financial aid verification process and enable colleges to more efficiently process state and federal financial aid grants. It is the intent of the Legislature that system improvements supported by this funding have the effect of reducing the manual processing of financial aid applications, thereby enabling financial aid program staff to provide additional technical assistance and guidance to students seeking financial aid. The Chancellor's Office shall determine the methodology for allocating these funds to community college districts.

- (8) (A) \$5,300,000 shall be allocated to a community college district to conduct a statewide media campaign to promote the following message: (i) the California Community Colleges are affordable, (ii) financial aid is available to cover fees and help with books and other costs, and (iii) an interested student should contact the student's local community college financial aid office. The campaign should target efforts to reach low-income and disadvantaged students who must overcome barriers in accessing postsecondary education. The community college district awarded the contract shall consult regularly with the Chancellor of the California Community Colleges and the Student Aid Commission.
- (B) Of the amount identified in subparagraph (A), \$2,500,000 shall be allocated to expand: (i) outreach for students from non-English speaking households and bilingual households, (ii) marketing and outreach aimed at baccalaureate degree pilot programs, and (iii) marketing and outreach aimed at increasing current and future student awareness of the California College Promise Grant. Bilingual efforts shall target areas of the state that meet at least one of the following conditions: (i) have concentrations of non-English speaking and bilingual households, or (ii) have underserved populations, a history of declining community college attendance, or both.

7.
  - (a) The funds appropriated in Schedule (6) shall be used to assist districts in funding the excess direct instructional cost of providing special support services or instruction, or both, to disabled students enrolled at community colleges and for state hospital programs, as mandated by federal law.
  - (b) Of the amount appropriated in Schedule (6):
    - (1) At least \$3,945,000 shall be used to address deficiencies identified by the United States Department of Education Office for Civil Rights.
    - (2) At least \$943,000 shall be used to support the High Tech Centers for activities including, but not limited to, training of district employees, staff, and students in the use of specialized computer equipment for the disabled.
    - (3) At least \$9,600,000 shall be allocated to community college districts for sign language interpreter services, real-time captioning equipment, or other communication accommodations for hearing-impaired students. A community college district is required to spend \$1 from local or other resources for every \$4 received pursuant to this paragraph.
    - (4) \$642,000 shall be allocated for state hospital adult education programs at the hospitals served by the Coast and Kern Community College Districts.
8.
  - (a) The funds appropriated in Schedule (7) shall be allocated pursuant to Article 5 (commencing with Section 79200) of Chapter 9 of Part 48 of Division 7 of Title 3 of the Education Code.
  - (b) Of the amount appropriated in Schedule (7):
    - (1) \$9,488,000 is for childcare, except that a community college district may request that the chancellor approve the use of funds for other purposes.

- (2) No less than \$5,060,000 shall be used to provide direct workstudy wage reimbursement for students served under this program, and \$633,000 is available for campus job development and placement services.
9. The funds appropriated in Schedule (8) shall be allocated to community college districts to provide foster and relative or kinship care education and training pursuant to Article 8 (commencing with Section 79420) of Chapter 9 of Part 48 of Division 7 of Title 3 of the Education Code. A community college district shall ensure that education and training required pursuant to paragraphs (12) and (13) of subdivision (g) of Section 16519.5 of the Welfare and Institutions Code receive priority.
10. The funds appropriated in Schedule (9) shall be allocated to a community college district to contract with the State Department of Social Services in order to contract with organizations qualified pursuant to Chapter 5.6 (commencing with Section 13300) of Part 3 of Division 9 of the Welfare and Institutions Code to provide services pursuant to that chapter to persons on California community college campuses. Use of these funds shall be included in updates provided to the Legislature on the State Department of Social Services' immigration programs.
11. Of the amount appropriated in Schedule (10), \$685,000 is available to support the Academic Senate of the California Community Colleges course identification numbering system efforts and shall be subject to the requirements of subparagraph (B) of paragraph (5) of subdivision (b) of Section 70901 of the Education Code.
12. The funds in Schedule (13) shall be allocated to increase compensation for part-time faculty. Funds shall be allocated to districts based on the total actual number of FTES in the previous fiscal year, with an adjustment to the allocations provided to small districts. These funds shall be used to assist districts in making part-time faculty salaries more comparable to full-time salaries for similar work, as determined through collective bargaining in each community college district. If a community college district achieves parity between compensation for

full-time faculty and part-time faculty, funds received pursuant to this provision may be used for any other educational purpose.

13. (a) Of the funds appropriated in Schedule (14), \$90,000,000 shall be available on a one-time basis to support part-time faculty office hours.  
(b) The funds provided pursuant to subdivision (a) shall be available for encumbrance or expenditure until June 30, 2024.
14. Of the funds appropriated in Schedule (15):
  - (a) By September 1 of each fiscal year, up to \$3,000,000 shall be disbursed by the Office of the Chancellor of the California Community Colleges to one or more community college districts to provide textbooks or digital course content to inmates under the jurisdiction of the Department of Corrections and Rehabilitation who are enrolled in one or more California Community College courses. The provision of this material is expected to enable community college districts to provide instruction to incarcerated adults.
    - (1) To the extent possible, community college districts providing textbooks or digital course content pursuant to this subdivision are encouraged to first use open educational resources.
    - (2) Notwithstanding any other law, a contract between the Office of the Chancellor of the California Community Colleges and a community college district for purposes of this subdivision is not subject to any competitive bidding requirements of Section 10340 of the Public Contract Code.
  - (c) \$20,000,000 shall be allocated to the Chancellor of the California Community Colleges to increase the number of courses available through the use of technology, provide alternative methods for students to earn college credit, and support the California Virtual Campus Distance Education Program. These funds may be used to pay for a consistent learning

management system to help implement this program. The chancellor shall ensure, to the extent possible, that the following conditions are satisfied:

- (1) These courses can be articulated across all community college districts.
- (2) These courses are made available to students systemwide, regardless of the campus at which a student is enrolled.
- (3) Students who complete these courses are granted degree-applicable credit across community colleges.
- (4) These funds shall be used for those courses that have the highest demand, fill quickly, and are prerequisites for many different degrees.

15. Of the funds appropriated in Schedule (16):

- (a) \$22,929,000 is available for the following purposes:
  - (1) Funds shall be allocated for programs that target investments in priority and emergent sectors, including statewide and/or regional centers, hubs, collaborative communities, advisory bodies, and short-term grants. Short-term grants may include industry-driven regional education and training, Responsive Incumbent Worker Training, and Job Development Incentive Training. Funds allocated pursuant to this provision may be used to provide substantially similar services in support of the Strong Workforce Program.
  - (2) Funds applied to performance-based training shall be matched by a minimum of \$1 contributed by private businesses or industry for each \$1 of state funds. The chancellor shall consider the level of involvement and financial commitments of business and

- industry in making awards for performance-based training.
- (3) Up to 10 percent may be allocated for state-level technical assistance, including statewide network leadership, organizational development, coordination, and information and support services.
  - (b) \$248,000,000 shall be available to support the Strong Workforce Program pursuant to Part 54.5 (commencing with Section 88820) of Division 7 of Title 3 of the Education Code.
16. (a) \$81,000 of the funds appropriated in Schedule (17) shall be used to support the Historically Black Colleges and Universities (HBCU) Transfer Pathway program, which helps develop transfer guarantee agreements that help facilitate a smooth transition for students from the California Community Colleges to partnered HBCU institutions.
- (b) (1) \$698,000 of the funds appropriated in Schedule (17) shall be used to support transfer and articulation projects and common course numbering projects.
  - (2) Funding provided to community college districts shall directly offset any costs claimed by community college districts to be mandates pursuant to Chapter 737 of the Statutes of 2004.
17. (a) Of the funds appropriated in Schedule (18):
- (1) \$115,867,000 shall be used pursuant to Article 8 (commencing with Section 69640) of Chapter 2 of Part 42 of Division 5 of Title 3 of the Education Code. Funds provided in this item for Extended Opportunity Programs and Services shall be available to students on all campuses within the California Community Colleges system.
  - (2) \$16,824,000 shall be used for funding, at all colleges, the Cooperative Agencies Resources for Education

program in accordance with Article 4 (commencing with Section 79150) of Chapter 9 of Part 48 of Division 7 of Title 3 of the Education Code. The chancellor shall allocate these funds to local programs on the basis of need for student services.

- (b) Of the amount allocated pursuant to subdivision (a), no less than \$4,972,000 shall be available to support additional textbook assistance grants to community college students.
18. The funds appropriated in Schedule (19) shall be used for the following purposes:
- (a) \$1,984,000 shall be used for the Puente Project to support up to 75 colleges. These funds are available if matched by \$200,000 of private funds and if the participating community colleges and University of California campuses maintain their 1995–96 fiscal year support level for the Puente Project. All funding shall be allocated directly to participating districts in accordance with their participation agreement.
  - (b) Up to \$2,539,000 is for the Mathematics, Engineering, Science Achievement (MESA) program. A community college district is required to spend \$1 from local or other resources for every \$1 received pursuant to this subdivision.
  - (c) No less than \$1,836,000 is for the Middle College High School Program. With the exception of special part-time students at the community colleges pursuant to Sections 48802 and 76001 of the Education Code, student workload based on participation in the Middle College High School Program shall not be eligible for community college state apportionment.
  - (d) No less than \$2,581,000 is for the Umoja program.
  - (e) Consistent with the intent of Chapter 771 of the Statutes of 2014 and Chapter 772 of the Statutes of 2017, the chancellor shall enter

into agreements with 20 community college districts to provide additional services in support of postsecondary education for foster youth. Up to \$20,000,000 of the funds appropriated in this item shall be prioritized for services pursuant to Chapter 771 of the Statutes of 2014 and Chapter 772 of the Statutes of 2017. Further, the chancellor shall ensure that the list of eligible expenditures developed pursuant to subdivision (d) of Section 78221 of the Education Code includes expenditures that are consistent with the intent of Chapter 771 of the Statutes of 2014 and Chapter 772 of the Statutes of 2017.

- (f) \$10,000,000 of the funds shall be for support of Veteran Resource Centers. To the extent funding is provided in the annual Budget Act, the chancellor shall only allocate funding to community colleges that commit to either meeting or making progress towards meeting the minimum standards developed by the Office of the Chancellor of the California Community Colleges.
- (g) (1) Colleges shall establish ongoing partnerships with community organizations that have a tradition of helping populations experiencing homelessness to provide wraparound services and rental subsidies for homeless and housing insecure students. \$9,000,000 of the funds appropriated in Schedule (19) may be used for, but are not limited to, the following authorized activities:
  - (A) Connecting students with community case managers who have knowledge and expertise in accessing safety net resources.
  - (B) Establishing ongoing emergency housing procedures, including on-campus and off-campus resources.
  - (C) Providing emergency grants that are necessary to secure

housing or to prevent the  
imminent loss of housing.

- (2) Funding shall be allocated to campuses based on demonstrated need.
- (3) "Homeless" and "housing insecure" mean students who lack a fixed, regular, and adequate nighttime residence. This includes students who are:
  - (A) Sharing the housing of other persons due to loss of housing, economic hardship, or a similar reason.
  - (B) Living in motels, hotels, trailer parks, or camping grounds due to the lack of alternative adequate accommodations.
  - (C) Living in emergency or transitional shelters.
  - (D) Abandoned in hospitals.
  - (E) Living in a primary nighttime residence that is a public or private place not designed for or ordinarily used as a regular sleeping accommodation for human beings.
  - (F) Living in cars, parks, public spaces, abandoned buildings, substandard housing, bus or train stations, or similar settings.
- (4) By July 15 of each year, the Office of the Chancellor of the California Community Colleges shall submit a report to the Director of Finance and, in conformity with Section 9795 of the Government Code, to the Legislature regarding the prior year use of these funds, including the number of coordinators hired, the number of students served by campus, the distribution of funds by campus, a

description of the types of programs funded, and other relevant outcomes, such as the number of students who were able to secure permanent housing, and whether students receiving support remained enrolled at the institution or graduated.

- (i) \$5,800,000 shall be allocated by the Chancellor's Office to community colleges to support Dreamer Resource Liaisons and student support services, including those related to career pathways and economic mobility, for immigrant students, pursuant to Section 66021.8 of the Education Code.
19. The funds appropriated in Schedule (20) shall be allocated by the chancellor to community college districts that levied childcare permissive override taxes in the 1977–78 fiscal year pursuant to Sections 8329 and 8330 of the Education Code in an amount proportional to the property tax revenues, tax relief subventions, and state aid required to be made available by the district to its childcare and development program for the 1979–80 fiscal year pursuant to Section 30 of Chapter 1035 of the Statutes of 1979, increased or decreased by any cost-of-living adjustment granted in subsequent fiscal years. These funds shall be used only for the purpose of community college childcare and development programs.
  20. Of the funds appropriated in Schedule (21):
    - (a) \$8,475,000 shall be used to provide support for nursing programs.
    - (b) \$4,903,000 shall be used for diagnostic and support services, preentry coursework, alternative program delivery model development, and other services to reduce the incidence of student attrition in nursing programs.
  21. The Office of the Chancellor of the California Community Colleges shall annually report by December 1 of each year through 2021, on the racial or ethnic and gender composition of faculty, and efforts to assist campuses in providing equal employment opportunity in faculty recruitment

and hiring practices as well as systemwide training, monitoring, and compliance activities.

24. (a) Of the amount appropriated in Schedule (24):
  - (1) (A) \$7,500,000 may be used by the Chancellor of the California Community Colleges to provide technical assistance to community college districts that demonstrate low performance in any area of operations. It is the intent of the Legislature that technical assistance providers be contracted in a cost-effective manner, that they primarily consist of experts who are current and former employees of the California Community Colleges, and that they provide technical assistance consistent with the vision for the California Community Colleges.
  - (B) Technical assistance funded pursuant to this paragraph that is initiated by the chancellor may be provided at no cost to the community college district. If a community college district requests technical assistance, the district is required to spend at least \$1 from local or other resources for every \$2 received, as determined by the chancellor.
  - (2) (A) \$20,000,000 may be used by the chancellor to provide regional and online workshops and trainings to community college personnel to promote statewide priorities, including, but not limited to, strategies to improve student achievement; strategies to improve community college operations; and system leadership training to better coordinate planning and

implementation of statewide initiatives in alignment with the Board of Governors of the California Community Colleges' Vision for Success. To the extent possible, the chancellor shall partner with existing statewide initiatives with proven results of improving student success and institutional effectiveness. Each fiscal year, the chancellor shall submit a report on the use of funds appropriated pursuant to this provision in the prior year to the Department of Finance and the Joint Legislative Budget Committee no later than December 31 of each year. This report shall include information regarding California Community Colleges' participation in the activities funded pursuant to this provision.

- (B) Funding available pursuant to this paragraph may be used by the chancellor to coordinate with community college districts to conduct policy research, and develop and disseminate effective practices through the establishment of an online clearinghouse of information. The development of effective practices shall include, but not be limited to, statewide priorities such as the development of educational programs or courses for the incarcerated adults in prisons and jails, and the formerly incarcerated, educational programs or courses for California Conservation Corps members, and other effective practices. The online clearinghouse of information shall also reflect effective practices, guidance, policies, curriculum, courses, and programs developed by local community colleges in

support of the Strong Workforce Program established pursuant to Part 54.5 (commencing with Section 88820) of Division 7 of Title 3 of the Education Code.

- (C) It is the intent of the Legislature to encourage the chancellor to facilitate the development of local community college courses for the California Conservation Corps and the incarcerated adults in prisons and jails, and the formerly incarcerated. The Department of Corrections and Rehabilitation and the California Conservation Corps are encouraged to partner with the chancellor's office in the development and dissemination of local community college courses and effective practices pursuant to this subparagraph and subparagraph (B).

- 25. (a) The funds appropriated in Schedule (25) shall be allocated by the Chancellor of the California Community Colleges for the following purposes:
  - (1) Procurement, development, evaluation, and upgrading of high priority systemwide technology tools and infrastructure including, but not limited to, e-transcript, e-planning, and other tools to assist colleges to implement multiple measures of assessment pursuant to Chapter 745 of the Statutes of 2017, and technologies that facilitate portability of education credentials.
  - (2) Provision of access to statewide multimedia hosting and delivery services for colleges and districts.
  - (3) Provision of systemwide internet, audio bridging, data security, and telephony.

- (4) Services related to technology use, including accessibility guidance and information security.
  - (5) Technology product development and program management, technical assistance and planning, and cooperative purchase agreements.
  - (6) Ongoing faculty and staff development related to technology use and adoption.
  - (7) Ongoing support of the California Partnership for Achieving Student Success (Cal-PASS) program.
  - (8) Ongoing support for programs designed to use technology in assisting accreditation and the alignment of curricula across K–20 segments in California, as well as to support integration and interoperability toward an improved student experience.
  - (9) Support for technology pilots and ongoing technology programs and applications that serve to maximize the utility and economy of scale of the technology investments of the community college system toward improving learning outcomes.
  - (10) Up to 5 percent of the funds may be allocated by the chancellor to a community college district for statewide activities, not limited to statewide technical assistance to evaluate, plan, and continuously improve the system's data and technology roadmap and deployment.
- (b) Any funds not allocated pursuant to subdivision (a) shall be available for allocations to districts to maintain technology capabilities."

**Amendment to Budget Bill Item 6870-301-6087 and Addition of Items 6870-301-6041 and 6870-496, Capital Outlay, Board of Governors of the California Community Colleges**

**California Community Colleges New and Continuing Projects**—It is requested that Item 6870-301-6041 (see Attachment 1) be added in the amount of \$10,464,000 one-time Proposition 55 General Obligation Bonds (Prop 55), Item 6870-301-6087 (see Attachment 2) be increased by \$19,618,000 one-time Proposition 51 General Obligation Bonds (Prop 51), and Item 6870-496 (see Attachment 3) be added to revert funding for two projects. The details of the budget request are specified below:

**Add Construction Authority for Two Continuing Projects:** \$10,464,000 Prop 55 and \$3,909,000 Prop 51 is requested to provide construction authority for the following projects:

- North Orange Community College District, Anaheim Campus: Tower First Floor Life/Safety Renovation—\$10,464,000
- Ventura Community College District, Moorpark College: Administration Building Reconstruction—\$3,909,000

**North Orange County Community College District, Fullerton College: Business 300 Renovation:** \$14,056,000 Prop 51 is for working drawings and construction for the subject project and the reversion of \$14,056,000 Prop 51 through Item 6870-496 for the originally proposed North Orange Community College District, Fullerton College: Business 300 and Humanities 500 Building Renovation. The District indicated that bids for the Business 300 and Humanities 500 buildings came in significantly higher than anticipated. As a result, the local contribution was sufficient for only one building and Business 300 was considered the building with the greatest need for renovation.

**Siskiyou Joint Community College District, College of the Siskiyous: Remodel Theater and McCloud Hall:** The remaining \$1,653,000 increase in Prop 51 is for design of the subject project, and the reversion of \$1,653,000 Prop 51 through Item 6870-496 is for the related Siskiyou Joint Community College District, College of the Siskiyous: Theatre Arts Building Remodel/Addition. This request will address increased project costs, primarily associated with the "Addition" component of the original project, which called for the demolition of McCloud Hall, and an expansion of the Theatre Arts Building. By remodeling McCloud Hall instead, the district anticipates that the project will provide adequate space for the Arts program, at half the cost of the current estimate. Overall costs of the new project are \$28.5 million, which is consistent with the original estimate of \$27.2 million, as adjusted for inflation.

The effect of my requested action is reflected on the attachment.

**Amendment to Budget Bill Items 6980-001-0001 and 6980-101-0001, State Operations, Local Assistance, and Statutory Changes, California Student Aid Commission**

**Item 6980-001-0001, State Operations, Financial Aid Expansion Administrative Support, (Issue 040)**—It is requested that Item 6980-001-0001 be increased by \$410,000 ongoing General Fund and 3 positions to support the implementation of the financial aid programs and program revisions reflected in the 2021 Budget Act.

**Item 6980-101-0001, Local Assistance, Cal Grant Program (Issues 028 and 47)**—It is requested that Item 6980-101-0001 be decreased by \$328,933,000 to reflect revised Cal Grant program estimates and to assume additional program award growth associated with more students returning to college campuses in fiscal year 2022-23. Compared to the Governor's Budget, there are reduced costs for the program of \$208,864,000 in fiscal year 2021-22 related to an estimated revised in new recipients.

**Item 6980-101-0001, Local Assistance, Adjustment for Revised Chafee Costs (Issue 31)**—It is requested that schedule (1) of Item 6980-101-0001 be increased by \$31,000 and schedule (2) of Item 6980-101-0001 be decreased by \$31,000 to reflect revised estimates of available Chafee Program funding. Compared to the Governor's Budget, there are increased reimbursements of \$241,000 in 2021-22.

**Golden State Teacher Grant Program**—It is further requested that statutory changes be added to:

- Enable applications and initial eligibility determinations to be completed prior to a student enroll in a credential program.
- Extend the Commission's ability to adopt emergency regulations support the programs operations.
- Clarify that the Commission can assist students seeking a credential and committing to teaching in career technical education or bilingual education.
- Include the pupil personnel services credential within the list of qualifying credentials that would enable a student to apply to participate in the program.

**Dreamer Service Incentive Grant Program**—It is requested that statutory changes transmitted with the Governor's Budget be amended to allow Cal Grant A recipients who are eligible for a Cal Grant B but that receive a Cal Grant A award for financial reasons to participate in the program, and to clarify that any unspent programs funds may be transferred to support the University of California (UC) and California State University (CSU) Dream Loan programs only after the program's caseload funding has been obligated.

**Cohort Default Rates and Cal Grant Eligibility**—It is requested that statutory changes be added to require Cal Grant participating institutions to use the three-year cohort default rates certified in 2020 to determine an institution's eligibility to participate in the Cal Grant program for the 2023-24 academic year. The federal government's extended student loan pause has caused the underlying data needed to compute the three-year cohort default rates to be unavailable.

**Private Nonprofit Cal Grant Award**—The Administration proposes new statutory changes to revise the Associates Degree for Transfer admissions requirements for private nonprofit institutions to maintain the maximum Cal Grant tuition award at \$9,220. Commencing in 2022-23, the Associates Degree for Transfer admissions requirements would be based upon Associates Degree for Transfer admissions data from the prior year adjusted for changes in enrollment.

**Middle Class Scholarship Program**—It is requested that statutory changes transmitted with the Governor's Budget be amended to reflect changes consistent with revised estimates of costs of the Middle Class Scholarship Program.
