Amendment to Budget Bill Items 4100-001-0001, Item 4100-001-0890 and Reimbursements, and Addition of Item 4100-490, Support, State Council on Developmental Disabilities

Increased Federal Fund and Reimbursement Authority (Issue 013)—It is requested that Item 4100-001-0890 be increased by \$95,000 on a one-time basis to provide additional federal fund expenditure authority for the State Council on Developmental Disabilities (Council) to recruit, hire, and train public health workers to respond to the COVID-19 Pandemic and prepare for future public health challenges. This request allows the Council to satisfy the grant requirements provided by the federal Administration for Community Living awarded on March 1, 2022.

It is also requested that provisional language be added to Item 4100-001-0890 to make the grant funds available for encumbrance or expenditure through June 30, 2024 to provide flexibility for the Council to expend the funds by the end of the grant period (see Attachment 1).

Additionally, it is requested that Item 4100-001-0001 be amended by increasing reimbursements by \$365,000 on a one-time basis to enable the Council to expend a grant received by the California Community Foundation for the purchase and distribution of emergency go-kits, which contain a variety of items that are useful for people with intellectual or developmental disabilities when evacuating from their homes during a natural disaster.

**Reappropriation of Federal Grant Funds (Issue 015)**—It is requested that Item 4100-490 be added to reappropriate up to \$458,000 from Item 4100-001-0890, Budget Act of 2020, to allow the Council to fully expend the vaccine access grant provided by the federal Administration for Community Living and the Centers for Disease Control (see Attachment 2).

Amendment to Items 4140-101-0001 and 4140-101-0890, and Elimination of Items 4140-001-3397 and 4140-101-3391, Support and Local Assistance, and Statutory Changes, Department of Health Care Access and Information

Uncompensated Care Fund for Abortion Services (Issue 103)—It is requested that Item 4140-101-0001 be increased by \$40 million one-time to establish and administer an uncompensated care fund to support abortion services for individuals below 400 percent of the Federal Poverty Level. It is also requested that provisional language be added to Item 4140-101-0001 to support implementation of the program (see Attachment 1).

Small Rural Hospital Improvement Program Increase in Expenditure Authority (Issue 104)—It is requested that Item 4140-101-0890 be increased by \$71,000 ongoing for support of the Small Rural Hospital Improvement Program. The requested increase will allow the Department to award all available federal funds to small and rural hospitals, enabling these institutions to improve their quality of care and remain sustainable.

Health and Home Care Workforce (Issue 105)— It is requested that Item 4140-001-0001 be decreased by \$900,000 and Item 4140-101-0001 be decreased by \$17.1 million to shift funds to the Labor and Workforce Development Agency. It is requested that Items 4140-001-3397 and 4140-101-3397 be eliminated to shift funds to the Department of Health Care Services and the Department of Rehabilitation. It is also requested that provisional language be added to Item 4140-101-0001 to provide exemption from Public Contract Code requirements to support implementation of the proposal included in the Governor's Budget (see Attachment 1).

**Statutory Changes: Community Health Workers**—It is requested that statutory changes be adopted to define the role and eligibility requirements of Community Health Workers included in the Administration's Care Economy Workforce proposal. The statutory changes would also require statewide requirements for Community Health Worker training and certification programs to be established.

Amend the following provision of Item 4140-101-0001 as follows:

- "5. Of the funds appropriated in Schedule (1), \$\frac{256,975,000}{256,975,000}\$ is available for encumbrance or expenditure until June 30, 2028, to administer the Health and Home Care Workforce Program.
  - a) Contracts entered into or amended pursuant to this provision shall be exempt from Chapter 6 (commencing with Section 14825) of Part 5.5 of Division 3 of Title 2 of the Government Code, Section 19130 of the Government Code, Part 2 (commencing with Section 10100) of Division 2 of the Public Contract Code, and the State Administrative Manual, and shall be exempt from the review or approval of any division of the Department of General Services."

Add the following provision to Item 4140-101-0001:

- 9. Of the funds appropriated in Schedule (1), \$40,000,000 is available to establish and administer an uncompensated care fund for abortion services for individuals below 400% of the Federal Poverty Level.
  - a) Contracts entered into or amended pursuant to this provision shall be exempt from Chapter 6 (commencing with Section 14825) of Part 5.5 of Division 3 of Title 2 of the Government Code, Section 19130 of the Government Code, Part 2 (commencing with Section 10100) of Division 2 of the Public Contract Code, and the State Administrative Manual, and shall be exempt from the review or approval of any division of the Department of General Services.

Master Plan for Aging Investments (Issue 035)—It is requested that Item 4170-001-0001 be increased by \$8,891,000 and 7 positions ongoing and provisional language be added to support the Master Plan for Aging (See Attachment 1).

Caregiver Resource Centers (Issue 036)—It is requested that Item 4170-001-0001 be increased by \$545,000 and 1 position ongoing, Item 4170-101-0001 be increased by \$14,918,000 ongoing, and statutory changes be adopted to transfer the Caregiver Resource Center program from the Department of Health Care Service to the California Department of Aging (see related issue in the Department of Health Care Services Finance Letter reflecting the net-zero local assistance transfer).

Community Assistance, Recovery, and Empowerment (CARE) Court (Issue 037)—It is requested that Item 4170-001-0001 be increased by \$1,441,000 and 10 positions ongoing and Item 4170-101-0001 be increased by \$8,559,0000 ongoing to establish the CARE Court Supporters Program (see related issues in the Department of Health Care Services and Judicial Branch Finance Letters).

# **Technical Adjustments**

**Transfer of Multipurpose Senior Services Program Local Assistance Expenditure Authority (Issue 033)**—It is requested that Item 4170-101-0001 be decreased by \$31,932,000 ongoing to reflect the net-zero transfer of local assistance expenditure authority for the Multipurpose Senior Services Program from the California Department of Aging to the Department of Health Care Services (see Item 4260-101-0001 in the May 2022 Medi-Cal Local Assistance Estimate, Regular Policy Change 36 for corresponding change).

The California Department of Aging will continue to oversee and administer the program. Currently, the local assistance funding is reimbursed to the Department of Health Care Services which makes payments to providers. This technical adjustment streamlines fiscal administration of the program by reflecting the costs directly in the Department of Health Care Services budget and aligns with how the California Department of Aging's other Medi-Cal programs are budgeted.

Long-Term Care Ombudsman Expenditure Authority Transfer (Issue 039)—It is requested that Item 4170-101-0001 be increased by \$1.9 million ongoing and Item 4170-101-3167 be eliminated on an ongoing basis to reflect the transfer of expenditure authority from the Skilled Nursing Facility Quality and Accountability Special Fund to the General Fund. Welfare & Institutions Code (WIC) Section 14126.022 makes the fund inoperative on December 31, 2022. The Department of Health Care Services proposes statutory changes that will replace the expenditures from this Fund with direct General Fund expenditures for these activities (See Skilled Nursing Facility Financing Statutory Change Issue).

**Long-Term Care Patient Representative Program**—It is requested that Provision 3 of Item 4170-101-0001 be amended to authorize the California Department of Aging to utilize the expenditure authority in that Item for state operations to directly provide public patient representative services in any area of the State where the department is unable to contract with a local program (see Attachment 2).

# Add the following provisions to Item 4170-001-0001:

- 1. Of the amount appropriated in Schedule (3) of this item, \$3,500,000 shall be available for encumbrance or expenditure until June 30, 2024, for a public awareness and outreach campaign for the Long-Term Care Ombudsman program.
- 2. (a) Of the amount appropriated in Schedule (6) of this item, \$4,000,000 shall be available for encumbrance or expenditure until June 30, 2024, for an evaluation of Home and Community-Based Services in California.
  - (b) Notwithstanding any other law, the department may enter into exclusive or nonexclusive contracts, or amend existing contracts, on a bid or negotiated basis to implement the activities described in this provision. Contracts entered into or amended pursuant to this provision shall be exempt from Chapter 6 (commencing with Section 14825) of Part 5.5 of Division 3 of Title 2 of the Government Code, Section 19130 of the Government Code, Part 2 (commencing with Section 10100) of Division 2 of the Public Contract Code, and the State Administrative Manual, and shall be exempt from the review or approval of any division of the Department of General Services.

#### Amend Provision 3 of Item 4170-101-0001 as follows:

- "3. (a) Notwithstanding any other law, upon request by the Department of Aging and in consultation with the Department of Public Health, the Department of Finance may increase the expenditure authority in Schedule (2) of this item for the Office of Long-Term Care Patient Representative Program established by Chapter 3.6 of Division 8.5 of the Welfare and Institutions Code if the expenditure authority in this item is projected to be insufficient to provide adequate patient representative services based on program caseload and service costs. The Department of Finance shall not authorize an increase pursuant to this provision sooner than 30 days after notification in writing of the necessity thereof is provided to the chairpersons of the committees in each house of the Legislature that consider appropriations and the Chairperson of the Joint Legislative Budget Committee, or not sooner than whatever lesser time after that notification the Chairperson of the Joint Legislative Budget Committee, or the chairperson's designee, may determine.
  - (b) Notwithstanding any other law, if the Department of Aging is unable to contract with a Long-Term Care Patient Representative Local Program in any area of the State, the Department of Aging may utilize the expenditure authority in Schedule (2) of this Item for state operations to directly provide public patient representative services in that area of the State."

Amendment to and Addition of Various Budget Bill Items, Reimbursements, and Statutory Changes, Support and Local Assistance, Department of Health Care Services

# **State Operations**

Community Assistance, Recovery, and Empowerment Court (Issue 217)—It is requested that Item 4260-001-0001 be increased by 7 positions and \$15,178,000 in fiscal year 2022-23, \$1,065,000 annually between fiscal year 2023-24 and fiscal year 2026-27, and \$1,315,000 in fiscal year 2027-28 and ongoing to support the implementation of the Community Assistance, Recovery and Empowerment (CARE) Court Program, including designing training and technical assistance for counties. It is also requested that provisional language be added to Item 4260-001-0001 (see Attachment 1).

**Opioid Settlements Fund Oversight and State-Directed Programs (Issue 286)**—It is requested that Item 4260-001-3397 be increased by \$29,113,000 one-time, available over three-years, and Item 4260-116-3397 be increased by \$10 million one-time, available over three-years, to support substance use disorder provider training and distribution of naloxone to homeless service providers. It is also requested that provisional language be amended in Item 4260-001-3397 (see Attachment 2) and added to Item 4260-116-3397 (see Attachment 3).

**Medi-Cal Estimate (Issues 219, 251, 287, 288, and 298)**—It is requested that the adjustments below be made to the following items to reflect miscellaneous adjustments outlined in the Medi-Cal estimate.

- Item 4260-101-0001 be increased by \$1,018,614,000 and reimbursements be increased by \$91,254,000
- Item 4260-101-0232 be decreased by \$12,289,000
- Item 4260-101-0233 be decreased by \$3,520,000

Los Angeles County Misdemeanor Incompetent to Stand Trial Services and Supports (Issues 219, 287, 288, and 298)—It is requested that Item 4260-101-0001 be increased by \$100 million one-time, available over five years, to support and expand access to community-based health care treatment and housing for individuals charged with a misdemeanor and found incompetent to stand trial in Los Angeles County. It is also requested that Provision 18 be added to Item 4260-101-0001 to conform to this action (see Attachment 4).

CalHOPE Extension (Issues 219, 287, 288, and 298)—It is requested that Item 4260-101-0001 be increased by \$80 million in fiscal year 2022-23 and \$40 million in fiscal year 2023-24 to continue CalHOPE crisis counseling to Californians after federal FEMA grant funding ends until December 2023. It is also requested corresponding provisional language be added to Item 4260-101-0001 (see Attachment 4).

**Behavioral Health Crisis Continuum Planning (Issues 219, 287, 288, and 298)**—It is requested that Item 4260-101-0001 be increased by \$1.5 million one-time to continue a current year contract to support the California Health and Human Services Agency's Department of Health Care Services-specific component of a long-term plan for the behavioral health crisis continuum of care. It is also requested the corresponding provisional language be added to Item 4260-101-0001 (see Attachment 4).

Behavioral Health Federal Funds Adjustment (Issue 212)—It is requested that Item 4260-115-0890 be increased by \$31,148,000 one-time and Item 4260-116-0890 be increased by \$31,838,000 one-time to reflect an adjustment to the projected federal funds to support mental health and substance use disorder services. The increase in Item 4260-115-0890 primarily reflects a partial shift of a one-time Coronavirus Response and Relief Supplemental Appropriations Act of 2021 grant from fiscal year 2021-22 to fiscal year 2022-23. The remaining expenditure authority in fiscal year 2021-22 will be repurposed for recently awarded grants to support CalHOPE and "9-8-8" National Suicide Prevention Lifeline crisis centers. The increase in Item 4260-116-0890 reflects a partial shift of one-time COVID-19-related grant and one-time American Rescue Plan Act of 2021 grant from fiscal year 2021-22 to fiscal year 2022-23.

**Transfer Caregiver Resource Centers Expenditure Authority to California Department of Aging (Issue 214)**—It is requested that Item 4260-115-0001 be decreased by \$14,918,000 ongoing to reflect the net-zero local assistance transfer of the Caregiver Resource Center program to the California Department of Aging (see related issue in the California Department of Aging Letter reflecting the corresponding transfer).

**Family Health Estimate (Issue 218)**—It is requested that Item 4260-111-0001 be increased by \$15,534,000 ongoing, reimbursements be decreased by \$28,000 ongoing, and Item 4260-114-0001 be decreased by \$1,755,000 ongoing. These changes reflect revised expenditures due to caseload and other miscellaneous adjustments outlined in the Family Health Estimate.

Village San Francisco and Yurok Tribe of California Regional Wellness
Center (Issue 224)—It is requested that Item 4260-101-0001 be increased by \$30 million one-time to provide resources to the Friendship House San Francisco to support a portion of the construction costs of a multi-use health facility for the Village San Francisco (\$15 million) and to the Yurok Tribe of California to construct a Regional Wellness Center (\$15 million).

**Health Enrollment Navigators (Issue 231)**—It is requested that Item 4260-101-0001 be increased by \$30 million and Item 4260-101-0890 be increased by \$30 million one-time to continue the Medi-Cal Health Enrollment Navigators Project through fiscal year 2025-26.

**Equity and Practice Transformation Provider Payments (Issue 274)**—It is requested that Item 4260-101-0001 be decreased by \$130 million in fiscal year 2022-23, increased by \$107.5 million in fiscal year 2023-24, and increased by \$57.5 million in fiscal years 2024-25, 2025-26 and 2026-27, and Item 4260-101-0890 be decreased by \$130 million in fiscal year 2022-23, increased by \$107.5 million in fiscal year 2023-24, and increased by

\$57.5 million in fiscal years 2024-25, 2025-26 and 2026-27 to provide one-time payments to providers to address COVID-19 driven health disparities, improve quality in children's preventive, maternity and integrated behavioral health care, and advance practice transformation aligned with value-based payment models. It is also requested that provisional language be amended to extend encumbrance or expenditure by three years until June 30, 2027 (see Attachment 4).

**Elimination of Specified Medi-Cal AB 97 Provider Rate Reductions (Issue 275)**—It is requested that Item 4260-101-0001 be decreased by \$4,728,000, Item 4260-113-0001 be decreased by \$249,000, Item 4260-101-0890 be decreased by \$5,113,000, and Item 4260-113-0890 be decreased by \$464,000 ongoing to reflect updated estimates for eliminating the AB 97 rate reductions for specified providers.

**Reduction of Title XXI Premiums (Issue 276)**—It is requested that Item 4260-113-0001 be decreased by \$158,000, Item 4260-113-0890 be decreased by \$509,000, and statutory changes be decreased by \$24,000 ongoing to reflect updated costs to reduce premiums in the Title XXI program.

**Reducing Premiums for Working Disabled Adults (Issue 277)**—It is requested that Item 4260-101-0001 be increased by \$789,000 ongoing to reflect updated costs to reduce premiums for working disabled adults.

California Advancing and Innovating Medi-Cal (CalAIM) (Issue 281)—It is requested that Item 4260-101-0001 be increased by \$192,315,000, Item 4260-101-0890 be increased by \$214,701,000, Item 4260-113-0001 be increased by \$920,000, and Item 4260-113-0890 be increased by \$1,708,000 ongoing to reflect updated CalAIM estimates. It is also requested that provisional language be added to Item 4260-101-0001 (see Attachment 4).

**Skilled Nursing Facility Financing (Issue 284)**—It is requested that Item 4260-101-0001 be increased by \$55.3 million ongoing, Item 4260-101-0890 be increased by \$61.4 million ongoing, and statutory changes be added to provide a new Workforce and Quality Incentive Program for Skilled Nursing Facilities.

**General Fund to Proposition 56 Expenditure Transfer**—It is requested that Provisions 1 and 2 of Item 4260-112-0001 be amended to clarify technical details by which General Fund monies will be used to backfill Proposition 56 provider payments if there are insufficient revenues in the Health Care Treatment Fund (see Attachment 6).

Add Provision 10 to Item 4260-001-0001 as follows:

10. (a) Of the funds appropriated in Schedule (1), \$14,050,000 is available for encumbrance or expenditure until June 30, 2027 for the State Department of Health Care Services to support contracts to provide technical assistance for the implementation of the Community Assistance, Recovery, and Empowerment Court.

Amend Provision 1 of Item 4260-001-3397 as follows:

"1. Of the funds appropriated in Schedule (1) of this item, \$31,200,000 \$60,563,000 is available for encumbrance or expenditure until June 30, 2025, to support substance use disorder provider training and to operate a web-based statewide addiction treatment locator platform and related outreach campaign."

# Add Provision 1 to Item 4260-116-3397 as follows:

1. Of the funds appropriated in Schedule (1) of this item, \$14,750,000 is available for encumbrance or expenditure until June 30, 2025, to distribute naloxone to providers and organizations addressing the needs of individuals experiencing homelessness.

## Amend Provision 9 and 15 of Item 4260-101-0001 as follows:

- "9. Notwithstanding any other law, the Department of Finance may authorize the transfer of expenditure authority between Schedules (1), (2), and (3) and between schedules within this item and between this item and Items 4260-102-0001, 4260-111-0001, 4260-113-0001, 4260-114-0001, and 4260-117-0001 in order to effectively administer the programs funded in these items. The Department of Finance may revise reimbursement authority in this item in order to effectively administer the programs funded in these items. The Department of Finance shall notify the Legislature within 10 days of authorizing such a transfer unless prior notification of the transfer has been included in the Medi-Cal estimates submitted pursuant to Section 14100.5 of the Welfare and Institutions Code. The 10-day notification to the Legislature shall include the reasons for the transfer, the fiscal assumptions used in calculating the transfer amount, and any potential fiscal effects on the program from which funds are being transferred or for which funds are being reduced."
- "15. (a) Of the amount appropriated in this item, \$200,000,000\$70,000,000 in Schedule (3) is available for encumbrance or expenditure until June 30, 20242027 for the State Department of Health Care Services to make equity and practice transformation payments to qualifying Medi-Cal managed care plans, or through Medi-Cal managed care plans to their qualified contracted providers, to advance equity, reduce COVID-19-driven care gaps, invest in up-stream care models and partnerships to address health and wellness for ages zero to five and fund practice transformation aligned with value-based payment models to allow Medi-Cal providers to better serve the state's diverse Medi-Cal enrollee population. Subject to (b), payments pursuant to this provision are intended to promote patient-centered models of care and align with the goals of the DHCS' Comprehensive Quality Strategy.
- (b) The State Department of Health Care Services shall develop the methodology, eligibility criteria, metrics, performance milestones, and any other parameters for receipt of payments authorized in this provision.
- (c) This provision shall be implemented only to the extent any necessary federal approvals are obtained, and federal financial participation is available and not otherwise jeopardized.
- (d) Notwithstanding Chapter 3.5 (commencing with Section 11340) of Part 1 of Division 3 of Title 2 of the Government Code, the State Department of Health Care Services may implement this provision and any associated federal funding by means of plan or county letters, information notices, plan or provider bulletins, or other similar instructions, without taking any further regulatory action.
- (e) For purposes of this provision, `Medi-Cal managed care plan' shall have the same meaning as provided in subdivision (j) of Section 14184.101 of the Welfare and Institutions Code."

Add Provisions 18, 19, 20, and 21 to Item 4260-101-0001 as follows:

- 18. (a) Of the funds appropriated in Schedule (3), \$100,000,000 is available for encumbrance or expenditure until June 30, 2027, for the State Department of Health Care Services to provide grant funding to Los Angeles County to support and expand access to community-based health care treatment and housing for individuals charged with a misdemeanor and found incompetent to stand trial.
- (b) Upon order of the Department of Finance, up to \$780,000 of the funds made available pursuant to this provision shall be transferred to Schedule (1) of Item 4260-001-0001 for administration of the program described in (a) and are available for encumbrance or expenditure until June 30, 2027.
- (c) (1) Of the grant funding provided pursuant to this provision, at least seventy-five percent shall be allocated for capital costs to construct, acquire, or rehabilitate real estate assets for use as non-correctional treatment and housing facilities to serve the target population described in (a). This may include, but is not limited to, residential treatment settings, clinically enhanced interim housing settings, licensed adult and senior care settings, permanent supportive housing, or a capitalized operating subsidy reserve. (2) Of the grant funding provided pursuant to the provision, up to twenty-five percent may be allocated for rental subsidies to support placement of the target population described in (a) within qualified residential settings.
- (d) As determined by the State Department of Health Care Services, Los Angeles County shall meet all of the following conditions in order to receive grant funding pursuant to this provision: (1) provide qualifying matching funds or real property, as approved by the State Department of Health Care Services, that is equal to at least ten percent of the grant funding provided; (2) expend grant funding to supplement and not supplant existing funding available for the purposes described in this provision; (3) report relevant data to the State Department of Health Care Services, in a form, manner and frequency it requires, for the first five years of implementation; and (4) for capital costs described in (b) (1), commit to providing health care treatment or housing, or both, for the target population described in (a) in the financed facility or facilities for a minimum of thirty years.
- (e) This provision shall be implemented only if, and to the extent that, the State Department of Health Care Services determines that federal financial participation under the Medi-Cal program is not jeopardized
- (f) Notwithstanding Chapter 3.5 (commencing with Section 11340) of Part 1 of Division 3 of Title 2 of the Government Code, the State Department of Health Care Services may implement, interpret, or make specific this provision, in whole or in part, by means of information notices or other similar instructions, without taking any further regulatory action.
- (g) For purposes of implementing this provision, the State Department of Health Care Services may enter into exclusive or nonexclusive contracts, or amend existing contracts, on a bid or negotiated basis. Contracts entered into or amended pursuant to this provision shall be exempt from Chapter 6 (commencing with section 14825) of Part 5.5 of Division 3 of Title 2 of the Government Code, Section 19130 of the Government Code, Part 2 (commencing with Section 10100) of Division 2 of the Public

Contract Code and shall be exempt from the review or approval of any division of the Department of General Services.

- 19. (a) Of the funds appropriated in this item, \$80,000,000 in Schedule (3) is for the State Department of Health Care Services to support CalHOPE and \$1,500,000 in Schedule (1) is for the State Department of Health Care Services to support planning efforts for the behavioral health crisis continuum of care.
- (b) For purposes of implementing this provision, the department may enter into exclusive or nonexclusive contracts, or amend existing contracts, on a bid or negotiated basis. Contracts entered into or amended pursuant to this provision shall be exempt from Chapter 6 (commencing with section 14825) of Part 5.5 of Division 3 of Title 2 of the Government Code, Section 19130 of the Government Code, Part 2 (commencing with Section 10100) of Division 2 of the Public Contract Code and shall be exempt from the review or approval of any division of the Department of General Services.
- 20. Notwithstanding any other provision of law, the Department of Finance may adjust amounts in this item, Item 4260-111-0001, or any other related item resulting from the State Department of Health Care Services obtaining federal approval to claim federal financial participation for expenditures associated with Designated State Health Programs as part of the CalAIM Demonstration. Within 30 days of making any adjustment pursuant to this provision, the Department of Finance shall report the adjustment in writing to the Joint Legislative Budget Committee.
- 21. (a) The nonfederal share amounts received by the State Department of Health Care Services as monetary sanctions collected in the 2022-23 state fiscal year pursuant to subdivision (g) of Section 14197.7 of the Welfare and Institutions Code shall pursuant to subdivision (q)(1) of Section 14197.7 of the Welfare and Institutions Code be deposited into the General Fund.
- (b) This Item shall be augmented by the amount deposited into the General Fund per (a) and available for encumbrance or expenditure until June 30, 2024 for the State Department of Health Care Services to award grants to qualifying, non-profit legal aid programs and organizations that serve Medi-Cal managed care enrollees in Los Angeles County or other impacted counties, as necessary.
- (c) The State Department of Health Care Services shall determine the eligibility criteria, methodology and distribution of funds appropriated in this provision.
- (d) The State Department of Health Care Services may enter into exclusive or non-exclusive contracts, or amend existing contracts, on a bid or negotiated basis for purposes of implementing this item. Contracts entered into or amended pursuant to this provision shall be exempt from Chapter 6 (commencing with Section 14825) of Part 5.5 of Division 3 of Title 2 of the Government Code, Section 19130 of the Government Code, Part 2 (commencing with Section 10100) of Division 2 of the Public Contract Code, and from the State Administrative and State Contracting manuals, and shall be exempt from the review or approval of any division of the Department of General Services.

Amendments to Various Budget Bill Items and Reimbursements, Support, Local Assistance, and Statutory Changes, Department of Developmental Services

**Promoting Workforce Stability (Issue 077)**—It is requested that Item 4300-001-0001 be increased by \$881,000 and 5.5 positions and reimbursements be increased by \$220,000 and 1.5 positions ongoing. It is also requested that Item 4300-101-0001 be increased by \$185,300,000 one-time. These adjustments provide resources to support efforts to address current and emerging workforce challenges among regional center consumer service coordinators and workers who provide direct services. Additionally, it is requested that Provisions 11 and 12 be added to Item 4300-101-0001 to extend encumbrance and expenditure availability for the internship program and tuition reimbursement program components of this proposal (see Attachments 1 and 2).

Service Access and Equity Grant Program (Issue 079)—It is requested that I tem 4300-001-0001 be increased by \$634,000 and 4 positions and reimbursements be increased by \$158,000 and 1 position ongoing. It is also requested that Item 4300-101-0001 be increased by \$11,000,000 one-time. These adjustments provide resources to increase funding available in the Service Access and Equity Grant Program and support ongoing workload associated with monitoring existing and future grant applications and awards.

**State-Operated Facilities–Enhanced Federal Funding (Issue 089)**—It is requested that Item 4300-001-001 be decreased by \$780,000 and reimbursements be increased by \$780,000 one-time to reflect the estimated receipt of additional federal funds associated with the extension of the federal public health emergency related to the COVID-19 Pandemic.

**Regional Centers–Half-Day Billing Elimination (Issue 093)**—It is requested that Item 4300-101-0001 be increased by \$1,905,000 and reimbursements be increased by

\$940,000 ongoing to reflect elimination of the half-day billing policy for service providers. It is also requested that corresponding statutory changes be added for these purposes.

**Regional Centers–Enhanced Federal Funding (Issue 094)**—It is requested that Item 4300-101-001 be decreased by \$124,518,000 and reimbursements be increased by \$124,518,000 one-time to reflect the estimated receipt of additional federal funds associated with the extension of the federal public health emergency related to the COVID-19 Pandemic.

**Regional Centers–Early Start Eligibility (Issue 095)**—It is requested that Item 4300-101-0001 be increased by \$6,492,000 ongoing for resources associated with revising statutory provisions that specify qualifying determinants for early intervention services, including identifying Fetal Alcohol Syndrome as a risk factor for developmental disabilities. It is also requested that corresponding statutory changes be added for these purposes.

**Regional Centers–ICF-DD Rate Increase (Issue 096)**—It is requested that Item 4300-101-0001 be increased by \$1,421,000 ongoing to support additional funding provided to Intermediate Care Facilities – Developmentally Disabled and Skilled Nursing Facilities as a result of the state making permanent a flexibility adopted under the federal public health emergency related to the COVID-19 Pandemic.

**Regional Centers–Financial Management Services for Self-Determination Program Participants (Issue 097)**—It is requested that Item 4300-101-0001 be increased by \$4,392,000 and reimbursements be increased by \$2,808,000 ongoing to support moving the cost of Financial Management Services for Self-Determination Program Participants out of individual budgets. It is also requested that corresponding statutory changes be added for these purposes.

**Regional Centers–Emergency Preparedness (Issue 098)**—It is requested that Item 4300-101-0001 be increased by \$850,000 ongoing to support regional center emergency preparedness and response efforts, including resources for alert system contract renewals, satellite phones maintenance, ongoing distribution of emergency information materials, and replacement of batteries and generators.

**Regional Centers – Caseload and Utilization May Revision (Issue 106)**—It is requested that Item 4300-101-0001 be increased by \$38,539,000 and reimbursements be increased by \$12,318,000 ongoing. It is also requested that Item 4300-101-0172 be increased by \$230,000 and Item 4300-101-0890 be decreased by \$72,000 ongoing. These adjustments reflect updated expenditure estimates in operations and purchase of services driven by caseload and utilization.

**Disposition of Fairview Developmental Center (Issue 108)**—It is requested that statutory changes be added to specify a planning process and express intended use for the Fairview Developmental Center property in the City of Costa Mesa. The planning process would be in coordination with the Department of Developmental Services, the Department of General Services, and the City of Costa Mesa. For these purposes, it is

requested that \$3,500,000 be appropriated one-time to the Department of Developmental Services for allocation to the City of Costa Mesa to facilitate disposition of the property.

Language Only—It is requested that Provision 7 be added to Item 4300-001-0001 to exempt contracts concerning implementation of service provider rate models and the quality incentives program, pursuant to Welfare and Institutions Code section 4519.10, from the requirements contained in the in the Public Contract Code and the State Administrative Manual and from approval by the Department of General Services (see Attachment 3). This provision would allow the Department to continue using contractors currently in place through the full implementation of the programs by June 30, 2026.

**Language Only**—It is requested that Provision 2 of Item 4300-101-0001 be amended to change General Fund loan authority from \$869,794,000 to \$1,122,637,000 to reflect revised estimates regarding federal reimbursements (see Attachment 4).

**Language Only**—It is requested that Provision 9 of Item 4300-101-0001 be amended to extend the encumbrance and expenditure date for the service model pilot program focused on expanding employment opportunities for individuals with intellectual or developmental disabilities from June 30, 2025 to December 31, 2025 (see Attachment 5).

**Language Only**—It is requested that Provision 10 be added to Item 4300-101-0001 to specify the funds appropriated to the Department of Developmental Services for the purpose of supporting regional centers in maintaining an average service coordinator-to-consumer ratio of 1 to 40 for consumers birth through five years of age, inclusive (see Attachment 6).

Addition of Budget Bill Items 4300-301-0001 and 4300-491, Capital Outlay, Department of Developmental Services

California Construction Cost Index Increase-Construction—It is requested that Item 4300-301-0001 be added in the amount of \$1,148,000 one-time for the Porterville: Install Fire Sprinkler project that is proposed for construction funding in 2022-23 (see Attachment 1). The national construction market has experienced significant inflation since 2021. The California Construction Cost index, which is the metric the state uses to track overall construction prices, has increased by approximately 10 percent since the Governor's Budget and approximately 25 percent for capital projects that were funded in the 2021-22 budget. This request will address the cost increases resulting from these inflationary pressures to ensure projects can proceed to the construction phase with adequate funding.

**Porterville: Install Fire Sprinkler-Reappropriation**—It is also requested that Item 4300-491 be added to reflect the reappropriation of funds from the 2021 Budget Act that were proposed in the 2022-23 Governor's Budget (see Attachment 2). The reappropriation addresses delays in the project schedule related to the COVID pandemic. This is a technical request to add this language to the budget bill.

Amendment to Budget Bill Items 4440-011-0001 and Reimbursements, and 4440-490, and Addition of Item 4440-021-3398, Support, Department of State Hospitals (DSH)

**IST Solutions (Issues 100 and 103)**—It is requested that Item 4440-011-0001 be increased by \$489,336,000 and 76.0 positions in 2022-23, \$436,108,000 and 93.5 positions in 2023-24, \$471,739,000 and 98.5 positions in 2024-25, and \$591,933,00 and 95.0 positions in 2025-26 ongoing to implement solutions for the Incompetent to Stand Trail (IST) Workgroup. This funding will be used to address early stabilization, care coordination, waitlist management, and increasing IST beds in community-based programs by 5,000 over four years. Funding for IST solutions was previously included in the budget as a set-aside. It is also requested that provisional language be added to Item 4440-011-0001 to make \$318,750,000 available for encumbrance or expenditure to June 30, 2027 (see Attachment 1).

Mission Based Review: Workforce Development (Issue 074)—It is requested that Item 4440-011-0001 be increased by \$179,000 in 2022-23 to provide limited-term resources equivalent to one Staff Services Manager II Specialist to lead research efforts to build future partnerships to expand the psychiatry residency programs to other state hospitals.

Mission Based Review: Treatment Team (Issue 076)—It is requested that Item 4440-011-0001 be decreased by \$8,334,000 in 2022-23, \$9,420,000 in 2023-24 and 2024-25, and \$4,712,000 in 2025-26 due to one-time savings from shifting out the hiring plan for 29.5 positions to January 1, 2026, of which 27.1 positions were originally to be hired in 2022-23.

**Enhanced Treatment Program (ETP) Staffing (Issue 085)**—It is requested that Item 4440-011-0001 be increased by \$253,000 in 2022-23 for unforeseen fire sprinkler installation design change, the need to survey for potential asbestos containing materials, the discovery of gaps in the existing smoke barrier that have further extended the anticipated length of the project at DSH-Patton U-Building, and costs for building materials, construction, and labor that have increased since pre-COVID-19 when funding was provided.

County Bed Billing Reimbursement Authority (Issue 086)—It is requested that Item 4440-011-0001 be amended by increasing reimbursements by \$9,160,000 ongoing. This adjustment allows DSH to collect funds from counties for recently approved increased bed rates that are effective July 1, 2022 for Lanterman-Petris-Short patients and IST defendants who are not transported and returned to the committing county in a timely manner.

**Statewide Integrated Health Care Provider Network (HCPN) Reappropriation (Issue 070)**—It is requested that Item 4440-490 be amended to reappropriate \$5.4 million from Item 4440-011-0001 of the 2021 Budget Act to support the Health Care Provider Network to June 30, 2024 (see Attachment 3). There were delays in the implementation of the HCPN due to the redirection of resources to prevent and respond to COVID-19. In addition, due to the continuous COVID-19 challenges and needs, DSH experienced

delays in the solicitation of a business consultant to assist with the solicitation and implementation of the HCPN. DSH also anticipates an extended solicitation period for the HCPN contract, once posted, due to an extensive approval process and extensive vendor negotiations regarding rates and scope of work.

Mission Based Review: Treatment Team Reappropriation (Issue 090)—It is requested that Item 4440-490 be amended to reappropriate \$12,193,000 from Item 4440-011-0001 of the 2021 Budget Act to support the Mission Based Review: Treatment Team to June 30, 2024 (see Attachment 3). As of February 28, 2022, DSH's internal planning efforts to identify its programmatic needs continues in conjunction with an assessment of the existing infrastructure to determine the extent of site preparations required at each facility. After the assessment is complete, DSH will use funds to contract and purchase materials to install additional modular/trailer office buildings, furnishings, and IT infrastructure.

**Re-Evaluation Services for Felony IST Programs Reappropriation (Issue 091)**—It is requested that Item 4440-490 be amended to reappropriate \$4.1 million from Item 4440-011-0001 of the 2021 Budget Act to support the Re-Evaluation Services for Felony IST Programs to June 30, 2024 (see Attachment 3). Program establishment measures such as contract execution, and establishing procedures and protocols, in addition to delays in hiring, have resulted in unspent funds. The extension of funding would allow DSH to continue reevaluations of IST defendants, coordinate service delivery, and reimburse jail costs.

**IST Diversion Program Reappropriation (Issue 092)**—It is requested that Item 4440-490 be amended to reappropriate \$5 million from Item 4440-011-0001 of the 2021 Budget Act to support the IST Diversion Program to June 30, 2024 (see Attachment 3). The majority of diversion programs have experienced activation delays due to COVID.

**IST Solutions Reappropriation (Issue 095)**—It is requested that Item 4440-490 be amended to reappropriate \$15.3 million from Item 4440-011-0001 of the 2021 Budget Act to support the IST Solutions to June 30, 2024 (see Attachment 3).

Amendment to Budget Bill Items 4440-301-0001 and 4440-491, and Addition of Item 4440-301-0660, Capital Outlay, Department of State Hospitals

California Construction Cost Index Increase-Construction—It is requested that Item 4440-301-0001 be increased in the amount of \$140,000 one-time for the Atascadero: Potable Water Booster Pump System project (see Attachment 1) and Item 4440-301-0660 be added to reflect an increase in the amount of \$5,506,000 one-time for the Metropolitan: Consolidation of Police Operations project (see Attachment 2). The national construction market has experienced significant inflation since 2021. The California Construction Cost index, which is the metric the state uses to track overall construction prices, has increased by approximately 10 percent since the Governor's Budget and 25 percent for capital projects that were proposed in the 2021-22 budget. This request will address the cost increases resulting from these inflationary pressures to ensure projects can proceed to the construction phase with adequate funding.

**Metropolitan: Consolidation of Police Operations-Reappropriation**—It is also requested that Item 4440-491 be amended to reappropriate the construction phase of this project (see Attachment 2). The reappropriation is necessary to allow for the completion of regulatory reviews and approvals in the working drawings phase.

Patton: Fire Alarm System Upgrade- Supplemental Appropriation—It is requested that Item 4440-301-0001 be increased by \$12,191,000 (see Attachment 1). This project is ready to move to construction; however, due to COVID restrictions and legal requirements, the Department of State Hospitals had to re-evaluate its implementation options for the project, resulting in an extended project timeline and an increase in overall project costs.

- (b) Notwithstanding any other law, allocations pursuant to this provision shall be exempt from the personal services contracting requirements of Article 4 (commencing with Section 19130) of Chapter 5 of Part 2 of Division 5 of Title 2 of the Government Code, from the Public Contract Code and the State Contracting Manual, and shall not be subject to the approval of the Department of General Services, including provisions pursuant to Chapter 6 (commencing with Section 14825) of Part 5.5 of Division 3 of Title 2 of the Government Code.
- (c) Upon approval from the Department of Finance, the funds appropriated in Schedule (1) for the purposes described in this provision may be transferred to Item 5180-001-0001 to administer training on racial equity and implicit bias for CalWORKs county staff.
- (d) Any transfer in excess of 5 percent may be authorized pursuant to this provision not sooner than 30 days after notification in writing of the necessity therefor is provided to the Chairperson of the Joint Legislative Budget Committee, or not sooner than whatever lesser time after that notification the chairperson of the joint committee, or the chairperson's designee, may in each instance determine.

Add the following Provision to Item 5180-101-0001 to reflect the following:

- 20. (a) The Department of Finance may augment this item for the Trafficking and Crime Victims Assistance Program, established in Section 13283 of the Welfare and Institutions Code, to include Ukrainian citizens and nationals admitted to the United States as humanitarian parolees under Section 1182(d)(5) of Title 8 of the United States Code on or after January 1, 2022, through June 30, 2023.
- (b) The Trafficking and Crime Victims Assistance Program period of eligibility for individuals described in (a) shall begin on either July 1, 2022 or the individual's date of entry to the United States, whichever occurs later.
- (c) An augmentation of this item for the purposes identified in subdivision (a) of this provision may be authorized not sooner than 10 days following written notification to the Chairperson of the Joint Legislative Budget Committee, or a lesser period if requested by the department and approved by the Chairperson or the Chairperson's designee.

### Add Provision 4 to Item 5180-111-0001:

- 4. (a) Of the funds appropriated in Schedule (2), up to \$3,861,000 shall be available to support the administration of a transitional backup provider system for In-Home Supportive Services and Waiver Personal Care Services providers. These funds shall be available for use until the implementation of a permanent program.
- (b) The State Department of Social Services shall determine the methodology and distribution of the funds to those counties and providers it deems qualified.
- (c) Notwithstanding Chapter 3.5 (commencing with section 11340) of Part 1 of Division 3 of Title 2 of the Government Code, the department may implement, interpret, or make specific this item, in whole or in part, by means of information notices or other similar instructions, without taking any further regulatory action.

Amendment to Budget Bill Item 5180-141-0001 as follows:

10.(a) Of the funds appropriated in Schedule (1) \$81,471,000 \$57,627,000 is for the support of activities related to the Child Welfare Services-California Automated Response and Engagement System (CWS-CARES) project. Expenditure of these funds is contingent upon approval of project documents by the Department of Finance and the Department of Technology. This amount may be augmented up to a maximum of \$5,000,000 \$17,381,000 for project activities upon approval by the Department of Finance, in consultation with the Department of Technology. In providing approval, the Department of Finance shall consider verified satisfactory progress toward milestones associated with the CWS-CARES Product Roadmap, product adoption, and the roadmap change management process. Such an augmentation shall only be used to support an acceleration of planned project activities and shall not be used to increase total project costs. Any such augmentation shall be authorized no less than 30 calendar days following written notification to the Chairperson of the Joint Legislative Budget Committee, or a lesser period if requested by the Department of Finance and approved by the Chairperson of the Joint Legislative Budget Committee, or the chairperson's designee.

23. Of the funds appropriated in Schedule (1), \$150,000,000 shall be available to supplement county foster family and engagement activities contingent upon legislation detailing objectives, implementation design and timelines, data collection, and outcome measurements for these activities. This funding shall be available for encumbrance or expenditure until June 30, 2027.

- 24. (a) Of the funds appropriated in Schedule (1), \$10,375,000 is available for the State Department of Social Services to provide funding to eligible Short-Term Residential Therapeutic Program providers for the purpose of maintaining sufficient capacity for the foster care population.
- (b) The State Department of Social Services shall determine, in consultation with stakeholders, including the California Alliance of Child and Family Services, the County Welfare Directors Association of California, the Chief Probation Officers of California, and the County Behavioral Health Directors Association of California, the eligibility criteria and methodology for distribution of the funding pursuant to this provision.
- (c) Notwithstanding Chapter 3.5 (commencing with Section 11340) of Part 1 of Division 3 of Title 2 of the Government Code, the State Department of Social Services may implement, interpret, or make specific this provision, in whole or in part, by means of all-county letters, information notices, or other similar instructions, without taking any further regulatory action.
- (d) For purposes of implementing this provision, the State Department of Social Services may enter into exclusive or nonexclusive contracts, or amend existing contracts, on a bid or negotiated basis. Notwithstanding any other law, contracts entered into or amended pursuant to this provision shall be exempt from Chapter 6 (commencing with Section 14825) of Part 5.5 of Division 3 of Title 2 of the Government Code, Part 2 (commencing with Section 10100) of Division 2 of the Public Contract Code, and the State Administrative Manual, and shall be exempt from the review or approval of any division of the Department of General Services.
- (e) For purposes of this provision, "Short-Term Residential Therapeutic Program" shall have the same meaning as set forth in subdivision (ad) of Section 11400 of the Welfare and Institutions Code.
- (f) The State Department of Social Services, in conjunction with the State Department of Health Care Services and the county placing agencies, shall provide written updates to the appropriate policy and fiscal staff of the Legislature on a monthly basis, commencing January 1, 2023, and through June 1, 2023. After June 1, 2023, these updates shall be provided on at least a quarterly basis. Subject to and consistent with state and federal confidentiality and privacy laws, these updates shall include the following information: (i) information on youth that transition from short-term residential therapeutic programs that are converting their facilities to 16 beds or less, including the placement or family they move to, and the specialty mental health services they are receiving in this new placement or family, based on claims submitted to the State Department of Health Care Services, (ii) information regarding the eligibility criteria and methodology for distribution of the funding specified in subdivision (b) of this provision, (iii) data on the number of beds and individual facilities deemed institutions for mental disease and when this occurs for each affected entity, and (iv) the estimated federal financial participation that is foregone as a result of these conversions.

- 25(a) Of the funds appropriated in this item, up to \$25,000,000 shall be available for the State Department of Social Services to administer and enter into contracts with qualified organizations for the purposes of development and implementation of innovative placements models of care, trauma-informed services utilizing harm reduction strategies, specialized commercial sexual exploitation as defined in subdivision (d) of Section 11165.1 of the Penal Code. These funds shall be available for encumbrance or expenditure until June 30, 2025.
- (b) For purposes of implementing this provision, the State Department of Social Services may enter into exclusive or nonexclusive contracts, or amend existing contracts, on a bid or negotiated basis. Notwithstanding any other law, contracts entered into or amended pursuant to this provision shall be exempt from Chapter 6 (commencing with Section 14825) of Part 5.5 of Division 3 of Title 2 of the Government Code, Article 4 (commencing with Section 19130) of Chapter 5 of Part 2 of Division 5 of Title 2 of the Government Code, Part 2 (commencing with Section 10100) of Division 2 of the Public Contract Code, and the State Contracting Manual, and shall be exempt from the review or approval of the Department of General Services and Department of Technology.
- (c) Notwithstanding Chapter 3.5 (commencing with Section 11340) of Part 1 of Division 3 of Title 2 of the Government Code, the State Department of Social Services may implement, interpret, or make specific this provision, in whole or in part, without taking regulatory action.

- 26. (a) Of the funds appropriated in Schedule (2), \$175,000,000 shall be available for the Rapid Response program as described in Chapter 5.7 (commencing with Section 13400) of Part 3 of Division 9 of the Welfare and Institutions Code. These funds shall be available for encumbrance or expenditure until June 30, 2024.
- (b) In accordance with Section 1621(d) of Title 8 of the United States Code, this provision provides for services for undocumented persons.
- (c) Upon approval of the Department of Finance, funds appropriated in Schedule (2) for the purposes described in this provision may be transferred to Item 5180-001-0001 to implement and administer the Rapid Response program.
- (d) The State Department of Social Services and Department of Finance shall provide a written update to the Joint Legislative Budget Committee by April 1, 2023 on the services and support specified in this provision.

- 27. (a) Of the funds appropriated in Schedule (2), \$12,000,000 shall be available to the State Department of Social Services to provide funding for the following entities:
  - (1) \$3,000,000 to the Chula Vista Promise Neighborhood
  - (2) \$3,000,000 to the Corning Promise
  - (3) \$3,000,000 to the Hayward Promise Neighborhood
  - (4) \$3,000,000 to the Mission Promise Neighborhood
  - (b) These funds shall be available for encumbrance or expenditure until June 30, 2025.
  - (c) The State Department of Social services shall determine the best method for allocation of this funding.
  - (d) Notwithstanding any other law, the department's allocation of funds pursuant to this provision shall be exempt from the requirements of Article 4 (commencing with Section 19130) of Chapter 5 of Part 2 of Division 5 of Title 2 of the Government Code, and from the Public Contract Code and the State Contracting Manual, and shall not be subject to the approval of the Department of General Services.

- 28. (a) Of the amount appropriated in Schedule (2), \$2,500,000 shall be available for the purpose of funding legal fellowships for persons who provide services, including removal defense services, pursuant to Chapter 5.6 (commencing with Section 13300) of Part 3 of Division 9 of the Welfare and Institutions Code, in rural and underserved regions of California. For purposes of this funding, the State Department of Social Services may establish separate criteria to award grants or contracts to nonprofit entities to provide fellowship recruitment and placement, coordination, mentorship, and other activities that support the supervision and delivery of legal services.
- (b) These funds shall be available for encumbrance or expenditure until June 30, 2025, and liquidation until June 30, 2027.
