<p>ISSUE 2</p>	<p>IMPLEMENTATION OF THE FAIR LABOR STANDARDS ACT (FLSA) FOR IHSS</p> <p>Approve an enhanced and clarified exemption process for vulnerable IHSS recipients, adopting the proposal from the IHSS Coalition, with placeholder trailer bill language from Disability Rights California, to expand qualified exemptions, create an appeals process, and provide for a program notice. The original appropriation for the exemptions should be utilized to cover the cost of this exemption policy modification intended to create rightful access to vulnerable IHSS consumers in the program.
