Available Funds and Revenue Uncertainty

June 2016

- Nearly \$1.4 Billion in Unallocated Funds at End of 2015-16.**
- Recent Auction Results Add Substantial Revenue Uncertainty.**
 - Each of the five quarterly auctions from February 2015 through February 2016 generated over \$500 million in state revenue.
 - The May 2016 auction generated only \$10 million in state revenue.
 - Significant uncertainty about amount of revenue to expect in 2016-17, but possible that the next few auctions will have similar results to the May 2016 auction.
- Funding for Continuously Appropriated Programs Could Be Affected.**
 - Given revenue uncertainty, it is possible that these programs would receive significantly less funding than the expenditure packages assume.
 - Unclear how much 2016-17 revenue would be available for other programs, as well.



LAO Recommendations

June 2016

- Use \$1.4 Billion in Unallocated Funds as Starting Point for Expenditure Plan.**
 - Amount of additional funds available from 2016-17 auctions is subject to considerable uncertainty.

- Ensure Allocations From \$1.4 Billion Go to Highest Priority Programs.**
 - Consider both discretionary programs and continuously appropriated programs when identifying priorities. For example, the budget could provide specific allocation amounts for currently continuously appropriated programs to ensure they receive minimum desired funding level.

- Develop Plan for 2016-17 Revenue.**
 - With respect to any revenue generated in 2016-17, the Legislature might want to identify (1) the amount or percentage it would like to retain in the fund for future years and (2) its priorities for which programs to fund in 2016-17 beyond what it allocated from the \$1.4 billion.
 - Once the Legislature identifies these amounts and priorities, it could structure a budgeting strategy to ensure the allocations are consistent with its goals. This could include, for example, use of allocation formulas or funding “buckets” that designate how much revenue are provided to different programs based on how much revenue is received.

Overview of Aliso Canyon and Natural Gas Management Conference Issues



Governor's Proposals

- The Governor requested a total of 36 positions and \$13 million from various special funds for five state agencies (Air Resources Board, Department of Conservation [DOC], California Public Utilities Commission [CPUC], California Energy Commission [CEC], and the Office of Environmental Health Hazard Assessment) to carry out natural gas industry oversight functions.



Assembly Actions

- The Assembly approved the Governor's proposals but modified them by converting three permanent positions at CPUC and associated funding to three-year limited term.



Senate Actions

- The Senate approved the Governor's proposal subject to the passage of statute to provide accountability and reporting to the Legislature.
- Added \$2.1 million (Public Utilities Commission Utilities Reimbursement Account) and seven permanent positions at CPUC to implement Chapter 14 of 2016 (SB 380, Pavley) which, among other things, requires CPUC to open a proceeding to assess the ongoing level of natural gas storage needed at Aliso Canyon to maintain reliability.
- Adopted budget trailer language to (1) establish a single point of contact under the Secretary for Natural Resources to be responsible for natural gas safety, (2) provide mechanisms for state agencies to work together in order to ensure efficiency and coverage of all aspects of natural gas storage and transmission, and (3) provide for annual reporting on the administration's efforts to improve natural gas safety within the state.

Overview of Aliso Canyon and Natural Gas Management Conference Issues

(Continued)

- Adopted budget trailer language directing CEC to establish a natural gas tracking and rating system that will enable natural gas purchasers to assess lifetime environmental impact of the vented and fugitive emission of the gas they procure.
- Adopted budget trailer language to require that on or before January 1, 2019, the Division of Oil, Gas, and Geothermal Resources (within DOC) shall develop, through a public process, with input from independent experts, stakeholders, and the public, “best practices” for the design, maintenance, monitoring, operation, data reporting, and plugging and abandonment of gas storage wells.
- Provided for a contract for the California Center for Science and Technology to study natural gas transmission and storage within the state and provide the Legislature with recommendations regarding (1) gaps in regulation that could impact public and environmental health and safety, (2) areas where market mechanisms are not sufficient to protect public health and safety, (3) how the state could require cradle-to-grave best practices in the natural gas system, and (4) where the state should focus increased enforcement of the system.

LAO Recommendation: We recommend the Assembly version with modified trailer bill language. The Assembly version provides the funding and positions needed by DMV to implement AB 1461 and the funding and positions were not specifically a concern for the Senate. Both the Assembly and the Senate recognize the need for improvements to DMV's voter registration process. However, we find that the Legislature needs more information on the extent of the problems and potential solutions. Accordingly, we recommend modifying the Assembly's trailer bill language to require DMV to (1) evaluate several potential improvements to the voter registration process, such as adding voter registration information to driver license application form and using signature pads for voter registration, and (2) report by January 10, 2017 to the Legislature on the results of this evaluation, including recent data on the extent to which DMV customers are completing the voter registration process. The Legislature can revisit this issue next year to ensure that necessary improvements to the process are enacted.

Governor: The Governor's Budget proposes \$3.9 million to implement the New Motor Voter Program.
