Job Service Position Reduction Plan

As part of the Administration's on-going efforts to live within the State's means, the Governor's budget for State Fiscal Year 2007-08 proposes to redirect \$27.1 million Contingent Fund dollars back to the General Fund. Since 1983, the Contingent Fund has been used to supplement federal Wagner-Peyser funding that supports the Employment Development Department's (EDD) Job Service (JS) Program.

The JS Program matches job seekers with employers who need qualified workers through the administration of the State's labor exchange system known as CalJOBs. The JS Program is a key component of California's workforce investment system. JS services are delivered in conjunction with other employment, training and supportive services funded by the federal Workforce Investment Act (WIA) and other State and federal sources. These services are available to the public in One-Stop Centers throughout the State. JS is responsible for providing a variety of initial "core" services that are designed to assist One Stop customers in finding employment. JS also provides specialized services to targeted groups such as veterans, individuals with disabilities, migrant and seasonal farmworkers, and the long-term unemployed. The Federal Trade Act Assistance and Worker Opportunity Tax Credit programs are also administered by JS staff. JS services are available to the public in 139 locations, statewide.

The loss of the \$27.1 million Contingent Fund dollars will require the elimination of 271 positions from the JS Program. Approximately 80 percent (217) of these positions are assigned to field offices to provide direct services to the public. The remaining 54 positions are assigned to the Central Office to perform program and administrative support functions including legal, program review, information technology, labor market information and administrative support. The elimination of the Central Office positions will be mitigated through attrition or moving staff to different programs. The JS field positions targeted for elimination are listed below.

While the elimination of 217 field positions will result in fewer staff available to provide employment services to the public, every effort will be made to minimize the impact on services to special targeted groups and the delivery of core services in the One Stop Centers. Some of the field positions will be eliminated through attrition. Where it is necessary to eliminate filled positions, staff will be transferred to vacant positions in other EDD program areas. EDD is also reviewing existing facilities to identify

opportunities to consolidate staff and reduce rent costs. Any savings achieved through rent reductions will be used to offset the position reductions. The actual number of positions to be eliminated may be less than the current estimate depending on the outcome of efforts to reduce rent and other overhead costs.

Under WIA, Job Service is responsible for providing core services in at least one comprehensive One Stop Center in each of the 50 Local Workforce Investment Areas (LWIA). A One Stop is defined as "comprehensive" if it provides the public with direct access to all of the services offered by the required partners in one physical office location. The EDD has developed a preliminary plan for achieving the position reductions that will ensure continued compliance with this federal mandate. The reductions are based on the following considerations:

- Business needs will be the primary factor considered in selecting positions for elimination. The 131 line staff positions, Employment Program Representatives, (EPR) will be targeted for reduction based on the percentage of total EPR positions that are currently assigned to each of the Job Service regions. This will maintain the current organizational structure and result in an equitable distribution of the reductions within each LWIA.
- The reduction of management positions will be based on the current management to staff ratios.
- Positions requiring special skills and/or meeting State or federal statutes and regulations such as language and veteran status will not be eliminated.
- Positions that do not require special skills will be identified for reduction in accordance with existing labor/management collective bargaining agreements.
- Permanent Intermittent (PI) EPRs will be furloughed prior to the mandatory transfer of permanent staff.
- Every effort will be made to minimize the impact of the reductions on the WIA partners and the integrated service strategies in the One Stops.

Proposed implementation options for the reductions include the following:

- Positions that become vacant in the targeted classifications will not be backfilled unless they are mission critical.
- EDD will identify vacancies in other program areas and encourage staff to voluntarily transfer.
- If necessary, mandatory reassignments of employees from Job Service to vacant positions within other Branches will occur.

Based on these considerations, the Table below provides the number of positions proposed for elimination in the Northern, Los Angeles and Southern geographic areas of the State, along with the total number of positions in the targeted classifications for comparison. A more detailed breakdown is provided in Attachment 1.

A list of the One Stop locations included in each of the regions within these geographic areas is provided in Attachment 2, along with information on the type of One Stop designation. The One Stop designation is determined by the services that are available at a particular site. In addition to the requirement for each LWIA to operate at least one comprehensive One Stop where partners are present to provide services, there are numerous affiliate and satellite sites that house one or more partners and provide access to services electronically or by referral.

Attachment 3 provides an inventory of Job Service facilities and corresponding rent costs. The loss of the Contingent Fund will require EDD to reduce facilities costs by approximately \$3.1 million. The downsizing of the Job Service program over the past several years has resulted in an excessive amount of unused space in many EDD facilities. The additional staffing reductions resulting from the loss of the Contingent Fund may provide opportunities to consolidate resources into fewer facilities in some locations. EDD is currently working with partners to develop a plan for reducing rent costs.

Attachment 4 provides a list of the options that are under consideration. Discussions with partners are currently underway and should be completed on or about May 1, 2007. Final decisions on facilities options will be made once EDD has received input from all of the stakeholders. Efforts to reduce rent costs will continue regardless of decisions made on the Contingent Fund. EDD has already achieved savings in some of the projects that are nearing completion. The savings achieved by reducing premises costs will be used to offset the staffing reductions.
