









## NATIONAL ICAC PROGRAM BACKGROUND

Created in 1998, the Internet Crimes Against Children (ICAC) Task Force is a national network of **61** coordinated task forces, representing over **5,400** federal, state, and local law enforcement, dedicated to investigating, prosecuting and developing effective responses to internet crimes against children. Each ICAC Task Force is run by one lead agency which in turn solicits law enforcement agencies within their region as affiliates. Each ICAC Task Force works hand in hand with the National Center for Missing and Exploited Children (NCMEC), whose mission is to help find missing children, reduce child sexual exploitation, and prevent child victimization.

Federal Statute 18 U.S.C. § 2258A requires electronic communication service providers—such as internet service providers, social media platforms, and other online services—to report any apparent instances of Child Sexual Abuse Imagery (CSAM) to the National Center for Missing & Exploited Children (NCMEC) whenever such content is detected on their platforms. These reports are called CyberTips. NCMEC distributes CyberTips through its online portal to the designated lead agency of the Internet Crimes Against Children (ICAC) Task Force based on the location of the online predator and/or victim.

The ICAC Task Force lead agency is the only agency to receive these tips and is in turn tasked with assigning them to the appropriate affiliate law enforcement agency for investigation. In 2023, the number of CyberTips surged by 12%, with a staggering 300% rise in cases of child enticement, where children are groomed or coerced into producing sexually explicit images or meeting offenders in person. Of the approximately **1.1 million** CyberTips traced to locations within the United States, California topped the list with **110,785 reports**.

Beyond their mandate to investigate CyberTips, ICAC Task Forces also undertake proactive efforts to combat child exploitation. These efforts include operations to track down individuals actively distributing Child Sexual Abuse Imagery (CSAM) and undercover online chat initiatives aimed at identifying, apprehending, and prosecuting the most dangerous predators—those seeking to meet children for sexual purposes.

The ICAC Task Force program mandates training for law enforcement personnel, prosecutors, and other professionals involved in ICAC efforts, ensuring that investigations align with the National ICAC Program Operational and Investigative Standards, as outlined by the U.S. Department of Justice. Additionally, the program is dedicated to educating parents, youth, and the broader community about the risks of online

activity, including the threat of online child victimization.
