# Amendment to Various Budget Bill Items, Support, Department of Human Resources

**Classification Audit**—It is requested that Item 7501-001-0001 be increased by \$650,000 General Fund in fiscal year 2025-26 to conduct an audit of work performed by the California Association of Professional Scientists, Bargaining Unit 10 as required by its 2024 MOU.

It is further requested that provisional language be added as follows to conform to this action:

4. Of the funds appropriated in Schedule (1), up to \$650,000 is provided to support an audit of work performed by the California Association of Professional Scientists, Bargaining Unit 10. The Department of Finance may adjust this appropriation to ensure sufficient authority for the final audit contract. At that time, any unused funds shall be returned to the General Fund. The Director of Finance shall notify the Joint Legislative Budget Committee within 30 days of the adjustment.

**Statewide Recruitment, Outreach and Education Paid Media Campaign (AB 1511)**—It is requested that Item 7501-001-0001 be decreased by \$5,088,000 and 1 position in 2025-26, \$5,081,000 in 2026-27, 2027-28, and 2028-29, and \$81,000 ongoing, Item 7501-001-0821 be decreased by \$1,000 in 2025-26 and ongoing, Item 7501-001-0915 be decreased by \$11,000 in 2025-26 and ongoing, and Item 7501-001-0001 be decreased by \$67,000 in reimbursement authority in 2025-26 and ongoing. These requests propose adjustments to the Governor's Budget proposal which would have expanded CalHR's media outreach into ethnic and community media outlets in accordance with, Chapter 352, Statutes of 2024 (AB 1511).

**Learning Management System (LMS) Consolidation with CalHR and DGS**—It is requested that Item 7501-001-0001 be decreased by \$399,000 and 1 position in 2025-26 and \$392,000 ongoing. This request proposes adjustments to the Governor's Budget proposal which would consolidate three statewide training systems into one statewide LMS.

Amendment to Budget Bill Item 7502-001-0001, Support, California Department of Technology

The May Revision proposes adjustments to prior investments to assist in closing the projected shortfall. These adjustments include the following:

Office of Information Security's Advisory Services Program Virtual Chief Information Security Officer Service—It is requested that Item 7502-001-0001 be reduced by \$500,000 in fiscal year 2025-26, and ongoing, to remove the establishment of the Virtual Chief Information Security Officer Service originally proposed in the Governor's Budget.

Below are the remaining adjustments included in the May Revision:

California Compliance and Security Incident Reporting System—It is requested that Item 7502-001-0001 be increased by \$2,030,000 in 2025-26 and \$316,000 in 2026-27, and ongoing, to replace the sunsetting California Compliance and Security Incident Reporting System CDT uses for the state's data security.

**Mission Critical Collaborative Tools**—It is requested that Item 7502-001-0001 be increased by \$327,000 in 2025-26, and \$202,000 in 2026-27, and ongoing, to support increased demands for cloud-based collaboration and design tools used to support statewide technology initiatives, provide funding for a disaster response resource website, and provide ongoing integration for disaster relief with Digital Identification services.

**Accountability.ca.gov Transparency Initiative**—It is requested that Item 7502-001-0001 be increased by \$185,000 in 2025-26, and 2026-27, to support a digital transparency initiative designed to track and report local government performance on housing, homelessness, and behavioral health.

Amendment to Budget Bill Item 7920-011-0001, Support, California State Teachers' Retirement System

State Contributions to CalSTRS—It is requested that Item 7920-011-0001 be increased by \$7,184,000 ongoing, to reflect an increase in the state's contributions to the California State Teachers' Retirement System's (CalSTRS) Defined Benefit (DB) Program and Supplemental Benefit Maintenance Account (SBMA). The state's contributions to the DB Program and SBMA are calculated using creditable compensation provided by the Teachers' Retirement Board (Board) for the fiscal year immediately preceding June 30; the report is published annually by the Board by October 25, with a subsequent report due by April 15, displaying necessary revisions to creditable compensation. Based on the Board's April 11, 2025 creditable compensation report, the DB contribution will be increased by \$5,525,000 and the SBMA contribution will be increased by \$1,659,000, as compared to the Governor's Budget.

**Benefit Payment Revisions**—It is requested that Item 7920-011-0001 be increased by \$908,000 ongoing, to reflect the state's share of overpayments identified by the system to be paid on July 1, 2025, as required by Education Code Section 24616.2. Based on the overpayments identified by CalSTRS from the prior fiscal year, the state's share of costs for overpayments made as a result of errors by the system will be \$908,000, as compared to \$0 in the Governor's Budget.
