SB 113 (Committee on Budget and Fiscal Review)

As Amended August 29, 2026

Majority vote

SUMMARY

Amends the 2026 Budget Act to reflect changes needed to implement the 2026 August budget package.

Major Provisions

Health

- 1) Includes \$1 million for research to be conducted by the California Health and Human Services Agency in partnership with the University of California to identify changes in the insured and uninsured populations in California, health care utilization trends, and the impacts of the implementation of H.R. 1 on health care and nutrition programs.
- 2) Adjusts state operations and local assistance amounts for the Uncompensated Care Program and Abortion Practical Support Program and makes technical and clarifying changes related to implementation.
- 3) Includes \$15.5 million for the Department of Health Care Access and Information to support the production of low-cost options for epinephrine pens and tuberculosis-related drugs.
- 4) Includes \$2 million to support the CalRx program to enter into partnerships to offer glucagon-like peptide 1 (GLP-1) agonists, pursuant to Legislation.
- 5) Clarifies that \$15 million is to support training for promotoras and community health workers.
- 6) Includes \$10 million to support gender-affirming care services for children and youth to be implemented through the Department of Health Care Access and Information.
- 7) Clarifies that the Physician Access Workforce Program supports medical school loan repayments in San Luis Obispo, Monterey, Santa Cruz and San Benito.
- 8) Clarifies that the physician access study in San Luis Obispo County and the Central Coast region will assess the feasibility of the creation of a medical school or a physician education program in partnership with the UC and CSU systems, and that funding may be used for scoping and planning of medical school infrastructure and legal consultation.
- 9) Includes \$2 million to the University of the Pacific to support development of a new medical school.

- 10) Provides \$2 million for the San Francisco Campus for Jewish Living for building renovations and infrastructure upgrades.
- 11) Provides \$1 million for the City of Long Beach for the West Health Facility for facility, security and safety improvements.
- 12) Includes \$300,000 for contract resources to support the transition of Federally Qualified Health Centers (FQHCs) and Rural Health Centers (RHCs) reimbursement for state-only services from the Prospective Payment System (PPS) to non-PPS methodologies.
- 13) Shifts resources allocated to clear the Medi-Cal Home and Community Based Alternatives (HCBA) Waiver waitlist from local assistance to state operations, and makes technical changes to implementation.
- 14) Specifies the funding implementation of \$5 million to the allcove youth mental health centers.
- 15) Provides \$7.1 million to the Yurok Tribe of California for its allcove site.
- 16) Provides \$30 million to support repayment of federal funds claimed in relation to payments to a prohibited entity under the federal reconciliation bill HR1.
- 17) Includes \$6 million for the Westminster Free Clinic to support infrastructure development.
- 18) Includes \$3.5 million to support the San Gabriel Behavioral Health and Youth Wellness Center and the Healthcare Workforce Development and Simulation Training Center in Monterey Park.
- 19) Provides \$8 million for the Martin Luther King Jr. Community Hospital for operational support.
- 20) Provides \$1 million for Los Angeles County to support mobile clinics for respiratory illnesses.
- 21) Provides \$2 million for Santa Clara Valley Healthcare for equipment to expand behavioral health treatment modalities.
- 22) Includes \$500,000 is available to Luminarias Institute Inc. to support the Behavioral Health Capacity Preservation Program.
- 23) Includes \$2 million for Kern County to support the design, construction, staffing, and deployment of a purpose-built mobile dental unit with two dental chairs and on-board X-ray capability.
- 24) Includes \$88,000 is for Kern County to expand cancer prevention, early detection, screening, and patient navigation resources for residents of rural and disadvantaged communities who face barriers to accessing cancer prevention and care.

- 25) Provides \$325,000 is available to Watsonville Community Hospital to support hospital upgrades.
- 26) Provides \$1 million for the Loma Linda Children's Hospital for support of the Resiliency Institute for Childhood Adversity.
- 27) Includes \$1.3 million is available to Santa Barbara County to support a three-chair mobile dental vehicle to provide oral health services to county residents.
- 28) Provides \$1 million to Planned Parenthood California Central Coast to support postpartum programs in San Luis Obispo, Ventura, and Santa Barbara Counties.
- 29) Allocates \$300,000 is available to the United Way Capital Region to convert the Sierra Health Foundation's Alhambra Boulevard site into a permanent, trauma-informed center for the Sacramento region.
- 30) Allocates \$500,000 to extend the current contract between the Department of Health Care Services and Shatterproof to support the Atlas treatment platform.
- 31) Reappropriates \$1.4 million for the Naloxone Distribution Project.
- 32) Includes \$7 million for the Governor's Advisory Council for Physical Fitness and Well-Being, of which \$2 million is to expand training opportunities for coaches of youth sports. Includes technical implementation provisions.
- 33) Makes technical adjustments to the implementation of the Youth Sports for All Act.
- 34) Provides \$5 million for the Public Health Network Information Exchange to advance public-benefit health innovation.
- 35) Provides \$3 million to the California Department of Public Health to improve women's health outcomes across reproductive health, maternal health, menopause, behavioral health, heart health, and chronic conditions.
- 36) Includes \$150,000 to the Delano Mosquito Abatement District for renovation and modernization of its regional public health laboratory to improve laboratory safety and expand surveillance, early detection, and response capabilities for vector-borne and zoonotic disease threats.
- 37) Provides \$3 million to the Los Angeles County Department of Public Health for environmental recovery.

Human Services

- 38) Includes provisional language providing for the use of \$2.4 million that was included in the June Budget for the State Council on Developmental Disabilities to create a Special Education Parent Action Network to provide parent leaders, pupil advocates, and other stakeholders with information and tools to effectively advocate on behalf of students in special education.

- 39) Provides authority for the Department of Finance to increase the amount of the appropriation for state operations for the Department of Community Services and Development (CSD) up to \$5 million to cover employee compensation costs not covered under the department's annual federal awards.
- 40) Provides \$9,229,000 for the Farmworker Housing Component of the Low-Income Weatherization Program, administered by CSD, from the Safe Drinking Water, Wildfire Prevention, Drought Preparedness, and Clean Air Fund. Provides for contract and bidding exemptions to facilitate the use of these funds, as there has been one vendor, the current vendor, who has been the recipient of past funds, and without the exemptions, the department would have to undergo a procurement process that would utilize resources that could be used for direct services.
- 41) Moves \$710,000 that had been allocated in the June Budget on a one-time basis for Meals on Wheels San Diego County from the Department of Social Services (DSS) to the California Department of Aging (CDA).
- 42) Includes an additional \$66 million for the Department of Rehabilitation (DOR) to meet caseload demand for the Vocational Rehabilitation (VR) program in the current fiscal year. DOR recently received federal approval, which had been delayed, to implement the "order of selection" process, which is the federally mandated process VR agencies must implement when they do not have sufficient resources to serve the caseload. Due to the delay in federal approval, the \$66 million is necessary to address cashflow needs.
- 43) Approves the movement of language from incorrect items to other items regarding the five percent of funding for Housing and Homelessness Programs administered by DSS for administrative costs for these programs, including, but not limited to, the technical assistance and outcomes tracking activities.
- 44) Moves the \$10 million augmentation that included in the June Budget for the CalWORKs Housing Support Program to the appropriate budget item.
- 45) Provides for increased funding for automation for DSS to comply with federal law changes related to the CalFresh Elderly Simplified Application Project (ESAP) population redefinition and for the Trafficking and Crime Victim Assistance Program (TCVAP) eligibility extension.
- 46) Cleans up provisional language for the Tribal Foster Care Prevention Initiative.
- 47) Includes reappropriation authority for the Stop The Hate 2023 appropriation, to allow for the full utilization of the remaining available funds by June 30, 2027.
- 48) Removes the general appropriation of \$10,000,000 for Immigration Regional Capacity-Building and replaces this with specified appropriations for the next seven items, which add to the prior \$10,000,000.
- 49) Includes \$2,000,000 for Catholic Charities Diocese of Monterey for immigrant support services.

- 50) Includes \$500,000 for Services, Immigrant Rights & Education Network (SIREN) Immigration Services.
- 51) Includes \$3,000,000 for Inland Coalition for Immigrant Justice (IC4IJ).
- 52) Includes \$1,000,000 for Catholic Charities of San Diego.
- 53) Includes \$500,000 for California Rural Legal Assistance Foundation.
- 54) Includes \$2,000,000 for Coalition for Humane Immigrant Rights (CHIRLA) to expand its immigration legal services in the San Fernando Valley.
- 55) Adds \$1,000,000 to the prior \$2,000,000 for Centro La Familia for immigrant support services.
- 56) Removes \$6,000,000 for the Center Against Racism and Trauma (CART).
- 57) Specifies that \$1,330,000 that was appropriated in the June Budget is for the Jacobs and Cushman San Diego Food Bank.
- 58) Includes \$250,000 for the Delano Senior Nutrition Program to provide nutritious meals, nutrition education, and essential support services to seniors throughout the Delano community.
- 59) Includes \$1,000,000 for the San Diego No-Cost Senior Transportation Program, which provides a monthly ride allocation that allows low-income older adults to maintain their health, independence, and well-being.
- 60) Includes \$1,000,000 for the City of Long Beach to provide people with disabilities access to adaptive technology and digital skills training.
- 61) Includes \$2,000,000 for the Crowell Family YMCA in South Pasadena, to support the renovation of the facility, including repairs and upgrades, to expand accessibility and improve gathering space.
- 62) Includes \$3,000,000 for the California Food Bank Delivery Alliance, which includes Second Harvest Food Bank Santa Cruz, Second Harvest of Silicon Valley, The Foodbank of Santa Barbara County, Emergency Food Bank of Stockton/San Joaquin, and the Los Angeles Regional Food Bank, to support effective home food delivery models to reach residents who cannot reliably access traditional food distribution sites.
- 63) Includes \$1,500,000 for the Promise Neighborhood initiative.
- 64) Includes \$3,000,000 for the Crenshaw Family YMCA to support a comprehensive capital improvement project to modernize an aging facility and close a longstanding equity gap in access to health and wellness infrastructure in the Crenshaw corridor.
- 65) Includes \$2,500,000 for Our Big Kitchen LA (OBKLA).
- 66) Includes \$1,855,000 for the SOVA Community Food and Resource Program.

- 67) Includes \$2,500,000 for the Mid Valley YMCA.
- 68) Includes \$4,500,000 for the YMCA of Metropolitan Los Angeles to sustain and expand critical community safety-net services, including food assistance and youth support programs, across Los Angeles County. These funds are not available for expenditure or encumbrance until January 1, 2027.
- 69) Includes \$1,000,000 for the Mission Neighborhood Center (MNC) for facility acquisitions, improvements, expansion, and operations.
- 70) Includes \$1,000,000 for the Simi Valley YMCA to support facility expansion.
- 71) Includes \$2,000,000 for the Lowe Family YMCA.
- 72) Includes \$2,000,000 for the Boys & Girls Clubs of Metro Los Angeles' programs in the City of Inglewood.
- 73) Includes \$1,500,000 for the Kolar Family YMCA, located in Downey, to support facility expansion and improvement.
- 74) Includes \$5,000,000 for the Family Assistance Program in San Bernardino County to support a one-time capital allocation to renovate existing homes and build new housing.
- 75) Includes \$1,500,000 for the Fresno Economic Opportunities Commission (EOC) Food Distribution Program to support food distribution efforts and senior meals in rural communities.
- 76) Includes \$2,000,000 for Big Brothers Big Sisters Orange County.
- 77) Includes an augmentation of \$4,000,000 for the Refugee Programs Bureau, increasing the appropriation from \$35,500,000 to \$39,500,000.
- 78) Includes \$15,000,000 to support additional sexual assault prevention practices, contingent upon the future enactment of budget legislation detailing the use of these funds.
- 79) Includes \$200,000 for the Family Rescue Center for facilities expansion and improvement.
- 80) Includes \$3,600,000 for the California Parent & Youth Helpline, operated by Parents Anonymous.
- 81) Includes \$88,000 for Laura's House in the city of Aliso Viejo for transportation services for survivors of domestic violence.
- 82) Includes \$750,000 for Ashes to Beauty for outreach and assistance to immigrant families.

- 83) Includes \$750,000 for the Immigrant Action Network to expand the community defense program serving immigrants at the Concord Immigration Court through the SAFE Center.
- 84) Includes \$750,000 for Families Empowered and Transformed (F.E.A.T) to support community-based services for families, including parenting programming, supportive father involvement, anger management and domestic violence classes, and teen mentoring.
- 85) Includes \$550,000 for Community Bridges for the acquisition of a production kitchen that supports Meals on Wheels operations throughout Santa Cruz County.
- 86) Includes \$600,000 for the Food for Thought Food Bank to expand kitchen facilities.
- 87) Includes \$576,000 for the San Bernardino Community Service Center for immigrant legal services, community outreach, and education.
- 88) Includes \$750,000 for the Family Assistance Program of San Bernardino County to expand crisis intervention and stabilization services to homeless minors and transition age youth in San Bernardino County.
- 89) Includes \$1,000,000 for the Orangewood Foundation for the Youth Emergency Services & Homeless Youth Emergency Services Pilot program.
- 90) Includes \$1,000,000 for the United Across Borders Foundation to expand capacity for food distribution.
- 91) Includes \$1,000,000 for the City of Fremont to transition to a year-round emergency shelter program.
- 92) Includes \$1,000,000 for the Mission Economic Development Agency to provide cradle-to-career services.
- 93) Includes \$500,000 for the Mission Neighborhood Center, Inc. for capital projects to expand family and early care services.
- 94) Includes \$68,000 for Many Mansions in Ventura County for resident assistance funds.
- 95) Includes \$200,000 for the Skye's The Limit Institute of Wellness to support community-based services for residents in Kern County.
- 96) Includes \$47,000 for the Home on the Green Pastures in the city of Tustin for services for survivors of domestic violence.
- 97) Includes an additional \$500,000 for Feeding San Diego to expand service operations in San Diego County.
- 98) Clarifies that \$10,000,000 appropriated in the June Budget is for the Mixteco/Indigena Community Organization Project (MICOP) as lead administrator for the Southern Central Coast Regional Network Hub for Immigrant Families.

- 99) Includes an additional \$10,000,000 for the CalFood program, which brings the total General Fund for CalFood in the 2026-27 Budget to \$118,000,000.
- 100) Includes \$1,100,000 for Fostering the Future Accounts for foster youth.
- 101) Includes \$1,600,000 for Compass Family Services.
- 102) Includes \$1,000,000 for the Saint John's Program for Real Change.
- 103) Includes \$2,000,000 for the Potrero Hill Neighborhood House.
- 104) Includes \$550,000 for West Marin Community Services.

Economic Development

- 105) Includes \$30 million for California's leadership in quantum technologies and deep space research.
- 106) Provides \$2.5 million to the City of Oakland for the Façade and Tenant Improvement Grant Program.
- 107) Appropriates \$1.5 million to the Inland Empire Community Foundation to support the region of Riverside and San Bernardino County through grantmaking research, and narrative to change through the Cielo Fund.
- 108) Includes \$1.25 million for Southeast Los Angeles (SELA) Collaborative to support economic development initiatives, small business assistance, and grants, nonprofit capacity building, and other programs to strengthen the Southeast Los Angeles region.
- 109) Provides \$2 million in one-time General Fund to The Nonprofit Partnership - Long Beach to support nonprofit capacity-building through training, technical assistance, leadership development, organizational support, and grant funding for nonprofits serving Long Beach and Lakewood.
- 110) Provides \$2 million in one-time General Fund to Contra Costa County for the Green Empowerment Zone to support the region's concentration of highly skilled energy industry workers by prioritizing access to tax incentives, grants, loan programs, workforce training programs, and private-sector investment in the renewable energy sector.
- 111) Includes \$100,000 to the Kern County Office of Veterans' Services for grants to support veteran business and veteran entrepreneurs.
- 112) Provides \$750,000 to Kern County for improvements at Meadows Field Airport to expand and modernize the airport.
- 113) Appropriates \$125,000 to the City of Delano for improvements at Delano Municipal Airport to expand and modernize.

- 114) Provides \$300,000 to the Community Foundation for San Benito County for a grant writer to build countywide funding pipeline.
- 115) Provides \$900,000 to Visit California for enhanced marketing of California's wine industry.
- 116) Includes \$500,000 to the Pasadena Tournament of Roses Association for public safety, security, and operational costs with the Rose Parade and Rose Bowl Game.
- 117) Provides \$500,000 to the Redland Chamber of Commerce for development and construction of the "Welcome to Redlands" signs initiative.
- 118) Provides \$100,000 to the Antelope Valley Economic Development & Growth Enterprise for job creation focused on manufacturing, logistics, aerospace, and clean energy.
- 119) Appropriates \$100,000 to the Antelope Valle Chamber of Commerce for its Small Business Acceleration & Economic Growth program.
- 120) Includes \$150,000 to the San Bernardino County Fire District Division 5 North Desert to replace the aging Fire Station 305 HVAC system.
- 121) Provides \$4.2 million in one-time General Fund to the San Gabriel Valley Council of Governments for regional projects that strengthen economic development, expand educational opportunities, enhance public safety, and preserve and improve parks and open space throughout the San Gabriel Valley.
- 122) Provides \$3 million in one-time General Fund to the Los Angeles Cleantech Incubator to support California-based climate-technology companies in commercializing and deploying solutions through pilots, market access, workforce development, business support, and access to capital.
- 123) Provides \$3 million in one-time General Fund to the Governor's Office of Business and Economic Development for ethnic media outreach grants.
- 124) Provides \$3 million in one-time General Fund to the Governor's Office of Business for public media stabilization grants.
- 125) Includes \$1.8 million to Further Triennial to animate the cultural history and celebrate the creative present of Northern California through exhibitions, public programs, and educational initiatives.
- 126) Provides \$60,000 to the Chinatown History and Culture Association for wayfinding signs in the City and County of San Francisco.
- 127) Provides \$500,000 for support costs to administer the funding appropriated for Go-Biz.

Housing and Homelessness

- 128) Transfers administration of \$200 million in Multifamily Housing Program (MHP) funding from the Housing and Community Development Department (HCD) to the Housing Development and Finance Committee (HDFC).
- 129) Reduces the appropriation to Round 7 Homeless Housing, Assistance, and Prevention (HHAP) program by \$10 million, leaving the total Round 7 HHAP appropriation at \$890 million.
- 130) Includes \$1 million for the preservation of housing in South San Francisco to support the acquisition, preservation, and/or rehabilitation of Single Room Occupancy properties and prevent the displacement of lower-income residents.
- 131) Provides \$1.4 million for Larkin Street Youth Services to support housing, healthcare, food assistance, and safety net services for homeless and at risk youth; and to support the acquisition and rehabilitation of transitional housing youth beds in San Francisco.
- 132) Appropriates \$2 million for Sacramento Tiny Homes to address homelessness in Sacramento.
- 133) Includes \$3 million for San Francisco Safe House to support permanent housing.
- 134) Provides \$17 million for regional housing finance authorities in San Diego, Bay Area and Los Angeles.
- 135) Includes \$100,000 for Contra Costa County to support the Casita Project, a farmworker pilot project by Hijas Del Campo.
- 136) Provides \$ 1 million to the City of Santa Clara for the Santa Clara Family Community Benton Lawrence Homekey interim housing project.
- 137) Includes \$1 million to the City of Orange for HUB Resource Center operating expenditures.
- 138) Provides \$5 million in one-time General Fund to the Downtown Revitalization Core in Sacramento for a high-density housing and grocery project in a food desert.
- 139) Includes \$1.75 million for the Latino Community Foundation Community Resilience Initiative for economic opportunity, housing preservation and critical infrastructure improvements for Latino farmworkers.
- 140) Provides \$2 million in one-time General Fund to the City of Vista to fund an additional year of interim and transitional housing through the Buena Creek Navigation Center.
- 141) Provides \$3 million in one-time General Fund to the City of Oceanside for capital and hard costs associated with an interim housing project on city-owned land for the purpose of addressing street homelessness.

- 142) Includes \$1 million for the Amigos de Guadalupe to support the Mayfair Family Housing Preservation and Affordable Housing Development.
- 143) Provides \$2 million in one-time General Fund to the City of Pittsburg to facilitate and scale the construction of affordable housing units for families in the East Bay in coordination with the Yellow Roof Foundation.
- 144) Provides \$2 million to the California Farmworker Foundation to develop its Resource Center providing healthcare, mental health, dental, and vision services; workforce development and technical training; legal and immigration assistance; benefits enrollment; after-school and senior programs; and food pantry and financial literacy services in the City of Delano.
- 145) Appropriates \$1.26 million for the City of Santa Cruz to support the acquisition of land and the construction of an affordable housing project near the intersection of Highway 1 and Highway 9.
- 146) Includes \$350,000 for Abbey Road to support the renovation of apartments for transitional age youth North Hills.
- 147) Provides \$15 million in one-time General Fund to the California Community Foundation to administer the Community Aid for Rebuilding and Equity (CARE) Fund and establish a dedicated Disaster Recovery and Anti-Displacement Implementation Fund for administering CARE activities related to homeowner rebuilding gap financing, community land banking and acquisition activities, nonprofit and Community Land Trust partnerships, and survivor oversight coordination.
- 148) \$500,000 for Open Arms Temporary Living for rehabilitation of a Community Support Center in Los Angeles.
- 149) \$500,000 for the Los Angeles Black Worker Center to complete the community engagement process for the redevelopment in Los Angeles.
- 150) Provides \$2 million in one-time General Fund to the Coalition for Responsible Community Development to cover construction cost increases at the 803 E. 5th Street affordable housing development in Los Angeles.
- 151) Provides \$2 million in one-time General Fund to the City of Fremont to transition to a year-round emergency shelter program.
- 152) Provides \$3 million in one-time General Fund to the City of Newark for an Affordable Housing for Families (SAHA) project to provide critically needed homes to extremely low-, very low-, and low-income households and to support first time homebuyer program.
- 153) Includes \$1 million for the Urban League of San Diego County to strengthen and expand the Housing Financial Assistance Program.

- 154) Provides \$6 million in one-time General Fund to the City of Santa Barbara for acquisition and rehabilitation of the historic Casa de la Raza building.
- 155) Includes \$500,000 for Ventura County to invest in interim housing at the county-owned building in Ventura.
- 156) Appropriates \$1 million for Whiskeytown Environmental School Community for support of housing and science programs.
- 157) Includes \$166,000 for El Camino Homeless Organization for the construction of a permanent dining structure and kitchen for individuals experiencing homelessness in Paso Robles.
- 158) Appropriates \$2 million for the Bolinas Community Land Trust to support affordable housing
- 159) Includes \$1.3 million for Project Homeless Connect to support the Everyday Connect program and Semi-Annual Community Day of Service.
- 160) Provides \$5 million to WalkGood Inc. to advance community healing, resident services and neighborhood investment through the Nathaniel for a proposed housing development.
- 161) Includes \$3 million for Freedom West Homes Corporation to support the Freedom West 2.0 revitalization project.
- 162) Provides \$750,000 for the City of Oakland to support the Holland transitional housing facility.
- 163) Appropriates \$1 million to support costs to administer the funding appropriated for HCD.

State Treasurer

- 164) Reverts \$1 million for the Blue Ribbon Commission on the Development of a California Department of Youth Sports.

Franchise Tax Board

- 165) Allow for continuation of the limited liability corporation tax reduction

Secretary of Government Operations

- 166) Allocates \$6,500,000 one-time in General fund for the California Black Women's Collective Empowerment Institute.
- 167) Allocates \$6,000,000 one-time in General fund for the Inland Empire Community Foundation for the Mobilizing and Edifying for Collective Community Advancement Inland Empire fund for infrastructure Building.

Department of Consumer Affairs

- 168) Allocates \$1,800,000 one-time in General fund agencies for costs associated with the maintenance and upkeep of the Mt. Tamalpais Mortuary and Cemetery, located in the County of Marin.
- 169) Allocates \$3,000,000 one-time in General Fund for the Lincoln Memorial Park Cemetery located in the City of Carson.
- 170) Allocates \$1,000,000 one-time in General Fund for the Mixed Martial Arts Retirement Benefit Fund,

DGS

- 171) Allocates \$3,000,000 one-time in General Fund for STEM Teachers Program at EnCorps., Inc.
- 172) Appropriated \$4,000,000 one-time in General Fund for capitol outlay and improvements to the Governor's Mansion in Sacramento.

Office of Data and Innovation

- 173) Allocates \$5,000,000 one-time in General Fund for Engaged California.

GoServe

- 174) Allocates \$1,500,000 one-time in General Fund for Big Brothers and Sisters of Greater LA.
- 175) Allocates \$2,000,000 one-time in General Fund for Improve Your Tomorrow facility and infrastructure improvements and operations and service expansion.

California Arts Council

- 176) Allocates \$4,000,000 one-time in General Fund to support for the cultural districts program at the California Arts Council

COMMENTS

This bill amends the 2026 budget act to reflect an August budget package. The June 2026 Budget Agreement deferred action on a number of budget items until the end of session, to allow greater focus and extended discussion. Primarily, this followed a recent trend of deferring climate investment conversations until after the budget, with the Proposition 4 Climate Bond and most of the Greenhouse Gas Reduction Fund allocations from the Legislature being made in this August bill instead of the June package. Additionally, approximately \$1 billion of General Fund spending assumed in the June package was also deferred to August and is appropriated in this bill. However, that spending was accounted for in the reserve and expenditure estimate of the June package but not yet detailed in the budget itself.

This bill does include some additional costs, estimated to be less than \$80 million total, reflecting unanticipated expenses for the State that were not included in the June budget. The largest of these unexpected items is a one-time \$66 million General Fund backfill to federal funds that were anticipated to be received by the Department of Rehabilitation for support for disabled workers but are now no longer expected to be received by the State.

This bill, and its corresponding budget trailer bills, also make technical changes, corrections, and clarifications to the June budget package.

FISCAL COMMENTS

This bill identifies specific spending priorities that were budgeted in the June budget agreement but not appropriated at that time. The bill increased General Fund expenditures by under \$100 million above the June agreement to account for the unexpected loss of federal funds at the Department of Rehabilitation and other adjustments. This bill also appropriates \$2.66 billion in funds from the Safe Drinking Water, Wildfire Prevention, Drought Preparedness, and Clean Air Bond Act of 2024 (Proposition 4) and appropriates \$450 million in Greenhouse Gas Reduction Fund.
