<p>ISSUE 1</p>	<p>LABOR ENFORCEMENT PROPOSALS</p> <p>ACTION: APPROVE STAFF RECOMMENDATION</p> <hr/> <p>Staff Recommendations: 1. Approve the BCP to eliminate the sunset dates and increase the annual revenue caps on the OSH Fund and LECF and include supplemental reporting language directing DIR to meet with stakeholders on a quarterly basis to discuss the uses and outcomes of the two funds, and to report to the Subcommittee next year on the progress of creating more transparency for these funds and the efficacy of the stakeholder meetings.</p> <p>2. Approve the BCP to stabilize and streamline funding for the Compliance Monitoring Unit.</p> <p>3. Eliminate the TICF assessment on high hazard employers and shift the assessment to the OSH Fund.
