Issue	Description
Issue 1: Healthy California for All Commission	

Governor proposed reversion of General Fund expenditure authority of \$5 million approved in the 2018 Budget Act for the Council on Health Care Delivery Systems. Proposed a new General Fund appropriation of \$5 million and trailer bill language to rename the council the Healthy California for All Commission and adjust its responsibilities to evaluate options to transition to a single-payer health care financing system.

Senate approved the reversion and new appropriation and adopted placeholder trailer bill language, consistent with the Governor's proposal.

Assembly took no action.

Conference issue is the \$5 million reversion, new appropriation of \$5 million, and trailer bill language for the Healthy California for All Commission.

Issue 2: Office of Healthy and Safe Communities	

Governor had no proposal.

Senate took no action.

Assembly approved General Fund expenditure authority of \$6 million to establish the Office of Healthy and Safe Communities under the direction of the Surgeon General.

Conference issue is General Fund expenditure authority of \$6 million and establishment of the Office of Healthy and Safe Communities under the direction of the Surgeon General.

Issue 3: State of the State's Public Health	

Governor had no proposal.

Senate took no action.

Assembly approved two positions and General Fund expenditure authority of \$318,000 for the Surgeon General to annually report public health data to the Legislature that describes the state of the state's public health.

Conference issue is two positions and General Fund expenditure authority of \$318,000 for the Surgeon General to annually report public health data to the Legislature that describes the state of the state's public health.

Issue	Description
Issue 4: Mental Health Workforce Development	

Governor proposed one-time General Fund expenditure authority of \$50 million, available until June 30, 2025, to support mental health workforce development through existing loan repayment and scholarship programs administered by the Office of Statewide Health Planning and Development.

Senate adopted the Governor's proposal, but allocated \$1 million to provide loan repayments for former foster youth serving as mental health providers in public facilities or provider shortage areas. Approved \$2.7 million of Mental Health Services Act (MHSA) funds for psychiatry fellowships.

Assembly adopted the Governor's proposal, but set aside \$750,000 to provide loan repayments for former foster youth and \$2.7 million to fund psychiatry fellowships.

Conference issues are 1) the amount of expenditure authority set aside for former foster youth serving as mental health providers (\$750,000 or \$1 million), and 2) the funding source for psychiatry fellowships (General Fund or MHSA funds).

Governor had no proposal.

Senate took no action.

Assembly adopted placeholder trailer bill language to restore access to Public Use Files, consistent with past practice.

Conference issue is restoration of access to Public Use Files, consistent with past practice.

Issue	Description
Issue 6: Reversion – All Payer Claims Database Excess Funding	

Governor had no proposal.

Senate reverted \$50 million of the \$60 million General Fund appropriation in the 2018 Budget Act allocated to implement an all payer claims database.

Assembly took no action.

Conference issues is reversion of \$50 million General Fund.

Issue 7: Managed Care Organization (MCO) Enrollment Tax	

Governor had no proposal.

Senate approved total General Fund savings of \$1.4 billion in 2019-20, and \$1.8 billion in 2020-21 and 2021-22, and adopted placeholder trailer bill language to extend the MCO enrollment tax. The 2019-20 savings assumes a three-month lag in tax collections.

Assembly approved total General Fund savings of \$858 million in 2019-20, and \$1.8 billion in 2020-21 and 2021-22, and adopted placeholder trailer bill language to extend the MCO enrollment tax. The 2019-20 savings assumes a six-month lag in tax collections.

Conference issue is total General Fund savings in 2019-20 (\$1.4 billion or \$858 million) based on whether the assumed lag in tax collections should be three months or six months.

Issue 8: Full-Scope Medi-Cal for Undocumented Adults	

Governor proposed:

- 1) \$98 million (\$74.3 million General Fund) for expansion of full-scope Medi-Cal coverage for young adults age 19-25, regardless of immigration status.
- 2) Trailer bill language to implement coverage expansion January 1, 2020, and withhold 100 percent of 1991 Realignment revenue from County Medical Services Program (CMSP) counties until the CMSP reserve is reduced to the equivalent of two years of expenditures. After the CMSP reserve reaches this level, the state would redirect 75 percent of realignment revenue ongoing.

Senate:

- 1) Approved \$98 million (\$74.3 million General Fund) for expansion to young adults ages 19-25, regardless of immigration status.
- 2) Approved \$62.5 million (\$49.6 million General Fund) for expansion to seniors, regardless of immigration status.
- 3) Adopted placeholder trailer bill language to implement the expansion to both populations, provide for the Governor's proposed withholding of 1991 Realignment revenue, and increase eligibility regardless of immigration status by one year of age each calendar year, beginning with eligibility for individuals age 26 in January 2021.

Assembly:

- 1) Approved \$98 million (\$74.3 million General Fund) for expansion to young adults ages 19-25, regardless of immigration status.
- 2) Adopted placeholder trailer bill language to implement expansion to young adults and provide for the Governor's proposed withholding of 1991 Realignment revenue, but increasing the funding CMSP receives, above the Governor's proposal, after it reaches the required reserve level.

Conference issues are:

- 1) Expansion of eligibility for full-scope Medi-Cal coverage to income-eligible seniors regardless of immigration status.
- 2) Percent redirection of realignment revenues (75 percent or 60 percent) from CMSP counties after reserves reach the required threshold.
- 3) Expansion of eligibility regardless of immigration status by one year of age each calendar year.

Issue 9: Proposition (Prop) 56 Supplemental Provider Rates	

Governor proposed \$2.2 billion (\$769.5 million Prop 56) for supplemental rate increases for physicians, dentists, women's health, intermediate care facilities-developmental disabilities (ICF-DDs), HIV/AIDS Waiver providers, and home health providers; \$500 million (\$50 million Prop 56) for family planning services in Medi-Cal; and to sunset all Prop 56 investments on December 31, 2021.

Senate approved funding for supplemental provider rate increases and family planning and adopted placeholder trailer bill language to direct family planning funding for specific purposes, require DHCS to seek three-year federal approval for supplemental rate increases, and eliminate the statutory cap for reimbursement of clinical labs. Rejected the Governor's proposed sunset of Prop 56 investments.

Assembly:

- 1) Approved funding for supplemental provider rate increases and family planning and adopted placeholder trailer bill language to direct family planning funding for specific purposes, require DHCS to seek three-year federal approval for supplemental rate increases and collect unspent Prop 56 funds from managed care plans, and eliminate statutory cap for clinical labs and durable medical equipment.
- 2) Approved \$80 million Prop 56 to increase rates for ICF-DDs, pediatric subacute facilities, CBAS, non-emergency medical transportation, hospital-based pediatric physician services, and eliminated statutory cap for clinical labs and durable medical equipment.

Conference issues are:

- 1) \$80 million Prop 56 to increase rates for ICF-DDs, pediatric subacute facilities, CBAS, non-emergency medical transportation, hospital-based pediatric services, and eliminate statutory cap for clinical laboratories and durable medical equipment.
- 2) Trailer bill language to require DHCS to collect technically unspent Prop 56 funds from managed care plans.
- 3) Sunset of Prop 56 investments on December 31, 2021.

Issue 10: Proposition 56 One-Time Investments	

Governor proposed:

- 1) \$544.2 million (\$250 million Prop 56) for a Value-Based Payments program.
- 2) \$105 million (\$52.5 million Prop 56) for developmental and trauma screenings.
- 3) \$50 million (\$25 million Prop 56) for provider training to deliver trauma screenings.
- 4) \$120 million Prop 56 funds for additional awards in the Physicians and Dentists Loan Repayment Program through CalHealthCares.

Senate:

- 1) Approved funding for the Value-Based Payments program, developmental and trauma screenings, provider training, and loan repayment.
- 2) Adopted placeholder trailer bill language to implement the Value-Based Payments program.

Assembly:

- 1) Reduced Value-Based Payments funding to \$170 million Prop 56, approved funding for developmental and trauma screenings, provider training, and loan repayment.
- 2) Adopted placeholder trailer bill language to implement the Value-Based Payments program, allowing federally qualified health centers (FQHCs) to participate.

Conference issues are:

- 1) Funding level for Value-Based Payments program (\$250 million or \$170 million)
- 2) Trailer bill language to allow FQHCs to participate in the Value-Based Payments program.

Issue 11: Restoration of Medi-Cal Optional Benefits	

Governor proposed \$33.4 million (\$11.3 million Prop 56) to restore optical benefits in Medi-Cal beginning January 1, 2020.

Senate:

- 1) Approved \$33.4 million (\$11.3 million Prop 56) to restore optical benefits in Medi-Cal beginning January 1, 2020.
- 2) Approved \$21.1 million (\$6.1 million General Fund) and adopted placeholder trailer bill language to restore the following Medi-Cal benefits beginning January 1, 2020: audiology, incontinence creams/washes, podiatry, and speech therapy.

Assembly:

- 1) Rejected Governor's proposed restoration of optical benefits in Medi-Cal with Prop 56 funds.
- 2) Approved \$38.9 million (\$18 million General Fund) and adopted placeholder trailer bill language to restore the following Medi-Cal benefits beginning January 1, 2020: audiology, chiropractic, incontinence creams/washes, optical, podiatry, and speech therapy.

Conference issues are:

- 1) Funding source for restoration of optical benefits in Medi-Cal (Prop 56 or General Fund).
- 2) List of additional benefits proposed for restoration.

Issue 12: Whole Person Care Housing Services	

Governor proposed \$100 million General Fund in 2019-20 to provide funding for supportive housing services in Whole Person Care pilot counties.

Senate approved Governor's requested funding for supportive housing services.

Assembly approved Governor's requested funding for supportive housing services and adopted placeholder trailer bill to require the department to work with counties on the allocation methodology, target the funds, and ensure flexibility.

Conference issue is trailer bill language to require the department to work with counties on the allocation methodology, to target the funds, and to ensure flexibility.

Issue 13: Non-Whole Person Care Counties Funding	

Governor proposed \$20 million Mental Health Services Fund in 2019-20 for counties without Whole Person Care pilots to develop and implement programs to focus on coordinating health, behavioral health, and social services for individuals with mental illness and who are homeless, or at risk for homelessness.

Senate approved Governor's requested funding from the Mental Health Services Fund.

Assembly approved Governor's requested funding, but from the General Fund, rather than Mental Health Services Fund.

Conference issue is the funding source (General Fund or Mental Health Services Fund) for counties without Whole Person Care pilots to develop and implement programs to focus on coordinating health, behavioral health, and social services for individuals with mental illness and who are homeless, or at risk for homelessness.

Issue	Description
Issue 14: Strengthening Fiscal Estimates & Cash Flow Monitoring	

Governor requested 25 positions and expenditure authority of \$3.8 million (\$1.8 million General Fund and \$2 million federal funds) in 2019-20 and \$3.6 million (\$1.7 million General Fund and \$1.9 million federal funds) annually thereafter for the Department of Health Care Services (DHCS) to improve the accuracy of the Medi-Cal and Family Health Local Assistance Estimates and provide additional oversight and monitoring of the department's cash flow.

Senate approved the Governor's proposal as budgeted and adopt placeholder trailer bill language to: 1) provide regular updates on actual cash flows compared to estimates, 2) present to the Legislature a long-term plan for administrative changes to promote sound estimates and budget transparency, and 3) initiate a stakeholder process with legislative staff and the Legislative Analyst's Office (LAO) to identify possibilities for future changes.

Assembly Denied the Governor's request.

Conference issues are:

- 1) Resources for DHCS to improve the accuracy of its local assistance estimates
- 2) Trailer bill language requiring more transparency on cash flows and directing DHCS to work with the Legislature and LAO to improve its budgeting processes.

Issue 15: Managed Care Sanctions Trailer Bill Language	

Governor proposed trailer bill language to clarify the Department of Health Care Services' (DHCS) authority to impose sanctions on managed care plans, mental health plans, and substance use disorder plans.

Senate adopted placeholder trailer bill language, consistent with the Governor's description of the pending trailer bill language.

Assembly rejected the Governor's proposal without prejudice, as the language was unavailable.

Conference issue is trailer bill language to clarify DHCS' authority to impose sanctions on managed care plans, mental health plans, and substance use disorder plans.

Issue 16: Assisted Living Waiver Expansion	

Governor had no proposal.

Senate approved savings of \$47.1 million (\$23.6 million General Fund) in 2019-20, growing to \$304.1 million (\$152 million General Fund) by 2023-24, and adopted placeholder trailer bill language to phase-in an additional 10,756 slots in the Assisted Living Waiver program by March 1, 2023.

Assembly took no action.

Conference issue is expansion of slots in the Assisted Living Waiver and associated savings.

Issue 17: Expand SBIRT to Opioids and Other Drugs	

Governor had no proposal.

Senate approved \$8.4 million (\$2.6 million General Fund) and adopt placeholder trailer bill language to expand the Medi-Cal benefit for screening, brief intervention, referral, and treatment (SBIRT) to include screening for the overuse of opioids and illicit drugs.

Assembly took no action.

Conference issue is the funding and trailer bill language to expand the Medi-Cal benefit for SBIRT to include screening for the overuse of opioids and illicit drugs.

Issue 18: Substance Use Counselors in Emergency Departments	

Governor had no proposal.

Senate approved \$10 million General Fund ongoing to support the hiring of trained substance use disorder peer navigators and behavioral health peer navigators in emergency departments of acute care hospitals.

Assembly approved \$20 million General Fund one-time to support the hiring of trained substance use disorder peer navigators and behavioral health peer navigators in emergency departments of acute care hospitals.

Conference issue is the funding level (\$10 million or \$20 million) and length of time for funding (ongoing or one-time) to support the hiring of trained substance use disorder peer navigators and behavioral health peer navigators in emergency departments of acute care hospitals.

Governor had no proposal.

Senate approved \$8.6 million General Fund to support extension of Medi-Cal eligibility from 60 days to one year for post-partum women diagnosed with a mental health disorder.

Assembly took no action.

Conference issue is funding to support extension of Medi-Cal eligibility from 60 days to one year for post-partum women diagnosed with a mental health disorder.

Governor had no proposal.

Senate adopted placeholder trailer bill language to explicitly define Children's Crisis Residential Programs as Psychiatric Residential Treatment Facilities for the purposes of reimbursement.

Assembly took no action.

Conference issue is trailer bill language to explicitly define Children's Crisis Residential Programs as Psychiatric Residential Treatment Facilities for the purposes of reimbursement.

Governor had no proposal.

Senate took no action.

Assembly approved \$60 million (\$30 million General Fund) one-time and adopted placeholder trailer bill language to support health enrollment navigators for two years to provide outreach, enrollment, retention, and utilization assistance in Medi-Cal.

Conference issue is funding and trailer bill language to support health enrollment navigators for two years to provide outreach, enrollment, retention, and utilization assistance in Medi-Cal.

Governor had no proposal.

Senate took no action.

Assembly approved \$14.3 million General Fund in 2019-20 and \$19.1 million ongoing, offset by equivalent General Fund savings reflecting budget neutrality, to continue the California Community Transitions program, which supports individuals transitioning from nursing homes to the community.

Conference issue is budget neutral continuation of the California Community Transitions program, which supports individuals transitioning from nursing homes to the community.

Conference issue is funding to expand technology services statewide to all Caregiver Resource Centers.

Conference issue is funding for a liaison between audiologists and the California Children's Services program to reduce delays in treatment authorizations and reimbursements.

Issue	Description
Issue 29: Early Psychosis Research and Treatment	

Governor proposed \$25 million General Fund one-time for the Department of Health Care Services (DHCS) to provide grants to county mental health plans, nonprofit organizations, behavioral health providers, or academic institutions to identify and support appropriate interventions for California youth experiencing signs of early psychosis.

Senate rejected the Governor's \$25 million General Fund allocation to DHCS and approved \$25 million General Fund for the Mental Health Services Oversight and Accountability Commission (MHSOAC) to fund its existing Early Psychosis Intervention Plus Program. Governor had no proposal in this area.

Senate took no action.

Assembly approved \$8.3 million General Fund ongoing and placeholder trailer bill language to create the Child Welfare Public Health Nursing program. The program would build upon the existing use of public health nurses in child welfare services in Los Angeles County, and provide preventive services to families with children who are at risk of being placed in the child welfare system.

Conference issue is whether to approve funding and trailer bill language.
