	<b>VARIOUS DEPARTMENTS WITHIN CALEPA</b>	Various budget reductions across CalEPA boards, departments, and offices due to a decrease in rental expenses resulting from the CalEPA building bond refinancing completed in August 2013. The refinancing allowed for a lower interest rate to be paid on the bonds, which resulted in lower debt service and associated lease costs of \$1,980,000 annually. (MR)
