2	<p><b>Long-Term Care Career Pathways (Issue 150)</b>—It is requested that Item 5180-151-0001 be increased by \$200 million one-time to incentivize, support, and fund career pathways for IHSS providers, allowing these workers to build on their experience to obtain a higher-level job in the home care and/or health care industry. It is also requested that provisional language be added to this item to conform to this action.</p> <p><i>Questions Posed Previously:</i> Please describe how this project would implement in 2021-22 and after? The proposed Budget Bill Language for this proposal is minimal. What statutory changes are needed to establish this project and delineate how it would operationalize?</p>	<p>Hold open. 4	<p><b>IHSS State and County Sharing Ratio (Issue 152)</b>—It is requested that Item 5180-111-0001 be increased by \$57.3 million to allow for the continuation of the 65 percent state and 35 percent county sharing ratio and the continuation of the 10 percent over three years option.</p>	<p>Approve as Budgeted, with placeholder TBL with clarifying changes from the counties to achieve the intent of the availability of the 10 percent tool for two uses for all counties after January 1, 2022.</p>

5	<p><b>Housing and Disability Advocacy Program Augmentation (HDAP) (Issue 154)</b>—It is requested that Item 5180-151-0001 be increased by \$175 million to assist disabled individuals who are experiencing homelessness. Additionally, the Budget waives the Interim Assistance Reimbursement requirement through the end of 2023-24 for this program. It is also requested that provisional language be added to Item 5180-151-0001 to identify funding is allocated for these purposes.</p>	Approve as Budgeted, with placeholder BBL.
10	<p><b>CalWORKs Housing Support Program (HSP) Augmentation (Issue 164)</b>—It is requested that Item 5180-101-0001 be increased by \$475 million for the CalWORKs Housing Support Program, which assists CalWORKs families in obtaining and retaining permanent shelter. The increased funding reflects one of several components included in the Administration’s proposal to address homelessness. This program provides housing-related supports to eligible families experiencing homelessness in the child welfare system.
