The purpose of this memo is to highlight ID.me's work with government and commercial entities.

### About ID.me

- ID.me has more than 28 million pre-verified users, including more than 25% of California's entire adult population, due to our work with the California DMV, the City of San Diego, Veterans Affairs, the Social Security Administration, Allscripts, MGM and hundreds of entities that use ID.me.
- Over 60,000 new users sign up for ID.me's shared Identity Provider service every day
- We authenticate over 380,000 unique transactions per day (across new and existing members)
- We screen more than 1.2 million identity documents per month
- ID.me is the only vendor with a NIST 800-63-3 Identity Assurance Level 2 certified Supervised Remote identity verification capability that enables all eligible users to prove their identity online during a video conference with an ID.me trained agent over Zoom, FaceTime, or Google Meet
- NIST has awarded ID.me more than five million in grant funding since 2013 to speed up the market adoption of ID.me's secure and privacy enhancing identity verification technology.
- Winner of the Audience Choice Award at Privacy Identity Innovation 2014
- One of the top 1,500 Websites in the US by user traffic (source: Alexa.com)
- ID.me has maintained a 99.99% uptime on average over the last three years
  - On average, ID.me's platform receives over 300,000 requests per hour (220M 250M requests per month) with an average backend response time of 90 110ms
  - The average RPM (requests per minute) for the platform is 5,300 with an increase to 14,000 during peak load times

# California EDD

- 64,950 users successfully verified their identity since launch on October 1 (10,825 per day)
  - 58,915 users verified via ID.me's self-serve process without assistance
  - 6,035 users verified via ID.me's Virtual In-Person (video chat) agent assisted process
- Over 8M Californians have an existing ID.me account
- Approximately 25% of users who went through CA EDD already had an ID.me login

- MGM Guest Check-In
  - Verifies over 1.44 million users annually and has been verifying users for mobile check in since early summer
  - 48,0000 monthly active users
- Allscripts Electronic Prescription for Controlled Substances (EPCS)
  - Over 50,000 providers credentialed across Allscripts for DEA-compliant Electronic Prescription of Controlled Substances
  - ID.me authenticates over 135,000 prescription requests a day
