#### Overview of Key Proposals in the May Revision for Health and Human Services

For each department/office with a key proposal listed, please present on the proposals identified in this agenda, answer the questions listed, and be prepared to answer additional questions from the Subcommittee. For the Members and the public, additional details for the proposals are included in the attachments to this Agenda, are on the Department of Finance website, or remain pending from the Administration.

## 4a. 0530 California Health and Human Services Agency (CalHHS)

 California Automated Response and Engagements (CWS-CARES) System. Requests an additional \$163.7 million (\$83.4 million General Fund) for the project to support ongoing project development costs, and authority to access an additional \$36.6 million (\$18.3 million General Fund) should project activities accelerate.

*Questions:* Please explain the reasons for the additional costs. What is the new timeline for implementation? What are the overall project costs for CWS-CARES before and after this proposal?

• Health Innovations Initiative, request for \$10 million General Fund.

*Questions:* What will the \$10 million be used to do? How will this project benefit vulnerable participants/recipients in programs like CalWORKs and SSI/SSP?

• Home and Community-Based Services (HCBS) Spending Plan Changes. The May Revision proposes a six-month extension until September 30, 2024.

*Questions:* Explain the extension and how much more time it will provide for programs that are struggling to fully spent HCBS funds by the current December 31, 2023 deadline. Which programs are impacted within CalHHS departments/offices and which are not?

• Electronic Physician Order for Life Sustaining Treatment Registry Project and the California Emergency Medical Services (EMS) Data Resource System Project Budget Change Proposal.

## 4b. 4100 State Council on Developmental Disabilities (SCDD)

- Reimbursement Authority Increase for \$106,000 on a one-time basis to enable the SCDD to expend funds associated with an agreement with the University of Southern California's University Center for Excellence in Developmental Disabilities.

#### 4c. 4120 Emergency Medical Services Authority

- California Emergency Medical Services Central Registry for \$190,000.
- Appointment of a Chief Medical Officer for \$29,000.

#### 4d. 4140 Department of Health Care Access and Information

- Reallocate Funds for CalRx Pharmaceutical Drug Procurement for \$2,000,000 reappropriated for the Capital Infrastructure Security Program.
- CalRx Naloxone Initiative for \$30 million.

#### 4e. 4170 California Department of Aging (CDA)

 Older Adult Behavioral Health Budget Change Proposal, with \$20 million General Fund in 2023-24, \$20 million General Fund in 2024-25, and \$10 million General Fund in 2025-26 to support the continuation of the Older Adult Friendship Line, a targeted media campaign for older adults, and competitive grants to local jurisdictions to build organizational capacity to identify and address older adult behavioral health and substance use disorder needs.

#### 4f. 4260 Department of Health Care Services

- High-level overview of the DHCS budget and Medi-Cal estimate proposed in the May Revise.
- Managed Care Organization Tax for approximately \$19.4 billion.

*Questions:* What's the justification for spreading out the expenditures over 8-10 years? Do you anticipate being able to renew the MCO Tax in three years with the same structure, thereby generating the same level of revenue? Please justify the specific provider types selected for proposed 2023-24 rate increases. Has the federal government put a limit on the amount of tax revenue that can be used for General Fund backfill? Please respond to the LAO recommendations on this proposal.

• Naloxone Distribution Project for \$141.3 million.

*Questions:* Harm reduction organizations state that they perform 2/3 of the overdose reversals in the state, and are requesting continued funding for staffing and operations; would you be supportive of spending OSF for this purpose?

• Behavioral Health Modernization for \$40 million.

*Questions:* Is this request not premature given that this proposal has yet to be approved by either the Legislature or the voters? Please provide detail on what these funds would be used for.

• Children and Youth Behavioral Health Initiative: Fee Schedule Third Party Administrator for \$10 million.

*Questions:* Are these new resources above the \$4.5 billion approved for the CYBHI?

Increased CARE Act funding, including: \$128.9 million in 2023-24, \$234 million in 2024-25, \$290.6 million in 2025-26, and \$290.8 million in 2026-27 and ongoing, and Los Angeles County CARE Court Start-Up Funding—provisional language to specify \$15 million.

*Questions:* Please respond to the modifications recommended by the LAO. Please share the justification for your cost estimates given that implementation has yet to begin. Are you willing to provide regular implementation reports to the Legislature, as recommended by the LAO?

*Questions:* Please describe the proposed modifications to the trailer bill that are included in the May Revision, and to what degree they address the concerns and opposition from stakeholders.

# 4j. 4560 Mental Health Services Oversight and Accountability Commission

#### 4260 Department of Health Care Services

The Subcommittee requests the OAC present its request for position authority and a shift of resources from local assistance to state operations for purposes of implementing the evidence-based practices component of the Children and Youth Behavioral Health Initiative (CYBHI). The CYBHI includes \$429 million for evidence based practices, of which 10 percent (\$42.9 million) is to be administered by the OAC, as described in a 2022 Budget Change Proposal (4560-001-BCP-2022-GB). This proposal requests that \$15 million of this funding be used as follows:

- Research and Evaluation: \$1.6 million (2 Limited-Term positions and contracts)
- Grant monitoring and legal support: \$1.4 million (2 Limited-Term positions and contracts)
- Communications: \$400,000
- Community Engagement/Project Manager: \$1 million
- Consultants: \$600,000

- Stanford (allcove): \$5 million
- UC Davis (EPI): \$5 million

#### Questions:

- In 2021, during final budget negotiations on the CYBHI, the Legislature insisted on appropriating 10 percent of these funds to the OAC (through an MOU with DHCS) because of the OAC's experience with, and expertise on, evidence-based mental health programs for youth, as well as the OAC's ability to allocate funding quickly. Please explain why, as of May 16<sup>th</sup>, 2023, none of these funds have been transferred to the OAC, and there is no MOU in place.
- 2. What is the content of the draft MOU that DHCS and the OAC have been discussing?
- 3. The Department of Finance denied the OAC's request for position authority, due to the absence of a signed MOU; does this mean the Administration would find it acceptable to delay this program by a year?
- 4. Is there a need for an extended expenditure period for these funds?
- 5. Is there a need to approve of shifting some or all of these resources from local assistance to state operations?
- 6. Please also provide an update on any implementation challenges associated with the Mental Health Student Services Grant Program within the context of the CYBHI.
