ISSUE 1: PROPOSITION 99 FUNDS

The Proposition 99 Cigarette and Tobacco Products Surtax Fund includes \$40 million in a restricted reserve. The Governor's May Revise proposes to keep these funds in the reserve for settlement of outstanding litigation. However, the plaintiffs in the outstanding lawsuit have indicated that they are not interested in pursuing the lawsuit, and have requested that the funds be allocated to augment existing tobacco education and research activities.

Subcommittee No. 1 on Health and Human Services has allocated 32.5 million of the restricted reserves for education and prevention purposes. However, there is an addition \$7 million that could be allocated to UC to augment their current tobacco research program.

Assembly Budget Subcommittee No. 1 recommends that Subcommittee No. 2 take a conforming action to allocate the restricted reserves in the Health Education and Research accounts to conform to the Senate, and Subcommittee #1.
