L15 **Radiation Regulation** 0 0 Language

Senate adopted trailer bill language requiring the Health and Human Services Agency and California Environmental Protection Agency (CalEPA) to confer and develop a transition plan, to be submitted by November 1, 2007, for the transfer of responsibility for ionizing radiation from the Department of Public Health to the Department of Toxic Substances Control or other entity within CalEPA.

Assembly took no action in this area.
